Lobbyist's Legislative Report

Well folks, this month's Lobbyist Report is going to be short and sweet — I'm scheduled back at the Capitol to try and round up enough votes to kill a popular (among non-riders) motorcycle noise EPA label matching bill.

As you may, or may not know, Senator Fran Pavley's motorcycle smog check bill was amended on June 10 to take out all of the smog check provisions. Instead, she amended it to provide that all post 1982 motorcycles must have the federal EPA noise labels on their frames and mufflers to be legal.

The fine would be \$300 and the citation would be non-correctable, which a motorcycle noise violation currently is. A point would also be awarded by the DMV, raising insurance rates. My daily lobbying efforts, meetings with staffers, your telephone calls, faxes, letters and e-mails started paying off, because on June 15, Pavley amended SB

435 for the second time in five days. This time, the EPA label matching requirement will only apply to motorcycles model year 2000 and after and it would remain a fix-it ticket citation. Replace the non-EPA labeled pipes, get the legal replacements signed off by the CHP and it'll still cost you only a \$25 fee. No points. Most importantly, you can't be pulled over for an officer to take a look-see, or if you are parked. It will be a secondary offense — you'll have to be stopped for some other violation.

The second time, however, will be a \$250 non-fix-it ticket, and with penalty citations and court costs, it'll total upwards of \$1,000.

We obviously will continue to Oppose SB 435. **PLEASE**, go see your local Assembly Member with our talking points. If your Representative is not in, don't waste your visit — see his Chief of Staff or another staffer. Bring any petitions to them as well.



Recap of How Well ABATEPAC's Endorsed Candidates Did In the June 8 Primary Election —

- Out of 88 Races that ABATE Endorsed Candidates were in, 66 Won or 76%.

- Of the 21 Races that ABATE Endorsed Candidates lost, 5 were in dual or triple endorsement races in which the ABATE endorsed candidate **WON!**

- One race is still too close to call. Out of 33,212 total votes cast for all candidates, only 40 votes separate the top 2 candidates and **one is ABATE Endorsed.**

- An ABATE-Endorsed Candidate, Mike Gatto, won both the Assembly Special Election in the 43rd Assembly District, and the Democratic Primary for the same district.

- An ABATE-Endorsed Candidate, Bill Emmerson, won the Senate Special Election for the 37th Senate District.

JOB WELL DONE! With a 76+% battling average, this is a great start to follow up with in the November General Election.

Rest up from your campaign work, but now let's turn all of our efforts to **KILL SB 435!**

Executive Director's Report

Greetings Brothers, Sisters & Friends:
I'd like to start off by wishing everybody a safe and joyous 4th of July celebration.

The 4th of July marks an occasion that is more than just backyard barbecues, gatherings of friends and families, and fireworks displays, but it also marks the occasion when our Founding Fathers, men of great vision and courage, initiated one of the most profound and far reaching revolutions in the history of mankind. While the history books will tell us about the Industrial Revolution as one of those major historical events, the fact of the matter is it would more aptly be titled the "Industrial Evolution". Even though the introduction of industrial machinery did revolutionize the way manufacturing, agriculture and many other industries mass produced and marketed their goods, products and services, it has been a never-ending and constantly evolving process that has led to a level of "standardization" and saturation of consumer markets never seen before in the history of man. Unfortunately, there has been a never-ending legislative evolution in the way free Americans have been led back to the yoke of oppression

redress of their grievances is very much under assault today as evidenced by recent occurrences within ABATE. The October 2009 and January 2010 BOD meetings saw law enforcement gathering license plate numbers, taking photos and harassing a veteran's organization for allowing an ABATE meeting to be conducted on their premises. It begs the question what law enforcement is going to do with the intelligence information they gathered during these breaches of our civil liberties and of invasions of privacy by police, not too mention being incredibly poor demonstrations and breaches of etiquette and good taste by the agencies involved.

But those are only small isolated instances of our rights being infringed upon. The real damage is done by those wearing suits and who find themselves in possession of a title either elected or appointed, and of the two, often it is the appointed officials who are the most dangerous. Worse yet, some elected representatives manage to get one of his or her bad ideas passed into law. It is then turned over to some state agency filled with unqualified cronies or termed out legislators and they are then allowed to develop regulations that have not been vetted by the process of traveling through the halls of the legislature. At least with elected representatives, they can be voted out and there is some small measure of accountability. With appointed bureaucrats, it is often hard to determine the chain of command; stonewalling though the employment of recorded messages where you have to Press 1 for English is rampant and passing the buck from one bureaucrat to the next is the name of the game. We are constantly under assault from so many different quarters as to often make it extremely difficult to decide which flank we need to defend!



Unfortunately, ever since that incredible moment in history, those formerly in power have steadily chipped away at what our forefathers wrought for us with their blood, sweat and tears. Yeah, we've scared them a couple of times since then, what with the Great Civil Rights movements of the Sixties, when many of us marched in the streets demanding change; as some went to jail, some were beaten and some even died for what they believed in. Freedom is indeed a very messy business! The right of the people to peacefully assemble and demand

Executive Director's Report

All this aside, I am extremely proud of the manner that the membership of ABATE of California has pulled together to fight SB-435, an extremely unnecessary and poorly crafted bill authored by State Senator Fran Pavley. I am in hopes that by the time you are reading this article that ABATE of California has already announced SB-435 went down in flames. For two years ABATE members have risen to the challenge every time Pavley has changed tactics and we have managed to hold this discriminatory, unjust and inappropriate legislation at bay. At the Eleventh hour, after suffering several defeats, Pavley decided to adopt yet another tactic and changed SB-435 to a "noise bill" which is where she was headed all along I suspect.

As I write this the battle still is being waged, but the simple fact is this: Without the incredible outpouring of opposition to SB-435 by ABATE members, SB-435 would long ago have been passed and the California motorcycle community would have been saddled with another piece of burdensome legislation whose only real impact would be to make life more difficult for us and to transfer wealth from our pockets to government coffers. ABATE members statewide have all contributed to the fight against SB-435, and I am very proud of your efforts. Give yourselves a hand! As I close, let me say that should SB-435

pass out of the Assembly Transportation Committee and make it to the floor of the legislature, we still have not lost. We need to keep the pressure on the legislature and keep those letters, calls, faxes and emails coming in to the offices of your district legislators. In addition, I would take this opportunity to once again urge all who are able to make a donation to one or more of the funds which helps keep ABATE defending your rights to Ride Free. The General Fund, the PAC Fund, and the Lobbyist Fund are all in needs of donations to help sustain us through this time of immediate crisis, and beyond that, there is always a new threat too from the legislature and special interests who would rather see motorcycles as museum pieces rather than a form of transportation and recreation.

And lastly, after reviewing much of the background documentation presented by such diligent and stalwart ABATE members as Splatt and Dennis Stalter, it appears to me that there will be sufficient and compelling grounds for legal action to challenge SB-435 in the courts should it come to pass. My suggestion to the membership and to my colleagues on the Board of Directors is that we immediately begin planning to once again implement a "Judicial Fund" should it become necessary to fight SB-435 in the courts system.

As has been stated by so many others, "Let us hope for the best but prepare for the worst".



Let Gill or Spike know and make a copy of the ticket for them. Call the PD and ask if that intersection had a high rate of accidents. If not, there should not be a camera there.

Thank goodness the rain has finally stopped! Unfortunately, we went directly into summer with high winds and hot temps. Whew!



Vote No On SB 435 As Amended – Now It's a Motorcycle Exhaust Noise Enforcement Bill!

SB 435, as Amended, will be heard in the Assembly Transportation Committee by the end of June. Due to strong ABATE opposition, all of the motorcycle smog check provisions were stripped out and SB 435 reportedly will be amended to provide that if bikes don't have mufflers with matching federal EPA noise standard labels, they can be cited for a \$300 *non-fix-it ticket*. That's if you're riding it or it's just parked, anywhere.

California Vehicle Code Sections 27150 and 27151 have already been on the books for 40 years and are used routinely for loud motorcycle exhaust violations. Why enact overlapping existing law in a state with a \$20 billion budget deficit. Isn't that irresponsible? Besides, the EPA muffler label stamps on mufflers are the equivalent of the tags on bed mattresses — they are manufacturers' warranties. In this case, the labels mean that the muffler complies with the federal noise standard for new motorcycles for one year or 3,730 miles, whichever comes first. After that, due to wear and tear or damage, compliance with the noise standard no longer applies.

Under current law, if the mufflers are replaced with noise compliant ones, labels or not, and verified by peace officers, the citations are written off with a \$25 court fee. This way, a proper correction to a violation is accomplished.

The aftermarket muffler industry has supplied replacements due to wear and tear or damage for decades. For the tens of thousands of aftermarket catalytic mufflers that wear out, where does one get a replacement, if stock parts aren't available, since CARB reportedly has approved only *one* aftermarket replacement, so far? What happens to the owner of a bike that they bought used with a non-labeled muffler? Should they be cited for something they are not responsible for?

- Vehicle Code Sections 27150 & 27151 already are used to cite loud mufflers.
- Spending the money to enact redundant vehicle noise control laws when the state has a \$20 billion deficit is irresponsible.
- The EPA noise labels on motorcycle mufflers are nothing more than new bike manufacturer warranties, good for just one year or 3,730 miles.

- Noise laws from all sources, like autos with noisy boom boxes or mufflers, loud house parties and construction equipment need to be enforced, not just targeting motorcyclists for subjective and discriminatory prosecution.

- The EPA noise labels on aftermarket replacement mufflers are nothing more than manufacturer warranties, good only at time of purchase.

- I bought my bike used and it doesn't have a muffler stamp. Is it fair that I should get a ticket for that?

- My muffler just wore out. My dealer or manufacturer doesn't have any more stock ones. What do I do, stop using my motorcycle?

Tech Tips by Craig Griswold Tires

Now that the riding season is in full swing, folks are breaking out their scoots and hitting the road. It's always good to do a visual inspection before getting underway, and one of the most critical safety items on your bike is your tires. This month we'll cover some basic maintenance issues and a few points on selection as well.

At the top of the maintenance list is tire inflation. The majority of bikes that roll into our shop have under inflated tires. The best case scenario is premature wear and some minor handling issues. Worst case can be increased operating temperatures and blow

outs. Keep in mind that different brands have different specifications, so check the data for that manufacturer. The rule of thumb is to check pressure before every ride. A quick visual is good too. Look for damage in the tread and sidewall. Bikes that don't see a lot of mileage or sit for prolonged periods, especially out in the weather, can have a tread that looks acceptable, but the sidewalls can be cracked. Most tires have tread wear indicators; however, a service manual will give the minimal tread depth. If in doubt, replace it!

If you change your own tires, remember that *most* motorcycle tires are directional, and almost all are front and rear specific. Additionally, remember to mount the tire with the "balance dot" in line with the valve stem. The dot is usually yellow or red, and it indicates the light spot of the tire that is identified during manufacturing. It's a good idea to replace the tube and rim strip (if applicable) every tire change. A little off topic, it doesn't hurt to check/service wheel bearings at the same time. Always refer to your service manual for specific procedures and specifications.

The great tire brand debate is almost as varied as the synthetic oil debate. We have had great success with all of the major brands and even some of the discount brands. Some are reportedly constructed of softer materials than others, offering better traction at the expense of some mileage. The best thing to do is ask a few reputable shops and also

check information available from the manufacturer.

For all of you custom bagger guys and gals, a popular look these days are the low profile tires on taller rims. A word of caution with that set up: All tires have a load rating and all bikes have axle weight limits that correspond with those load ratings. **Most of the low profile tires do not have a load rating that is sufficient for Harley-Davidson Touring models.** This may not be an issue for a show bike, but for your daily rider with the occasional passenger and load of luggage, it could spell trouble. Your owner's manual and chapter 2 in your service manual have your bike's GAWR (Gross Axle Weight Rating). Compare these numbers with those of the tire load ratings on your bike.

Next month we'll cover other items to check before blasting off for that next road trip. Ride safe!
