The Elections are only one month from now! Our Executive Director Mark Loudermilk asked us, as your Lobbyist, to go over the list of Candidates for the November 3rd Elections, suggesting Endorsements for Legislators who have supported or who were Motorcycle friendly during the last two-year session. This Voter's Guide is published in this issue. Please share the list with all Motorcycle friends and allies to help elect Motorcycle friendly Officials.

The Legislature will return to Sacramento December 7th to Elect the Speaker of the Assembly and the Senate to Elect the Speaker Pro Temp. Senator Jones will reintroduce SB 1024 to allow the continued use of off-road race motorcycles on BLM, Department of Forestry and State off Road parks for practicing and sanctioned competition racing events. Our bill got caught up in the fight between the Senate and the Assembly, passed out of the Assembly Floor at 11:55 pm and was not able to be returned to the Senate in time to have the Assembly amendments concurred upon – even the Speaker Pro Tems Bill didn't pass the Assembly! (Over 100 hundred other bills died in the same manner)

The California Motorcycle Safety Program is scheduled to do a Zoom meeting this month, I will report next issue on actions taken at this meeting! The program was shut down over a month due to the Covid virus! Classes are being held, just at fewer locations. Now is the time to submit ideas for Legislation next year on the 2021-22 two-year session! You can submit your ideas to the Executive Director or our office!

Thank you to the Members and Locals for Supporting the Dedicated Lobbyist Fund, keeping us at the Capitol fighting for your rights!





Latest Legislative Information From ABATE



California has always allowed valid "out of state" OHV registered vehicles to use our public lands. It has come to our attention that some of our neighboring states have recently implemented a "non-resident" fee for OHV's being operated in their state. By no longer honoring our California registration these states are reneging on a long standing tradition in the OHV community. These new regulations will be expensive and prove onerous to every legally licensed OHV owner that travels and recreates in other states. Our ABATE OHV Division is asking for your help and financial support in fighting this type of legislation. Assembly Bill 2761 sponsored by Assemblyman Gallagher (Republican—Yuba City) seeks to remedy this issue of reciprocity and ABATE of California is asking you to help the OHV communities of our states restore equal access to OHV areas for all legally licensed users.

In addition to AB 2761, Abate of California is proposing two other bills for our elected official's to consider this year. Our first bill would require DMV to allow rider's to take both the M/C skill's test and their DMV written exam during their CHP certified M/C training classes. After a rider successfully completes and passes both tests the school would submit the information to DMV and they would issue a valid M/C endorsement card by mail to the rider that is valid for the duration of their current California drivers license. Upon license renewal the M/C endorsement would then be added to their new license thereby saving the student the time and expense associated with visiting and testing at their local DMV office.

Our second bill would seek to exempt all M/C riders and especially our Military Veteran riders from being accessed a toll fee when traveling on a toll road within the state of California.

SB-1024 Jones Off-highway vehicles: This bill would exempt specially constructed motor vehicles operated solely in organized racing or competitive events upon a closed course from the identification device requirement for motor vehicles operated exclusively off the highways. The bill would repeal provisions relating to special transportation identification devices for motorcycles and corresponding fees, and would make other related conforming changes. The bill would additionally provide that competition all-terrain vehicles (ATVs) are not exempt from identification. **Passed Assembly 11:55PM August 31st, Midnight Deadline for Senate**

***SB-1147 Glazer State park system: Carnegie State Vehicular Recreation Area:** This bill would express the intent of the Legislature to enact subsequent legislation that would preserve the Carnegie State Vehicular Recreation Area for conservation purposes. **Held in Rules Committee**

***SB-1032 Allen State parks: Off-Highway Motor Vehicle Recreation Commission:** This bill would make the creation of the commission permanent by deleting the January 1, 2023, repeal date. The bill would require the commission members to instead have expertise in and represent off-highway vehicle recreation, environmental protection, motorized access to nonmotorized recreation, law enforcement, environmental restoration, public health and safety, rural landowners and residents, biological or soil specialization, or the public at-large. **Held in Senate Natural Resources & Water**

SB-1351 Beall Department of Transportation: state highways (Amended) Planning: This bill would prohibit the director from approving an allocation of an amount greater than 5% of a transportation planning agency's annual revenues. Existing law authorizes certain statutorily created transportation planning agencies to allocate up to 3% of their annual revenues for transportation planning and programming processes, and alternatively authorizes the allocation of a greater amount upon approval by the Director of Transportation.

This bill would require those rules and regulations to be updated at least every 4 calendar years to reflect changes to the operators' transfer policies, payment methods, and any other relevant policy changes. This bill would provide that, if the Commission on State Mandates determines that the bill contains costs mandated by the state, reimbursement for those costs shall be made pursuant to the statutory provisions noted above. **Enrolled and presented to the Governor** (September 30th Deadline)

AB-1964 Frazier Autonomous vehicles: This bill would expand the definition of the term "autonomous vehicle" to also include a remotely operated vehicle, defined as a specified type of vehicle that is capable of being operated by a driver or operator that is not inside of the vehicle. The bill would instead specify that a vehicle is not an autonomous vehicle if it is equipped with a collision avoidance system that is not capable of driving the vehicle without the active control or monitoring of a human operator that is seated in the driver's seat of the vehicle. **Held in Committee**

AB-2121 Friedman Traffic safety: This bill would require, beginning June 1, 2022, and every 6 months thereafter, Caltrans to convene a committee of external design experts to advise on revisions to the Highway Design Manual. This bill would extend the period of time a prima facie speed limit may be justified by an engineering and traffic survey, as specified, if a registered engineer evaluates the section of the highway and finds that there has been an increase in traffic-related crashes. **Trailer Bill Held in Assembly Transportation**

AB-2225 Grayson Smog check: exemption: historic vehicles: This bill would exempt motor vehicles that have been issued with the specialty plate described above from the requirement that it be inspected biennially upon registration. **Held in Assembly Transportation**

***AB-2551 Bauer-Kahan Off-highway vehicular recreation: Carnegie State Vehicular Recreation Area: Alameda-Tesla Expansion Area:** This bill would authorize the department to dispose of the portion of the Carnegie State Vehicular Recreation Area known as the "Alameda-Tesla Expansion Area" to permanently preserve that land for conservation purposes, as specified, if the department determines that disposing of the land is in the public interest. **Hearing Canceled at the Request of the Author**

***AB-2761 Gallagher Off-highway vehicles: reciprocity:** This bill would permit application of that exception only if the other state recognizes an identification plate or device issued by the department as valid for use in that state. By narrowing the exception, the bill would expand the scope of an existing crime and would therefore impose a state-mandated local program. **Held in Assembly Transportation**

***AB-2785 Cervantes Vehicles: off-highway vehicles (Spot):** This bill would delete obsolete provisions relating to the report, and would make other technical, nonsubstantive changes. **Not Assigned**

AB-3311 Grayson Vehicles: insurance: This bill would increase the amount of liability insurance coverage an owner or operator of a motor vehicle is required to maintain to \$30,000 for bodily injury or death of one person, \$60,000 for bodily injury or death of all persons, and \$25,000 for damage to the property of others as a result of any one accident. This bill would make conforming changes to the definition of "proof of financial responsibility" for purposes of the provisions described above. **Held in Committee**

***Protect Motorcycle Safety Fund and Off-Highway Vehicle from Trailer Bills/August Revise (After Taxes are Collected July 15 since April Deadline was postponed). We protected the Accounts so far through June Budget Vote – no money was stolen or defunded!**







“Riding Well” from Rider Magazine

Of Trepidation, Toilet Paper and Traffic Management

I never really paid much attention to the amount of toilet paper we had in stock at our house. Never really had to. But in today's world, things are suddenly different. I'm contemplating things I never would have imagined were worth considering, let alone planning for.

Apparently, a large portion of the population has known something of great importance that I've clearly been blind to: the critical significance of having an abundance of TP in the moment of crisis. (I'm going to resist speculating on the potential cause and effect relationship there.) Sure, I've been lightly conscious of the predictable rush on paper products, bread and milk each time a storm is forecasted, but I frankly just brushed that off as odd behavior practiced by a few people who really didn't know what else to do in preparation for a looming situation. Buying rolls of Northern was their plan for when things go south.

But now, after being faced with aisles of empty shelves at multiple stores, I find myself closely monitoring our own inventory of staple items. I thought I was nuts in doing so until a friend showed me the spreadsheet he's using to track his family's consumption of milk, butter, eggs and Angel Soft.

During the COVID-19 pandemic, we are all paying closer attention to things. Most of us have become hyper-aware of everything we touch, what we're doing with our hands and what actions other people are taking in their daily routines. "Why is that person not wearing a mask? Did they touch those vegetables after touching their face? Who has grabbed that door knob before me?"

We are not just considering these things; we're planning and responding with purpose. We are taking deliberate steps to preserve our health and safety by washing our hands more thoroughly and more often. (You're doing that, right?) We are wiping down surfaces with disinfectants, keeping our distance from others and carefully monitoring our spending and consumption "just in case."

For the foreseeable future, we will continue to operate in this heightened state, giving more thought to our surroundings. Whether we recognize it or not, these new habits will likely become a natural part of our new normal moving forward. And maybe that's not a bad approach to

safer riding. Consider this: This pandemic came swiftly and, although we had heard about its impact on others in distant lands, many thought it could never happen to us. Suddenly, we were in the midst of it. A tsunami of factors overwhelmed us and demanded immediate attention. We were forced to make on-the-fly decisions and actions. For some, all they could do was hold on tight and hope for the best.

Doesn't that sound a bit like having a string of good riding days until something unexpected - something that only happens to other people - suddenly happens to us? Let's apply a few lessons from the pandemic that can help us become safer riders....

Conserve essential resources. How much would we stock up on stopping distance if we realized there was a good chance we were going to run out of it at a critical moment on today's ride? How much traction would we wish we'd kept in reserve when that curve became tighter than we thought it was? How much sight distance would have been valuable to have on hand leading up to that car turning across our lane up ahead?

Just as we are mindfully managing our resources during the pandemic, we benefit by closely managing our inventory of sight distance, stopping distance, turn entry speed and available traction at all times. Recognize that the supply and demand for each of those commodities continually changes throughout each ride. The key is to have a surplus of each at any given moment.

Have hyperawareness of what others are doing. Be just as hyperaware about unacceptable behavior on the road as you are in public places these days. Pick up on the clues that indicate someone is going to do something unusual and potentially harmful to you and others. There is much we can do to recognize, and even predict, bad or reckless behavior and disregard for others if we're actively looking for the indicators. Keep in mind that being uncomfortable with what's going on around us isn't a bad thing. It's just that we've become more aware of our environment and recognize the need to adjust our position or extract ourselves from the scene altogether, just as we would socially during the pandemic.

Adopt the social distancing habit. Standing six feet apart is not a natural thing for us human types. We like to be closer to other people (well, most people). But now, a little more space between us is beginning to feel more comfortable. Certainly safer. In other words, a little more dis-

tance between us and others can become a more natural and healthy part of our regular routine, including when we are on a motorcycle. Adopt the same social distancing practice by stopping a little farther back from the vehicle ahead at an intersection. Create an extra space cushion from other vehicles, including other riders, anytime you can. Consider taking the path less traveled when possible, or picking times when congestion will be lighter. Create as much distance as possible and have an escape route when riding in a crowd of traffic is unavoidable.

Wear the Personal Protective Equipment. At first, I was the odd guy wearing a mask in public when others weren't. I was very self-conscious when walking through a store as the unmasked throngs looked at me. But, a few weeks later, I forgot to bring a mask with me on a trip to the essentials store and was suddenly getting stares because I was the only person not wearing a mask. Having ridden my bike to the store that day, I promptly pulled my full-face helmet over my head, closed the tinted shield and went about my shopping business. Hey, at least my solution was better than the guy I saw at Walmart wearing a hockey goalie mask (with large holes at the nose and mouth, no less).

Just as healthcare workers practice wearing the appropriate personal protective equipment (PPE), we as "road doctors" must practice wearing our own PPE suitable for riding every time we operate our bikes. Call it ATPPEATT (All The Personal Protective Equipment All The Time). A full-face helmet is our head's N95 mask equivalent. Our armored riding gear, motorcycle-specific gloves and riding boots may not protect us from contagions, but they will protect us from contusions.

By learning from our experience during this pandemic and applying the same critical thinking to our riding, we can heighten our awareness and increase our margin of safety on the road. With the same hypersensitivity, we can think through what is going on all around us, be fully aware of our actions at each moment, and anticipate how the actions of others may impact us. Or, I suppose we can always just hop back on, let our minds wander, and ignore the unpleasant thought of a potentially serious "uh-oh" moment. At least we have lots of toilet paper.

TARIFFS ON MOTORCYCLES SUCCESSFULLY OPPOSED, AGAIN: The Office of United States Trade Representative once again proposed tariffs of up to 100% on all 500-700cc motorcycles and scooters, as well as all parts and accessories, imported from the European Union and the United Kingdom, but opposition led by the motorcycle community led to the successful elimination of the ill-conceived 'tax' stemming from a dispute over aircraft subsidies.

The proposed trade sanctions would not only have negatively impacted the motorcycle sales industry, including the aftermarket equipment sector, it could have deeply affected motorcyclists who rely on imported parts for general maintenance.

"We're incredibly pleased that European motorcycles, parts, and accessories have been removed from the most recent round of EU tariffs in relation to the Airbus situation," said John Hinz of the Motorcycle Industry Council

(MIC) and CEO of KTM North America Inc. "We are extremely thankful that the U.S. Trade Representative heard our concerns and recognized the unintended and potentially devastating impacts that tariffs could have on our industry. This would not have been possible without the support of the MIC and its members, the efforts of Congressman Michael C. Burgess, M.D., Congressman Tim Walberg, Congressman Ken Calvert, Congressman Jim Jordan, our dealers and our employees, and the support of all our industry partners. Thank you to all who wrote letters, made phone calls, and let Washington, D.C. know the value of our industry and our businesses here in the United States."

It was an international effort as well, with written comments supplied by Antonio Perlot, secretary general of ACEM, the Motorcycle Industry in Europe. "This was the third time the USTR made this proposal, and the third time the industry was able to prevail with combined support," said Erik Pritchard, MIC president and CEO.

MOTORCYCLE SALES UP DESPITE PANDEMIC: "Despite economic downturn, powersports sales have been surprisingly robust," according to Cycle World Magazine, which notes; The streets are quiet. Supply chains have disintegrated. Unemployment is at record highs. So it would stand to reason that all economic indicators and consumer spending in particular would be down for the year as well but, perhaps counterintuitively, motorcycle sales are up.

"You heard that right," declares CW. "Across the board, retail sales for the last three months have shown a steady uptick. It's more obvious in certain segments but the trend is undeniable; year-to-date powersports sales are better than they've been in years. Can you say pandemic paradox?"

Following a series of declining years, 2020's data was already looking fairly optimistic; motorcycles sales in February of 2020 were up 3.5% year-to-date, according to MotorcyclesData.com, but when the pandemic hit in early March and the auto industry began its sales freefall, most business insiders assumed the same fate would befall the motorcycle sector. The surprising news came in early June, when the smoke cleared and the Motorcycle Industry Council (MIC) reported that year-to-date retail powersports sales were better than they'd been in the past three years. "The powersports industry is in a much more positive place than where we thought we'd be earlier this year, when the full impact of the pandemic began to come into focus," MIC President and CEO Erik Pritchard said.

Of course, "powersports" includes ATVs, side-by-sides, and motorcycles, but in fact, sales were up 18.9% through March, according to the MIC's Retail Sales Reporting System. In sum, sales were relatively strong from January through April, and May was a great month for most.

Pritchard also pointed out, "The first four months of 2020, it's the second-best performance only to 2016 - in the midst of a pandemic."

CARB FINES AFTERMARKET RETAILER FOR "UNAPPROVED" MOTORCYCLE EXHAUSTS: The California Air Resources Board (CARB) has announced that Comoto Holdings, Inc., the parent company of Revzilla, J&P Cycles, and Cycle Gear, has agreed to pay a \$1,937,500 fine for selling motorcycle exhaust systems not approved for street use in the state of California.

CARB sets laws and emission regulations for California that are more stringent than the federal government. An aftermarket intake or exhaust can be legal for street use in most of the United States, but illegal in California because CARB has not certified it. According to RideApart.com, this case involves the sale of around 7,750 parts to California residents that allegedly did not have legal exemptions to California's anti-tampering laws for emission controls.

Comoto sold these parts in California with the disclaimer that they were being sold for off-road and race use only, not for use on public roads. This has been a commonly accepted practice among aftermarket retailers attempting to conform with CARB certification, placing the responsibility on the consumer to make sure their vehicle is compliant with CARB regulations.

But that didn't stop CARB from taking legal action against Comoto anyway, accusing the company of selling them for both highway and off-road use. Rather than fighting it out in court, CARB and Comoto agreed to a \$1.93 million settlement, which will fund various air pollution funds and projects in California. While a hefty sum indeed, it's still far less than the potential \$180 million fine if Comoto been found guilty in court and slapped with the maximum fine.

Comoto says it will continue to sell these exhausts, but will put even stronger wording on them that they are not to be used on California roads, ever. This sets a dangerous precedent as well since the "for off-road use only" disclaimer has been a standard operating procedure for years.

Therefore, other aftermarket retailers may begin having second thoughts about continuing this practice, not wanting to risk having to go through an ordeal as Comoto did.

STURGIS CROWD SETS RECORDS: Some 400,000 bikers rumbled into the small South Dakota city of Sturgis for the 80th Sturgis Motorcycle Rally, one of the largest public gatherings since the COVID-19 pandemic began, despite fears it could become a "super-spreader" triggering a massive Coronavirus outbreak.

Though city officials reportedly expected a much smaller crowd this year, perhaps by as much as half, according to the Department of Transportation, the seven-day total for the 10-day rally as of Friday, August 14th, was 365,979 people, which is down just by 7.5% compared to last year at the same time. In spite of a drop-off in attendance of those in the 60-70 age range, which is understandable during the pandemic, the rally surprisingly experienced historically high numbers in first-time attendees, vendors and spending.

"Screw COVID" t-shirts nearly outnumbered mask sightings, as Republican Gov. Kristi Noem adopted a largely hands-off approach to the pandemic, avoiding a mask mandate and preaching personal responsibility. She supported holding the Sturgis rally, pointing out that no virus outbreak was documented from the several thousand people who turned out to see President Donald Trump and Fourth of July fireworks at Mount Rushmore.

SIoux TRIBE BLOCKS RIDERS FROM GOING TO STURGIS: The Cheyenne River Sioux Tribe established strategic checkpoints at entrance locations to the reservation to turn away tourists and bikers going to Sturgis as a means to control the spread of the Coronavirus into Native American territory. The Rapid City Journal reported that the Cheyenne River Reservation authorities would not allow those attending the Sturgis Motorcycle Rally to pass through the road blocks onto reservation land.

South Dakota Governor Kristi Noem (R) opposed this move, saying the traffic checkpoints are unlawful and demanded that they be removed. The Cheyenne River Sioux Tribe sued the federal government to keep its checkpoints, citing what they called Noem's inappropriate request for federal assistance.

The seven tribes that make up the Sioux Nation are now in a fight with federal and state officials regarding the legality of the checkpoints.

NEW HAMPSHIRE MANDATES MASKS FOR LACONIA MOTORCYCLE WEEK: Nationwide media images of mask-less, closely packed, attendees broadcast out of South Dakota at this year's Sturgis Motorcycle Rally, with just days before the August 22 start of the 97th annual Laconia Motorcycle Week, convinced Governor Chris Sununu to institute the first broad face-covering mandate in New Hampshire for all events of 100 or more people.

"Sturgis was a real warning sign to us," said the two-term Republican Governor, hoping to avoid a COVID controversy.

To add some teeth to the statute, the state will deploy Liquor Commission enforcement teams to levy fines on those not observing the directive during bike week, and state regulators also have the authority to seize the liquor license of offending establishments.

PHILIPPINES REQUIRES MOTORCYCLE PASSENGERS TO CARRY PPE SHIELDS: Over the past four months of COVID-19 quarantine restrictions, the Philippine government has outlawed carrying passengers on a motorcycle, and although they now permit pillion (passenger) riding only for couples who live in the same household and share the same bed at night, all backriders are now required by law to carry a clear plastic shield or barrier in between the pillion and the rider as Personal Protective Equipment (PPE).

Pasig City mayor, Vico Sotto, has sided with the riders and their plight, but says that for now, all we can do is follow guidelines, because there is no other choice. "It is true that this shield is dangerous. But for now, we have no other choice if we want to carry pillions as this is required by the government."

At the moment, the government stands firm on its ground that the required barrier shield is safe and effective, insisting that "these approved designs underwent a thorough study which includes the concept of aerodynamics and were also tested for quality safety standards."

Motorcycle safety experts, bike manufacturers, and the Motorcycle Rights Organization all disagree with the mandate and have called on the government to "hear the opinion of experts and professionals in the motorcycle industry before enacting protocols that would affect the lives of motorcycle riders unnecessarily."



Sunday was a ride to get breakfast at the Rock Store. I like their breakfast burritos. I also like seeing the folks there, especially Vern. It's also a nice ride.


