### Lobbyist's Legislative Report

The Legislature has adjourned for their summer recess and finally (for the first time in 8 years) passed out a State Budget, on time, that Governor Brown promptly vetoed. The first attempt was a State Budget that wasn't balanced, causing Legislators not to be paid or receive their \$140.00 each day tax free per diem payment for living expenses.


triggers that will go into effect and cause further reductions to money for schools and other state funded programs, should state revenues drop in the near future. So expect them back in October or November dealing with the state budget, once again.

A huge battle is brewing in early January to get ABATE's AB 1047 passed. This is the bill, by Assembly Transportation Committee Vice Chairman Kevin Jeffries (R-Murrieta), that will prohibit all California law enforcement agencies from using Grant money from the feds or the state Office of Traffic Safety to fund the setting up of "motorcycle only" traffic "safety" checkpoints. This is pure discrimination and profiling against law-abiding motorcyclists and has to stop *NOW!*

To demonstrate how out of control the use of this grant money has become, the City of Citrus Heights just announced that their "motorcycle safety" checkpoints will check for *loud mufflers*, courtesy of overtime money and sound meters provided by money from the Office of Traffic Safety. It's a real stretch to claim that loud mufflers are safety hazards; actually many bikers feel it's the other way around — *Loud Pipes Save Lives!*


ABATE's helmet law repeal bill, AB 695 will also be up for a vote at that same hearing. **THE ONLY WAY EITHER OF THESE BILLS WILL BE PASSED IS IF YOU'RE WILLING TO COME AND SHOW UP AND FIGHT FOR THEM! THE HEARING ROOM AND CAPITOL HALLS NEED TO BE PACKED WITH BIKERS!**



# COAST TO COAST BIKER NEWS

**FRANCE PARALYZED BY PROTESTING BIKERS:** Despite pouring rain, nearly 100,000 angry motorcyclists brought every major city in France to a standstill in protest of unfair proposals including requiring every rider to wear a fluorescent yellow high visibility vest, banning traffic filtering (lane splitting), and increasing the size of motorcycle registration plates.

Organized by the Federation Francaise des Motards en Colere (FFMC – French Federation of Angry Bikers) through its highly efficient network of regional and local offices, Paris alone saw more than 15,000 bikers blocking the heart of the capital, with thousands more paralyzing dozens of cities across the country for hours with demonstrations against the French government and interior minister Claude Guéant for their anti-motorcycle policies and proposals.

“Bikers in France are just fed up with Guéant’s stupid proposals and his ‘I can’t see you, I can’t hear you’ attitude, to the extent that almost 100,000 of them have today stood up against their government and paralyzed the whole nation,” reported [www.ukfrancebikers.com](http://www.ukfrancebikers.com).

In response to the largest motorcycle protest in France’s history, road safety director Michèle Merli said on national radio that bikers misunderstood the proposed obligation to wear a high visibility vest but would rather propose to riders that they wear a little yellow strap around their arm so that they can be better seen by motorists.

UK France bikers.com says they believe that “it is not the bikers who have misunderstood the latest government’s proposals but rather the French government who continue to severely misunderstand and under-estimate the safety of riders.”

**CONGRESS CONSIDERS ALCOHOL PROHIBITION:** Recognizing that higher levels of ethanol in gasoline can cause engine damage and void warranties for motorcycles, all-terrain vehicles and many other small gas-powered motors, U.S. Representative Jim Sensenbrenner (R-WI) has introduced H.R. 748 to prohibit the EPA from authorizing the use of gasoline containing greater than 10% ethanol.

The U.S. Environmental Protection Agency recently approved E15, gasoline containing 15% alcohol, for use in 2001 or newer cars and light duty trucks, though most on- or off-highway motorcycles and all ATVs are not approved for its use, and using the hotter-burning fuel could void the manufacturer’s warranty.

Motorcyclists should be concerned about the availability of compatible fuel supplies if gas stations primarily provide E15 gasoline for the majority of their customers, and riders are urged to contact their Congressional Representative to support H.R. 748.

**FEDERAL EFFORTS TO HALT “LEAD LAW”:** Congressman Denny Rehberg (R-MT) successfully inserted language into an appropriations bill on June 17 to prevent the government from using federal funds to enforce a ban on the sale of kids’ dirtbikes and ATVs due to the lead content of certain components.

A so-called “Lead Law” was passed by Congress in 2008 to protect children from the toxic metal typically contained in cheap imported toys, but the sales ban has also been enforced by the Consumer Product Safety Commission against youth-sized cycles which contain lead in certain components like batteries and brakes.

If passed with the Rehberg language intact, the federal funding measure would prohibit the CPSC from using money to enforce lead-content limits on off-highway vehicles intended for sale to children 12 and under.

In other developments in opposition to the “lead law”, a key Congressional subcommittee has approved a bill to exempt dirtbike and ATV battery terminals and other lead-content parts from the CPSC enforcement, voting on May 12 to send the Enhancing CPSC Authority and Discretion Act on to the full Committee on Energy and Commerce for further consideration.



**CAROLINA PROHIBITS MOTORCYCLE-ONLY CHECKPOINTS:** “HB 381 an Act to Prevent Law Enforcement Agencies from establishing patterns for vehicle stops at checking stations based on a particular type of vehicle is now Session Law 2011-216,” reports Doc Ski, legislative director for CBA/ABATE of North Carolina and a member of the National Coalition of Motorcyclists Legislative Task Force (NCOM-LTF).

The legislation passed unanimously through both houses of the legislature, and was signed into law on June 23 by Governor Beverly Perdue, making North Carolina the second state in a month behind New Hampshire to enact such laws in response to NHTSA funding of motorcycle-only checkpoints to stop motorcyclists en route to major biker events to check equipment and paperwork.

This bill, sponsored by Rep. John A. Torbett (R-Stanley), provides that a vehicle checkpoint pattern designated by a law enforcement agency shall not be based on a particular vehicle type and must include all types of vehicles, but does not restrict any other type of checkpoint or roadblock which is otherwise lawful.

In addition to preventing motorcycle-only roadblocks, Governor Perdue also signed HB 113 to increase the minimum penalties for violating the right of way of a motorcyclist. The previous fine for this infraction was a mere \$25, but this bill sponsored by Rep. Ric Killian (R-Raleigh) calls for a \$200 fine for a driver who causes a motorcyclist to leave his travel lane. The fine is increased to \$500 if there is property damage or personal injury sustained from this violation.

**STATES GREEN-LIGHT RED-LIGHT LAWS:** Motorcyclists in a growing number of states are being allowed to go through red lights when sensors aren’t able to detect they are there. Effective July 1, Virginia became the tenth state since 2002 to give motorcyclists license to proceed with caution after stopping when the device that causes the light to change from red to green doesn’t activate, while a similar bill in Illinois sits on the governor’s desk awaiting his signature.

HB 1981 by Virginia State Delegate Thomas A. Greason (R-Potomac Falls) allows riders of motorcycles, mopeds and bicycles to treat red lights as stop signs provided they come to a complete stop for two cycles of the light before proceeding with due care when safe to do so.

Illinois Governor Pat Quinn has until August 29 to sign or veto HB 2860 by Rep. Dan Beiser (D-Alton) which would permit motorcycle operators to proceed through a steady red signal that fails to change to green within a “reasonable period of time”. In order to garner support for the measure, the city of Chicago was exempted from the proposed new law.

Kansas also recently passed a “dead red” law that allows motorcyclists to run inoperable red lights without risking a ticket, and similar legislation has passed in Minnesota (2002), Tennessee (2003), Arkansas (2005), Idaho (2006), Wisconsin (2006), North Carolina (2007), South Carolina (2008), and Missouri (2008). Texas and California have addressed the problem by passing laws to require stoplights to be fitted with sensors that can detect motorcycles.

**PENNSYLVANIA OKAYS SUNDAY BIKE SALES:** Governor Tom Corbett marked the midpoint of the 2011 legislative session in July by signing dozens of new laws, including legislation allowing Sunday sales for motorcycle dealers.

Effective in sixty days, licensed Pennsylvania motorcycle dealers will be allowed to sell, buy or trade bikes on Sunday. Current law allows the sale of motorcycle parts and other merchandise on Sunday, but not bikes.

SB 419 is designed to give Pennsylvania dealers a level playing field with neighboring states that allow Sunday sales. Supporters have said sales have fallen in southeast Pennsylvania stores and have grown in New Jersey and Maryland since Sunday sales began recently in those states.

**HARLEY-DAVIDSON AUTOMOBILE LICENSE PLATE DEBUTS IN WISCONSIN:** The first-ever Harley-Davidson license plate for automobiles is now available to Wisconsin drivers to help fund safety initiatives. The new license plate is the first and only Harley-Davidson branded plate available anywhere in the United States and it is only being offered in Wisconsin -- the birthplace of Harley-Davidson.

Harley-Davidson Motor Company is partnering with the Wisconsin Department of Transportation to make the Harley-Davidson/Share the Road plates available for automobiles, light trucks and motor homes as of April 13, 2011. The cost of the plates will include a \$15 issuance fee, and an annual \$25 donation that will help support safety initiatives throughout the state.

The car-size license plate was designed in collaboration with the Harley-Davidson Motor Company Styling Team. The words "Share the Road" are displayed to emphasize the importance of motorcycle safety.

## DELAWARE GOVERNOR VETOES HELMET LAW REPEAL:

Governor Jack Markell has vetoed HB 95 which would have repealed the requirement that persons operating a motorcycle in Delaware carry a safety helmet. Since 1978 when the state repealed their mandatory helmet law, Delaware has one of the most unique helmet laws on the books by requiring riders to have a helmet in their possession on the bike, but not requiring those over 18 to actually wear one.

Even as Delaware riders hear of their governor's decision, all eyes are on Michigan where a bill to repeal their 42-year old helmet law appears destined for their governor's desk, where its fate is no more certain.

The Michigan Senate recently voted 24-14 to approve a measure that would allow motorcyclists 21 or older to go lidless if they have been licensed to operate a motorcycle for at least two years or have passed a safety course, though ABATE of Michigan opposes an amendment requiring \$100,000.00 in medical coverage to ride without a helmet, calling it excessive and noting that many insurance companies don't offer such coverage, and if they did the cost would be prohibitive.

ABATE says they will fight to have the insurance requirement removed as the bill moves through the house, but though republican Governor Rick Snyder remains non-committal he has hinted to the Detroit News that he's willing to consider the elimination of Michigan's motorcycle helmet law in the context of general auto insurance reforms that he's preparing to propose to lawmakers. Three previous attempts to repeal the helmet law have been vetoed by prior governors, twice by Snyder's immediate predecessor democratic governor Jennifer Granholm.

## JUDGE UPHOLDS PATCH-HOLDERS RIGHTS:

"A federal judge has rejected an unprecedented bid by the U.S. government to seek control of a gang's name and its identity - via its logo - through a court order in a case involving the notorious Mongols motorcycle club," according to the Associated Press report regarding an eight-page ruling by U.S. District Court Judge Otis Wright, II who wrote on June 28, 2011 that he must "regrettably" rule in favor of the Mongols because the group itself was not named in a 2008 racketeering indictment.

To summarize the Court's findings, Aid to Injured Motorcyclists (A.I.M.) Attorney Boyd Spencer of Pennsylvania wrote: Since the Mongols Nation Club was never indicted, much less ever convicted of any criminal act, then the criminal forfeiture of the trademark owned by the Mongols Nation was in total error.

The Mongols Motorcycle Club, or Mongol Nation, owned the trademark of the club colors since 1969.

Any assignment made by any member of the club to himself or any other individual was void. This is because the trademark was a collective membership mark which can only be owned by the organization for which the Mark stands. Only the Mongols Club or Mongols Nation could have a property interest or own the patch, colors, or trademark for the patch or colors.

Since the Mongols were not indicted in the criminal action, the property of anyone other than the defendants in a criminal action cannot have their personal property forfeited.

This order, and the prior litigation that led up to this order, is a victory for the rights of motorcycle clubs to own, display, and fly their colors, without forfeiture by the government.

## Install a Brighter Brake Light Bulb from Gadget & the BMW Riders’ Webpage

Our Vulcans use dual 1157 bulbs as a combo tail light and brake light. If you’d like a bit more visibility when braking, you can change this bulb out for a 2357 bulb. The 2357 is available at any auto parts store (there’s also a 2357A which is yellow). It produces the same brightness for the tail light (3 lumens) but 25% more light for the brake (40 lumens vs. 32)

So why didn’t Kawasaki use the 2357 bulb in the first place? Well, there’s a downside or two that you’ll have to weigh. The power required to run the 2357 bulb is the same as the 1157 in normal running, but with brakes applied there is a slight increase in the amps required (2.1 for the 1157, 2.2 for the 2357). The resulting increase in watts used is 1.28 watts, or a 4.76% increase over the standard 1157 bulb. You probably won’t lose any sleep over that. The major sticking point is bulb life. Your 1157 brake light element is rated for 1200 hours while the brighter 2357 element is rated for 400 hours. (The tail light element in both bulbs is rated the same at 5000 hours).

THIS JUST IN: If you can find them, Sylvania has a long life 2357 bulb labeled 2357LL which has about double the life of the standard 2357. Read more about it on the Sylvania Website

And the price of 25% more light while braking? About two dollars for both bulbs.

There is also a Halogen bulb option, but you’ll risk melting your tail light lens using it. Details are on this BMW riders’ webpage (along with more stats on the above change): <http://www.ibmwr.org/ktech/taillite.shtml>. John Del Santo

## In the Gloom of the Night by John Del Santo

When you were a kid, did you ever want to be invisible? Well, riding at night comes darn close to it! You know that many car drivers just don’t “see” motorcycles and even in the daytime many riders are struck from behind when slowing down or stopped. People who are stone sober see a lot less after dark, and anyone who has had a couple of drinks loses a decent amount of their judgment, reaction time, and night vision. Older drivers have gained skill and experience, but have less night vision and glare recovery, and newer drivers are sharp and quick but haven’t built the skill to recognize hazards quickly or the experience to know the best way to react to them. There are a lot of different people sharing that night road with you! When you are downshifting for a turn or stop, a couple of flashes on your brake-light should wake up the driver behind you to the fact that you are slowing. From dusk to dawn, the more you are aware and the more you can light-up and reflectorize yourself, the less chance you have of being mowed down.


At night we are looking well up the road, way beyond the puddle of our headlight. We’re looking for MOTION - the swing of an arm or flash of a sneaker. You will catch a flicker of motion if someone two blocks away walks between you and a road reflector or a reflectorized license plate. You’ll see that long before the pedestrian comes into view. Constant surface appraisal is the key for spotting oil, water, potholes, rocks and escaped tire treads. Scan for darker or lighter spots in the road where there shouldn’t be any.

Animals are active at night and are pretty much invisible from dusk on. They aren’t lit up and don’t wear safety vests and you can be right on them before you realize they are there. Fur doesn’t reflect any more light than a black leather jacket does, think about that. That’s a whole different concept of ‘Wearing Colors’.

After dark you are more likely to have moisture on the road. Even on dry road, at only 40 mph it will take you at least 120 feet to stop your bike (reaction time plus braking distance). If you can’t see further than 120 feet and you are running at 50 mph, then there is NO WAY you can stop when a hazard pops into view!

Overdriving your visibility (or ability) into the dark is just as dangerous as overdriving your visibility (or ability) into blind curves in the daylight. You can often swerve around a hazard, but this can sometimes result in an “unexpected improper dismount” and if you’re down at night, the next car coming around the curve will probably run you over.

So to go “Peacefully into the Night” be Alert, Be Visible and look for the Invisible.

## Time to Re-Tire?

A good set of properly inflated motorcycle tires with good tread keeps us attached to the road and separates us from being just another flying object. The National Highway Traffic Safety Administration estimates that hundreds of thousands of crashes could be prevented if vehicle owners kept their tires properly inflated. This agency recommends checking your tire pressure at least once per month. When you're on a trip, checking the pressure every morning is not a bad idea. According to the U.S. Department of Energy, keeping your tires properly inflated can improve your gas mileage up to 3.3%. And this quote was made before gasoline prices reached four bucks a gallon!

The MSF's "T-Clock Inspection" advises us to check: "TIRES: Tread depth, wear, weathering, evenly seated, bulges, imbedded objects. AIR PRESSURE: Check when cold, adjust to load/speed". If you do a lot of one-type of riding, such as a lot of freeway, your tread will wear unevenly; part of the tread can wear down while other parts look deep enough. Watch for the "wear bars" in the tread. When you change your tire, invest in a new valve stem.

Depending on the shape and size of the wheel and the valve stem, it can be a pain in the butt to check the air pressure on your bike. "Aw, what the heck, the tire looks round, it must be OK". I bought a small, brass, right-angled valve stem from San Diego BMW that attached to the valve stem on my wife's bike and made her life easier. Some Honda's come with a large L-shaped valve stem that sticks out and simplifies reaching

the stem with a gauge or air hose nozzle. That stem comes with a plastic support to keep the stem from vibrating, and if the stem is installed without that support, road vibrations can cause a crack in the stem and cause an instant "Air-Out". That was an exciting experience!

[AccuPressureCaps.com](http://AccuPressureCaps.com) sells a valve stem cap that changes color when the tire pressure starts to get low. If your tire pressure is too low, or too high, the tread will start to cup or bow and not make proper contact with the road. That kinda defeats the whole purpose of having good tread. The recommended pressure printed on the side of the tire is there for a good reason.

Any time a tire starts showing ozone cracks in the sidewall, it's time to replace them right away. Sidewalls operate at some pretty high temperatures due to the bending of the sidewall and any separation on a sidewall can cause catastrophic tire failure. A tire has a wax-like preservative in the rubber compound to keep it from hardening and splitting. This material is like sun blocker. It's that off-color material that seems to show up on your sidewalls for no reason. It protects the compound against ozone which is produced by the sun and also by electric motors. This protectant helps the compound to stay soft. It can be worn away, washed away, and chemically washed/leached out of the tire.

Do NOT clean your tires with stuff like Armor All. There are a few solutions that detailers use on tires that will not harm the tires, if you are into "pretty" instead of functional, but when applying even these, you can use it on the sidewall but not past the line that separates the sidewall from the tread area.

There are many important round things in life, like Silver Dollars and Crispy Donuts, but the most important are your motorcycle tires! They keep us alive and keep our knees in the breeze! Take good care of your tires and they will take care of you.



# Living in a Nowhere Land

“Honest, Officer, he came out of NOWHERE!” That phrase is heard so often at accident scenes and shows that a lot of drivers out there have no idea that there are blind spots all around them that don’t show in any mirror. Maybe they’ve heard about blind spots, but they don’t know where they are and certainly don’t check them before they make a move! It’s up to us to avoid getting caught in their mistakes.

You will be in someone’s blind spot hundreds of time each day; the trick is to stay there as short a time as possible. Be aware, watch for head motion or their tires starting to creep towards your lane, have an escape route open; and be ready with your throttle, brakes, and horn if they start to move towards you. Eye contact is good, but how many times has someone looked right at you and then pulled right out in front of you. You know that many drivers have unconsciously programmed themselves to look for cars and they just don’t see motorcycles. If you have a headlight modulator on your bike or run with your headlights on high beam during the day, it may help the car drivers to be aware. Many of the older members of the driving society have started to lose some of their hearing (this author included), and the more expensive cars are being produced to be so soundproof that the occupants can just barely hear the siren on a fire truck, let alone your mufflers. Folks who think that “loud pipes save lives” are liable to get a big surprise.

If you are driving through town on a multi-lane road, and a van or truck going in your direction is waiting to make a left turn at an intersection while you are passing them by in the right lane, you are in a major blind spot of the car coming from the opposite direction that is also making a left turn. Be ready! Bushes, fences, a stopped bus or a parked van, all create blind spots

at any intersection or driveway.

You know about the huge blind area behind a big truck, but there is also a big blind spot just off their right front fender. When you are behind a big truck or next to one, if you cannot see their face clearly in their mirror, then they can’t see you!

Car drivers who have decorations, parking placards, or big smelly deodorizers hanging from their rear-view mirror have created a blind spot out in front of them, off to the right side, that will hide a motorcycle or pedestrian until they are almost on them. People who turn their sun-visor sideways to keep the sun out of their side window may not see traffic coming from the left side until it is almost too late. Pickup trucks with caps and big family vans have major blind spots.

You know that tailgaters are also lane jumpers. Keep a special watch on them and the dopes that appear to be yacking on a car phone or texting. When the sun is low on the horizon and glare is everywhere, everybody is in someone’s blind spot.

It would be a bit extreme to think we need to shoot flares off in front of us as we’re tooling down the road, but if you assume that all the drivers never check their blind spots, are not concentrating on their driving, and may do just about anything at any moment, then you are taking good defensive steps towards keeping out of harm’s way. Stay visible and RIDE SAFE.



# To Blink or Not To Blink

California drivers do not need to use their turn signals if no other car is nearby according to a ruling handed down recently by the state's second-highest court. A three-judge panel of the court of appeal found that a La Habra Police Officer was in the wrong when he stopped Paul David for making a right-hand turn in his Chevy SUV without signaling. The Officer was about 55 feet away traveling in the opposite direction

at the time David made his turn. The road was otherwise empty. The Officer charged David with violating Vehicle Code section 22107, which states a signal must be used when "any other vehicle may be affected by the movement."

Because the police car was approaching from the opposite direction when David's vehicle made a right-hand turn away from the officers vehicle, and no other vehicles were present, there was no possible violation of section 22107 the Judge ruled.

This is good information to have on hand if you are ever bagged for turning without signaling, but do we really want to add "to blink or not to blink" into our driving habits? With all of the thousands of thoughts and decisions it takes to successfully pilot your motorcycle through traffic, why would we add "I'm getting ready to turn, so I need to signal continuously within 100 feet (that's about two tractor-trailer lengths) is there any vehicle or pedestrian within a hundred or so feet of the turn? Which direction are they headed? Is there anyone in any of those parked cars who is ready to throw open their door? Is there anyone in any of those parked cars who is ready to flip into a U-turn? Because we know that U-turners never signal their intentions because their cars did not come equipped with a

U-turn signal. Is there anyone in any of my blind spots? OK, it all looks clear, so I guess that I can turn without using my signal"

Man, that is an awful lot of work to avoid just signaling! You should build your driving habits so that when you are turning, you are signaling, period! That is WAY less work! Doing otherwise would be like if before coughing or sneezing I took the time and effort to check the whole area to see if there was anyone who I would be spreading germs on or who I would be spitting on their necktie or whose sanitary habits I would be offending and then deciding whether I would cover my mouth or nose or not. Of course not, we have trained ourselves as we became adults that if a cough or sneeze was coming, we cover up! When we are preparing to change the direction we are riding in, we signal. So with just a flick of our thumb, we let other folks know what our intentions are and reduce the chances that they will do something to get in our way and put us in harm's way.

Just read the American Motorcyclist Associations (AMA) August 2011 magazine article about HR412 which would amend a law aimed at lead in children's toys that inadvertently blocked the sale of kids' dirt bikes and all-terrain vehicles.

The bill is intended to exclude kid-sized machines that were ensnared in the Consumer Product Safety Improvement Act (CPSIA) of 2008. The CPSIA was intended to ban small toys with high lead content, but because of broadly written language, it has been interpreted to apply to all products for kids 12 and under, including dirt bikes,

ATV's, bicycles, clothing and books.  
In response to the outcry from AMA members and others, officials issued a stay of enforcement of the lead-content portion of the CPSIA, but did not eliminate the ban entirely. The stay is set to expire at the end of the year.


