## Lobbyist's Legislative Report

As we are writing this Bailing Wire Legislative Report, the Legislature is finishing the introduction of some 2000 Bills for the February 18th Deadline. We will be reviewing a plethora of Bills with a full report in our April issue and update our members to pertinent potential laws affecting Motorcyclists.

So far, we have introduced AB 2125 by the Vice Chair of Assembly Transportation Committee Vince Fong (R - Bakersfield). Our bill will establish a Pilot Program and allow Motorcycle riders to do the DMV motorcycle skills field test at a DMV office or at CMSP ranges. Currently the wait to do the DMV test for riders is up to three months at most DMV offices. This supplemental option will be offered weekly on 25% of the CMSP sites for the Pilot Program for the next 5-7 years.

Also, Senator Brian Jones (R - San Diego), a fellow rider, introduced SB 894 which will allow our Off-Road riders to continue using their 2022 off-roads bikes at State Vehicular Recreation Areas - BLM - US Forestry areas in California. This clarification is due after SB 227 Jones (2021), which went further last year, was killed by the Appropriations Chair Lorena Gonzalez. She has retired to take over as Head of the California AFL-CIO. The new Chair of Assembly Appropriations Chris Holden (D - Pasadena) has been fair to work with on our motorcycle bills.

With the indoor mask requirements being lifted - finally! - it will be a much better year. We will be able to do in person testimony in front of the Legislators in a Capital hearing room, as well as meeting with the Members and staff to discuss legislative bills that we Support or Oppose in their offices!

## Politics – Legislative: Bills At A Glance

### AB 2125 Fong (R – Bakersfield) Driver's licenses: motorcycle licensing pilot program:

This bill would require the Department of Motor Vehicles to establish a pilot program in order to evaluate the efficiency and safety, among other things, of using motorcycle safety program service providers and grant recipients to administer the driving demonstration portion of an exam to receive a license to drive a motorcycle, as specified. The bill would require the program to last 5 years and require a minimum of 25% of motorcycle safety program service providers and grant recipient sites to participate in the program. (Sponsor)

### SR-41 Caballero (D – Salinas) Motorcycle Profiling:

According to the Department of Motor Vehicles, there were 857,273 motorcycles registered in California in 2019. Motorcycle profiling is the illegal use of the fact that a person rides a motorcycle or wears motorcycle-related apparel as a factor in deciding to stop and question, take enforcement action, arrest, or search a person or vehicle with or without legal basis under the Constitution of the United States. Rallies to raise awareness and combat motorcycle profiling have been held in multiple states and six times at the California State Capitol since 2011.

\*Passed Senate Floor Unanimously 39-0 on 7/12/21

### SB 894 Jones (R – San Diego) Off-Highway Vehicles:

This bill would require, for the issuance or renewal of a competition identification, a specified configuration for the vehicle identification number and product identification number for an off-highway motor vehicle or ATV that is model year 2022 or later and is used solely for competition not on a public highway. This bill would require that a competition motorcycle display that identification plate or device on the left side of the motorcycle, commencing January 1, 2024. (Supporting)

### AB 958 Gibson (D – Los Angeles) Peace Officers: Law Enforcement Gangs:

This bill would define a law enforcement gang, a group of law enforcement officers within an agency that engages in a pattern of specified unlawful or unethical on-duty behavior, and would require law enforcement agencies to have a policy prohibiting law enforcement gangs and making participation, as specified, in a law enforcement gang grounds for termination. The bill would require an agency to disclose an officer's termination for involvement in a law enforcement gang to another law enforcement agency conducting a preemployment background investigation of that officer, as specified.

\*Signed into Law

### SB 66 Allen (D – Santa Monica) California Council on the Future of Transportation: advisory committee: autonomous vehicle technology:

This bill would require the secretary to establish an advisory committee, the California Council on the Future of Transportation, to provide the

Governor and the Legislature with recommendations for changes in state policy to ensure that as autonomous vehicles are deployed, they enhance the state's efforts to increase road safety, promote equity, and meet public health and environmental objectives. The bill would require the council to be chaired by the secretary and consist of at least 22 additional members, selected by the chair or designated, as specified, who represent, among others, transportation workers, various state and local agencies, and a disability rights organization. The bill would require the council to create subcommittees focused on one or more specific topics and to form one subcommittee led by the Office of Planning and Research focused on furthering the state's environmental, public health, and energy objectives, as specified. The bill would require the subcommittee to submit policy recommendations to the council and the Legislature by January 1, 2024, and to make those recommendations publicly available. (Supporting)\*Held in committee and under submission

As an added bonus, when you sign in for the ride you will get a free chance for the membership raffle - a free raffle ticket. You can purchase more if you like, and at a \$1 a ticket it's a good bargain! You can sell these raffle tickets to anyone and everyone.

March is the start of the spring season and with that brings bike nights, weekends at the dealership and the start of spring rides where folks congregate. Be sure, if it's possible, to carry your membership cards with you and before hand determine what sales pitch you need to use to interest new members. Have an approach for the various types of riders, sport bike riders, cruiser riders, and the dresser riders. Also remember to be polite when addressing your prospective new member. The key is to establish a good rapport with the prospective new member. That way, if he does not immediately sign-up as a member, he will have had a pleasant experience.

Remember to keep your members informed, because not all of your members will always be able to attend your Local's meetings. If they like your product, they will keep supporting your product, which is ABATE of California. The end result will be a renewal card when their membership is due.

Finally, I have been doing my membership report for a long time and have pushed keeping and retaining your members and business members with my columns.

Due to some personal changes, I, your ABATE Membership Chairman, will need a Technical Assistant. I am requesting someone who knows how to maneuver around computer programs (Access) to assist me with the processing of membership applications and renewals. **Membership Assistant Requirements:** Assist the State Membership Chairman when requested with keeping membership records in Access and inform the Locals of Changes in Membership as they occur. Assist with sending out monthly Membership Lists in (.Pdf) & (.xls) formats via email. Assist the State Membership Chairman when requested with sending out Membership Renewal reminders the 15th of each month. Assist the State Membership Chairman when requested with sending out and process Members who have become Inactive after 90 days by changing their status in Access, removing Ads from the BW, removing them from the Discussion Group list and notifying the Locals. Keep records for the Annual Membership Drive and report results on a quarterly basis to the State Membership Chairman.

At year end, assist the State Membership Chairman when requested with processing certificates and providing checks, via the State Treasurer, for the winners. On a Quarterly Basis generate and report Membership/People Numbers to the Membership Chairman. On a monthly basis generate Membership Cards/Certificates and send out with Membership pins/plates. Order plaques for New Business Members. Assist the State Membership Chairman when requested with organizing and administering the Annual Membership Raffle: get tickets printed, disburse to each Local President; collect stubs & Money, record receipts. # Safety Report

## I Love February

February is a great month. In So Cal it's 85 degrees and clear blue skies. It's a winter 85 degrees, yer not sweating like a hot August 85 degrees. You all know what I'm talking about.

The second month of the year out here usually means no more winter rain or cold fronts. We could get a rain or two but don't bet on it. It's the start of riding season of all sorts, whether street or dirt or track, it's about getting it on! Let the adventures begin!

The good news is that we can relatively ride without the nuances of bugs because it still gets fairly cold at night, whoopee! I do believe its different up in the Northern part of California, but my residence is down here and I'm reporting from my zone for now. From what I'm hearing, we would like some more of the winter season, but not too extreme, at least on the weekends when we can ride with short sleeve shirts and skimpy clothing worn by our significant others.

I have been preparing my bike for the riding season early this year, even though I keep a good eye on my bike year-round. After the winter season, I really get into the extra things to do because of the down time of winter. I usually do the major service and install new parts or have work done in January in preparation of riding without any major issues that could happen during the prime riding season. It's also about making sure my bike is safe and trustworthy.

Let me refresh you all, I just had my 6th operation on my legs at the end of this January. I took the last year off after 5 operations in 3 months to recuperate. I'm still recuperating while having additional operations. I'm backtracking somewhat to get my feel of writing back, or as I call it, unscrambling the fried brain syndrome!

When we talk about or think about motorcycle safety we think of the obvious - accident prevention and motorcycle safety while riding. We also have a plethora of motorcycle safety schools and the barroom discussion platforms etc. There are many organizations and private operations that help us all as far as staying educated while riding, but I think there are many more chapters in motorcycle safety that we are not really exposed to or we just take it for granted and that all is well as long as I survived the day its ok.

The motorcycle safety courses are out there and it's a country wide solution. They are geared to how to handle your motorcycle, certain situations to avoid or how to react in case you are put into these situations that can save your life or escape injury. Most courses give you the standard training and they expect you to advance your knowledge on your own, which is cool. I understand that almost every situation is different and the learning curve is as big as the number of riders out there. There is nothing better than experience on the road and sometimes it gets the best of us, that is the bad part of learning. For some it retires new riders and experienced riders as well, but for most of us we get knocked down and we get back up, then there is the elite, the ones who for the most part go through life unscathed. It's not luck (we'd love to have it) or timing that saved us from some sort of freak accident. I like to think of it as skill and staying focused while riding. To have the ultimate confidence while riding is freedom of the road, period! It's what most of us live for, outside of playing music with me bandmates, riding is second to none when you want to escape your life temporarily.

I have seen the best of the best riders get killed and the dumb of dumbest riders ride for all their life, go figure. I have no regrets for this last statement, it's true in what I have noticed all my life and maybe yours as well. What I have learned is that we only have limited control and usually what's not in our control usually makes us a statistic, because stuff happens, as we all say. What we do have is control of our body and mind, even though for a lot of us we have limited control due to aging and thus we medicate or change our lifestyles. When you get to a certain age you will know what I'm talking about, it's pure facts and sometimes it sucks big time!

Aging is graceful and it is prejudiced to the blessed. I am really grateful for my journey because I've left a lot of loved ones behind for one thing or another and sometimes old age feels like a curse but that's life. When we hit certain ages, we experience changes, for most of us it's more than one thing. It's usually one thing that leads to another and so on. I know now how important it is to share this because we all are subjected to some kind of illness/disease and the best thing you can do for it is to become aware of your body and mind, you need to start taking care of your guts! We do this for our motorcycles, cars, houses and whatever, but we kind of put our health on the back burner, it's a fact! It's not a macho thing or it will never happen to me kind of thing. The fact is, as we age and our guts wear out and we must go that extra mile sometimes just so we can ride. If I didn't change my life as per regular checkups, taking the proper medications and being on a vitamin/herbal kick, I wouldn't be riding today and that would really bother me. Staying healthy is a vital part of motorcycle safety!

Changing the subject now; how's your tire pressure? Has your bike hibernated for any length of time, even just a month or so? Tire pressure should be on the top of everyone's list of bike preparations. A few months ago (I'm still recovering) when I got my bike out early of winter prison, I checked my tire pressure and the front tire registered 25 pounds and the rear tire didn't register at all. The weird thing about this was the tires looked okay. They didn't look flat, just a little low. When I moved my bike, I could tell how low my tire pressure really was. I have this urge to check my bolts, screws, nuts and any other kind of fastening or mechanical parts that can vibrate and loosen over a period of time. I just know the V-twin vibrates more than a tectonic plate during an earthquake.

All it takes is one or two loose bolts and you can lose your oil fast thus causing a great panic, especially if it's making your bike smoke like a Churchill cigar in the wind. This happened to me and when I saw a white oil cloud following me on the freeway I had to pull over. I was shocked that my bike would be smoking that bad. When I pulled over and inspected my bike, I was glad I did. Oil was on my exhaust pipes, rim and tire and wherever oil can go while cruising at 65mph. On the bottom of the engine is where it was loose. I could feel where the oil came out. This was a first for me and the last time it has happened, end of story.

I think about it and wonder if I was lazy or just didn't check my bike out before I rode it or I just never tightened those bolts before, never the less it's on my list of nuts and bolts to inspect throughout the riding season or prepping for a major road trip. I feel like I got complacent and therefor I'm double checking myself until I feel I don't need to anymore, it's a humanistic instinct that we all have because we're human!

Should we have pre ride inspections? Pilots do it because human error is real and missing stuff while inspecting could be dangerous for the individual or individuals, as it happens all of the time. As I get back into riding (CONTINUED)

shape, I look forward to more adventurous rides by the time summer rolls around. I've got a lot of healing to do and one way to heal better and

### **NEW YEAR = NEW LEGISLATION:**

With 2021 in the rearview, New Year 2022 has hit the ground running in several states considering pro- and anti-biker laws, including some helmet legislation, profiling, noise, motorcycle safety, lane splitting, bike parking and lighting issues.

Freedom of Choice on helmet use is on the docket in some of the 18 states that still mandate riders to wear them, such as Massachusetts (H3524 & S2328: helmet standards), Nebraska (LB581) and West Virginia (HB2711 / SB127), while New York seeks to study the efficacy of helmets (A1107) and Alabama's legislature will consider requiring reflective headgear (SB65).

Lane splitting has been a hot topic lately, and Massachusetts (H3513 & S2315), Virginia (HB838) and Washington (HB1106 / SB5622 & HB1254) hope to join California, Montana, Utah & Hawaii in allowing motorcycles to bypass slow moving vehicles in heavy traffic situations.

Likewise, anti-biker profiling by law enforcement has been on many states' agendas since being enacted in Washington, Maryland, Louisiana and most recently Idaho, and now New York is the first this year among many more to introduce legislation (A1747 / S3869) in hopes of preventing police from discriminating against motorcyclists in their application of the law.

By sheer numbers, Massachusetts takes the prize for the most pro-motorcycle bills introduced already this session, with 11 pieces of legislation including H3487 / S2329 to advance motorcycle safety, H3417 / S2331 relative to a motorcycle safety fund, and H3438 to clarify testing and enforcement of motorcycle sound emissions.

On the "anti-" side of the dockets, New York is once again considering a prohibition on children under the age of 12 from riding on a motorcycle (A148),

and Virginia will debate "excessive noise" (HB367 and HB632 / SB180).

The year is young, with many more issues of interest on the horizon, pro and con, that concerned riders need to track and stay on top of, and one of the best ways to do so is to join your state motorcyclists' rights organization (SMRO) and subscribe to the monthly NCOM Biker Newsbytes by e-mailing "Subscribe" to [NCOMBish@aol.com](mailto:NCOMBish@aol.com).

### **BIKER ANTI-PROFILING RESOLUTION NEEDS YOUR SUPPORT:**

Since the federal Highway Bill passed Congress and was signed into law by President Biden without most of the pro-motorcycle provisions that bikers across America lobbied to include, it is now imperative that riders turn their attention toward garnering support for the stand-alone measure in the House that would help prevent anti-biker profiling.

Nearly three years ago, the U.S. Senate unanimously passed a nonbinding resolution condemning the discriminatory profiling of motorcyclists by law enforcement (S. Res. 154), and now the U.S. House of Representatives is again considering a similar bipartisan measure in the 117th Congress, H. Res. 366; "Promoting awareness of motorcyclist profiling and encouraging collaboration and communication with the motorcycle community and law enforcement officials to prevent instances of profiling."

Sponsored once again by Rep. Tim Walberg (R-MI) along with original co-sponsors Congressman Michael Burgess (R-TX), Congresswoman Cheri Bustos (D-IL) and Congressman Mark Pocan (D-WI), the anti-profiling resolution was introduced in the U.S. House of Representatives on April 30, 2021 to thwart "the illegal use of the fact that a person rides a motorcycle or wears motorcycle related apparel as a factor in deciding to stop and question, take enforcement action, arrest, or search a person or vehicle with or without legal basis under the Constitution of the United

States," as profiling is defined in the resolution.

H.R. 366 acknowledges that "complaints surrounding motorcyclist profiling have been cited in all 50 States," and the bipartisan resolution denotes three actionable items: (1) promotes increased public awareness on the issue of motorcyclist profiling; (2) encourages collaboration and communication with the motorcyclist community and law enforcement to engage in efforts to end motorcyclist profiling; and (3) urges State law enforcement officials to include statements condemning motorcyclist profiling in written policies and training materials.

All concerned motorcyclists are encouraged to contact their Congressional Representatives at (202) 224-3121 to ask that they join with 59 other colleagues as current cosponsors of H.Res.366 and help put a stop to law enforcement unfairly targeting motorcycle riders for traffic stops, questioning and citations.

**NOISE-DETECTING CAMERAS TO FINE LOUD MOTORCYCLES IN FRANCE:** Traffic cameras that can identify excessively noisy motorcycles and vehicles are being deployed across France, with riders and drivers who flout the rules facing fines of €135 (\$153USD).

The debate over the devices, which have been trialed in various countries across Europe, has run rife for some time, but the French are the first nation to initiate a wider roll-out of cameras that will flash and fine motorcycles and vehicles that exceed noise levels.

The Bruitparif-designed Meduse cameras feature microphones attached to a camera that can pick up and identify the direction of noise from the road below. Should the sound rise above a certain decibel, the camera is activated and a fine is subsequently issued.

Though noise cameras are -- officially speaking -- aimed at all vehicles, many feel motorcycles are unfairly targeted compared to cars with many routes popular with bikers used during trials.

### **MOTO-GP WILL NOT RACE IN COUNTRIES REQUIRING COVID QUARANTINES:**

When MotoGP resurfaced in October 2021, it looked like Grand Prix motorcycle racing might return to normal, packing the schedule with 21 rounds including eight outside Europe, but the Delta and Omicron variant waves caused many countries to reinstate travel restrictions -- including quarantines upon arrival -- forcing organizers to play musical chairs with the calendar throughout the year.

Dorna CEO Carmelo Ezpeleta sent a clear message at a recent racing forum that MotoGP will not visit countries in 2022 that require CoViD-19 quarantines; "If they tell us that we have to be quarantined for fourteen days, the answer is clear, no, I'm not going! That's the limit," Ezpeleta claimed. "As for the rest, they can ask us to have vaccination certificates or the documentation that we already did last year and that is why it was important to go to the United States as a test of what can be said to the rest of the countries."

Last year, MotoGP successfully ran events in Qatar and the United States, unfortunately the only races held outside Europe, while Japan and Australia are still requiring such measures, and Thailand is trending that direction.

With the Japanese and Australian Grands Prix set for September and October, 2022, the situation could hopefully change, while MotoGP's pre-season runs will also be a testing ground for Malaysia and Indonesia's ability to accommodate the international race series.

**JAPANESE MOTORCYCLE SALES HIT 23-YEAR HIGH:** Prior to the Coronavirus pandemic, motorcycle enthusiasts and OEMs alike lamented the elusive Millennial buyers and declining sales, but throughout the global health crisis, motorcycles have surprisingly

surged in popularity. As a result, manufacturers experienced record sales growth, with Ducati, BMW, and Energica reporting large gains in 2020 and 2021, and Japanese OEMs have similarly benefited from the increased interest and the "Big Four" (Honda, Kawasaki, Suzuki and Yamaha) are reporting that domestic shipments hit a 23-year high in 2021 (235,755 units in-country, up 20.6%).

In addition to the sales uptick, Honda, Suzuki and Yamaha all report increased sales among younger riders.

Before the pandemic, Japan's more restrictive emissions laws thwarted ridership growth, but 2021 marks the Island Empire's most successful year since 1998, when customers purchased 318,080 new motorcycles.

### **FOR WHAT IT'S WORTH: MOTORCYCLE RACERS BLINK LESS:**

A recent study has found that MotoGP riders blink far less than non-racers, with one test subject going 9 minutes without blinking!

During the first round of the 2021 MotoGP season, Pramac Ducati rider Johann Zarco set a new series top-speed record of 225 mph. At that speed, riders cover 330 feet in one second. The average blink takes 0.15 seconds, so riders traveling at that top velocity are effectively blind for nearly 50 feet of track.

That sounds like a terrifying prospect to us mere mortals, but a study between LCR Honda and Italian pharmaceutical company Sifi helps explain how MotoGP riders' eyes function in such extreme conditions. Conducted over six MotoGP seasons (2015-2021), Grand Prix riders would undergo tests prior to the race and 30 minutes following the checkered flag. The dual-test method revealed that rider reaction times and pupil performance remain in "Race Mode" for an extended period.

All racers easily exceeded the normal 4-6-second blink interval, and despite the stressful conditions, none of the subjects exhibited red, dry eyes or inflammation.

The results may be fascinating, but Sifi co-owner Carlos Chines believes this is just the beginning of a broader, long-term study.

"We basically want to continue researching the differences between 'normal' eyes and those of MotoGP riders," revealed Dr. Chines. "We also want to investigate the relationship between concentration and blink rate. From these results, we expect to understand whether one can work with little tricks, exercises, or eye drops to counteract fatigue, dry or sore eyes, and deterioration in vision."

**DROPPED BIKE BLUES:** Well, it's too late to write to Santa for a saddlebag stuffer, but you can contact Airbiker to acquire their portable assistive device to pick up downed motorcycles.

No matter how your bike got to the ground, you have to pick it up somehow, and while plenty of riding instructors teach methods to help you pick up a downed bike, the moment of truth may seem much different when you eventually face it.

Plus, the bigger the bike, the more intimidating the task, and what if you have a bad back or other injury that makes it a less smart idea to manhandle your scooter?

That's the problem that French startup Airsink wants to solve with their new product called Airbiker; a small pouch with an inflatable balloon and a few CO2 cartridges inside that gives enough boost for you to grab the handlebars and guide it back upright from a completely prone position on the ground.

It all packs up in a little zippered pouch, much like countless mini air-compressor units that riders may already carry in the event of flat tires, and is available directly from Airsink ([www.airsink.fr/boutique](http://www.airsink.fr/boutique)) at prices ranging from €130 (roughly \$147) to €195 (\$221).
