The ABATE Board of Directors feels both of these pieces of legislation will be very beneficial and are critically needed by EVERY rider in California and we are committed to actively monitor and support their legislative journey through our state capitol.

Stay tuned, I'm sure there will be more to come on these pieces of legislation! Until then, just "DECIDE TO RIDE"! Dave H.

We have just completed our first ABATE Board of Directors meeting of 2016 with a resolve to be even more "pro-active" in our quest of protection and enhancement of motorcycle rights in California.

We will be pursuing solutions to "stagnated" motorcycle legislation in our state capitol that affects our right to ride and also looking at ways to protect California riders from discriminatory and unlawful profiling tactics. These methods and tactics are used by some business establishments and law enforcement agencies based simply on our outward appearance and our choice of transportation.

Motorcycles are a very fuel efficient, low impact, and a practical alternative to the cars and trucks constantly clogging up the streets and highways of California. If everyone would "ride instead of drive" we could quickly and cost effectively solve the gridlock that so many of our California drivers face on a day to day basis. Our roads would instantly seem virtually empty and with lightweight motorcycles traveling on them, last practically forever.



## What is ABATE?

ABATE is a motorcyclists' rights organization (not a club) dedicated to preserving freedom of choice and freedom of the road, with emphasis on education and safety. Our members are active in programs for public awareness and motorcycle safety, and in supporting many types of charity events.

Included with an ABATE membership are a sew-on patch, membership card, and our monthly newsletter THE BAILING WIRE. There are no special requirements for joining aside from an interest in promoting motorcyclists' rights and safety with payment of the appropriate fees.

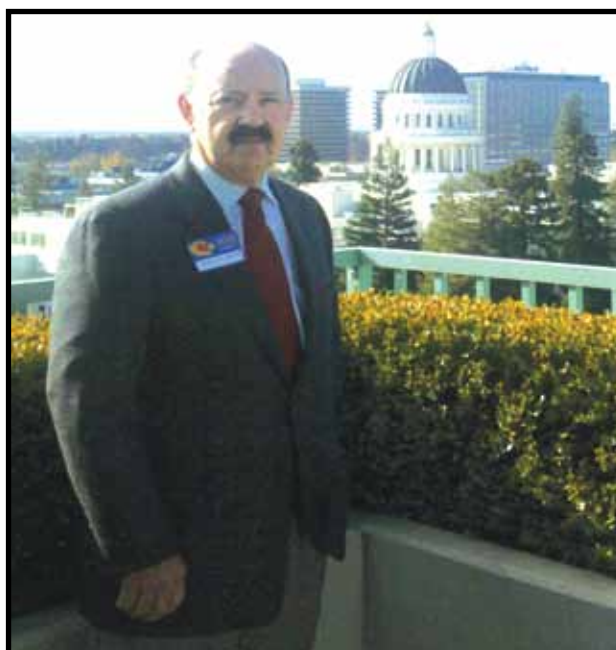

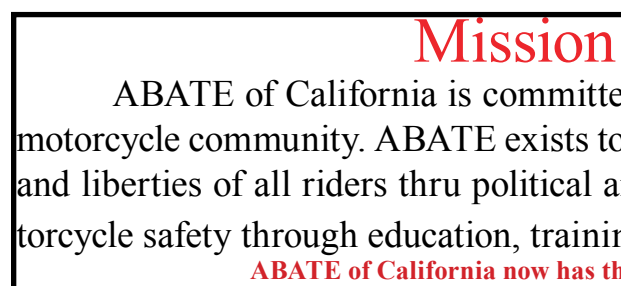
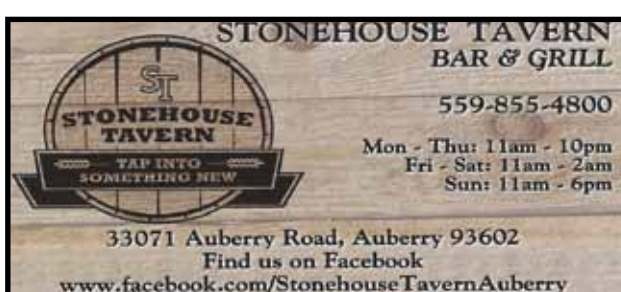

Our Legislature returned on January 4th. The Assembly elected another new Speaker out of Southern California, Anthony Rendon, from Lakewood. He will take over as Speaker on March 1st, and replaces our good friend, Speaker Toni Atkins from San Diego.

Governor Brown submitted a balanced budget with additional funding for a rainy day account should California face another economic downturn. There will be no slashing of social programs which was required two years ago with this proposed budget.



## Lobbyist's Report

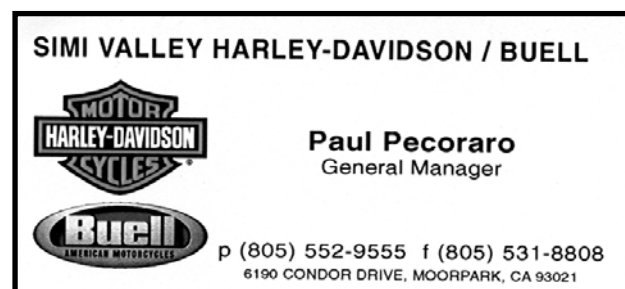
Currently several Democrats have introduced bills to restore, or increase, funding of these programs. Governor Brown has, so far, resisted these attempts, preferring to have a balanced budget. Brown does not want to dip into the substantial \$8 billion reserve fund he has battled to maintain that conflict with many legislators' agendas to spend it on social welfare projects.

Several bills are left over from last session — Assemblyman Bill Quirk's Lane Splitting bill, AB 51, is still in the Senate Transportation Committee and has until June to be acted on. It has until June, because it passed the Assembly, last year.

Assemblyman Cooley's motorcyclist anti-profiling bill, AB 334, did not fare so well — it passed its first Assembly policy committee, but was held on the suspense file in the Assembly Appropriation Committee. Since this fiscal committee did not have a hearing this January, all bills on suspense there, including AB 334, are **DEAD**. A new anti-profiling bill can still be introduced, however, in this session.

Senator Jim Beall's SBX1 1 to increase gas taxes and registration fees to fund highway repairs and transit did not pass. It is still alive because it is a bill introduced in a Special Session called by Governor Brown. The bill needs a 2/3 majority because it increases taxes. Unless the Republicans agree to vote for a tax increase, this bill is also dead this year.

Thanks for the contributions to keep me in the Capital protecting motorcyclists!

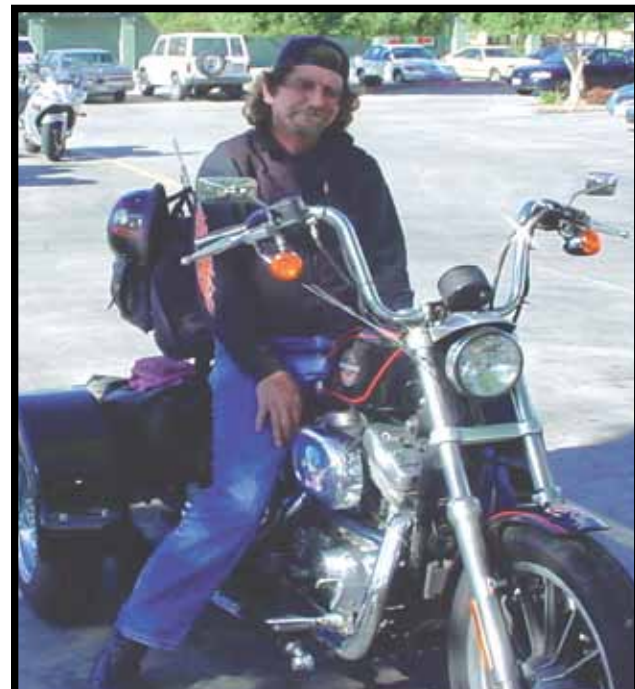

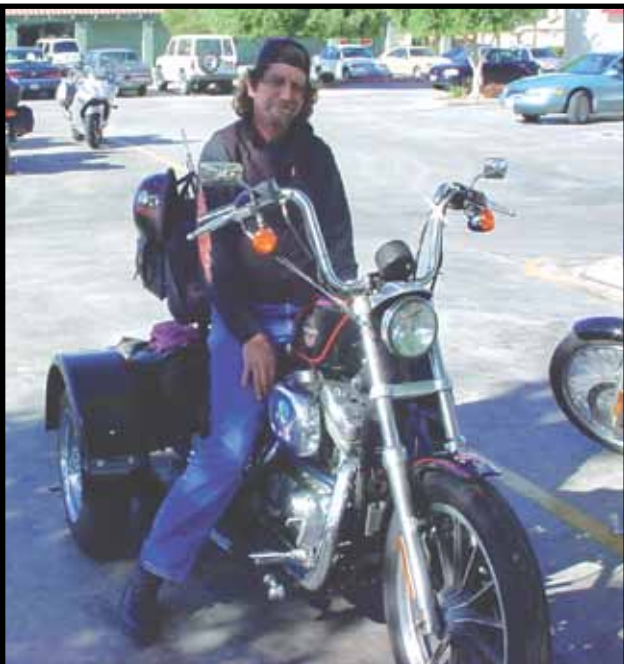

A dismal day for the January Rally at the Capitol in Sacramento. Weather was iffy, it remained mostly dry through the program, but rain started as the riders prepared to depart for their destinations.

Low turn-out must have been a big disappointment for those that put forth the time, effort and expense to arrange it. To be fair, the Easy Rider Show didn't fare much better.

Nothing new was brought to the table in regards to our rights or legislative action. AB 51 & AB 334 were mentioned only briefly as being "stalled" in committees.

Surj Gish (Oakland), of City Bike Magazine & "Share The Road" stickers, and a sport bike rider, spoke on the difficulty of getting more of the sport bike riders to participate in the biker rights activities.

I understand the hesitancy to ride together, as it is "my opinion" we are dealing with two different "species" - metaphor - dogs & cats do not run together in a pack. As for pack rides, cruisers in the curves are an obstacle course for sport bikes.

However, failing to use common daily road courtesy to avoid the anti 2-wheel mentality and not adding to the body count in support against the anti-motorcycle issues we are dealing with is inexcusable - again, "my opinion".

Legislation that adversely effects one, affects all, it is a matter of stand together or fall together - pretty simple.

## PAC & Lobbyist Report

At the January 23, 2016 PAC meeting Chuck Pedersen was confirmed as our 2016 PAC Legislative Director and Nick Benson was assigned, and will handle routine day to day operation of the PAC operations, as our Assistant Director.

A motion was made and approved to immediately implement the ABATE PAC Protocol policy and to update our PAC membership list as approved at the July 25, 2015 PAC meeting.

"In Suspense" or "stagnant" Assembly Bill AB 51 - Lane Sharing - Quirk/Lackey was discussed and a vote was taken to support the bill as written and to have Jim Lombardo, our ABATE Lobbyist meet immediately with the bill's author's to see what we can do to get this bill moving toward passage in this legislative session. Assembly Bill AB-334 - Anti-Profiling - Cooley is effectively "dead" at this time, but the general consensus was we should not give up on the legislation because of its value to EVERY rider in California and seek ways to introduce and pass similar legislation as quickly as possible.

We briefly discussed Assembly Bill AB 8 - Hit and Run Accidents - Gatto, AB 346 - Facial Recognition - Wilk, and Senate Bill SB 491 - Hearing Protection, that all took effect on January 1, 2016 and the possible benefits and ramifications of each for our members.

We then discussed the upcoming June Primary Elections in California and getting out our ABATE questionnaires and our candidate endorsements. In addition we discussed setting up and coordinating volunteers to help our candidates of choice in those elections. Also we reminded our members to register to vote if they have not done so already and then vote for our M/C friends on June 7th.

I want to thank everyone for their contributions to our Lobbyist and PAC Funds. At this time I would also ask you to forgo sending funds to our PAC account and instead please continue to earmark those donations to our Lobbyist Fund.

**NEW YEAR BRINGS NEW LEGISLATION:** Along with the new year comes an onslaught of new legislation, as new legislative sessions across the nation consider a myriad of motorcycle laws such as helmet legislation in ARIZONA that would charge riders a fee to ride without one. Prefiled on January 6, 2016, H.B. 2052 introduced by State Representative Dr. Randall Friese (D-Tucson) would modify their Under-18 helmet law to read; "An operator or passenger of a motorcycle, all-terrain vehicle or motor driven cycle who is at least eighteen years of age is exempt from the helmet requirement if the owner pays a (as yet undetermined) fee when registering their vehicle."

"A person who violates this section is subject to a civil penalty of five hundred dollars," and a 'portion' of the fees collected from the pay-to-play p-pot plot would be "deposited in the Spinal and Head Injuries Trust Fund."

Meanwhile, in INDIANA S.B. 157 would "eliminate the portion of the motorcycle registration fee that is currently distributed to the spinal cord and brain injury fund."

MISSOURI is considering numerous motorcycle-related bills, including seven helmet bills; one would repeal the law for anyone 18 or over (HB1663), another would exempt motorcyclists 21 or older from wearing a helmet if they have appropriate health insurance coverage (HB1464), one "Prohibits law enforcement from stopping a motorcycle for failing to wear protective headgear" (HB1957), while (HB1371) treats the infraction as a secondary offense, requiring another reason to pull a rider over, and four separate bills concern autocycles and primarily exempts certain operators of motorcycles and motortricycles from wearing protective headgear (SB659, SB694, SB851 & SB1732).

Three-wheelers are of concern in several states, as legislatures struggle with defining and regulating "autocycles," and in KANSAS House Bill 2436 would allow persons to take a motorcycle license driving exam on a 3-wheeled motorcycle and would restrict such licenses to trikes.

### SHARE WHAT'S HAPPENING IN YOUR STATE:

"At our annual NCOM Board meeting in November, the Board discussed what information would be beneficial to share with attendees at our annual NCOM Convention in May," says NCOM Board & Legislative Task Force member Annette Torrez, who is also chair of the New Mexico Motorcycle Rights Organization (NMMRO), adding that "We decided on a session on state legislative victories and defeats. We all face similar and different issues in each state during our legislative sessions, and by sharing the outcomes on bills that were sponsored, passed, failed and the details, we can learn from each other. By the sharing of information we may be able to advance many of the same victories or avoid the pitfalls faced."

**NCOM CONFERENCE CONVENES IN UNITY, COOPERATION & RESPECT:** The chill air in Kansas City, Missouri reverberated with the thunder of dozens of motorcycles as riders from a six-state area converged on the Holiday Inn KCI Airport November 21, 2015 for the National Coalition of Motorcyclists (NCOM) Region 2 Conference, which comprises Missouri, Oklahoma, Texas, Kansas, Nebraska and Iowa. This year, the Conference



was hosted by the newly-formed Missouri Confederation of Clubs and Independents, and chaired by NCOM Region 2 Co-Directors "Tiger Mike" Revere, President of Central OK District ABATE and Liaison to the Oklahoma Confederation of Clubs, and Tony Shepherd of ABATE of Missouri.

Following is a conference report submitted by Tiger Mike: "Riders from the Region 2 member states were both excited and thirsty for information on important issues, especially hoping for an update on the horrific Waco, TX event of May, 2015. Bikers were also apprehensive about whether the Waco tragedy might negatively impact attendance. As it turned out, the opposite was true, featuring a standing-room only crowd!"

The Conference convened off with "Tiger Mike" Revere and Tony Shepherd, NCOM Region 2 Directors, welcoming attendees and addressing "Freedom of the Road throughout the Nation", followed by NCOM Executive Coordinator "Sarge" Matthews covering "Discrimination among Ourselves/Outlawing our Existence as We Know It". NCOM Attorney Joey Lester covered Court Case Updates, including judicial victories regarding "No-Colors" Policies at Fairgrounds where Bikers are ejected because of their Patch Insignia.

After lunch, attendees participated in a forum dealing with "The Tragedy of Waco", featuring Joey Lester, TXCOC&I Chairman "Gimme Jimmy", and Louie Nobs and Dwayne Gryder from NCOM Christian Unity. A lot of accurate updates were shared to combat the disinformation advanced by the Media and Law Enforcement, and the program to raise funds to assist Waco Victims and their families was outlined. Go to [www.onabike.com](http://www.onabike.com) and contact NCOM Christian Unity for more information. NCOM Christian Unity Texas will be getting a Special Award for their hard work at this year's NCOM Convention in Atlantic City, and Christian Unity Liaison to the NCOM Board Louie Nobs is receiving the 2016 Ron Roloff Lifetime Achievement Award for his considerable efforts on behalf of Bikers everywhere over a lot of years.

Also featured at the Conference was "Gimme Jimmy" talking about the importance of the U.S. Defenders Program in the light of the Waco shootings; and "Double-D" and "Twitch" from the Washington Confederation of Clubs, who spoke on "Anti-Profiling Laws and How they Affect your State". This was an important topic, since several COCs are very interested in getting this type of legislation passed in their states.

The Conference continued with the Regional Meeting, where Motorcycling Rights representatives spoke of Legislative and Legal Issues in their respective areas; and the Confederation of Clubs Regional Meeting, where COC Officers and representatives in attendance spoke of legal and lifestyle challenges and accomplishments.

The NCOM Regional Conference concluded with the Christian Unity Seminar and Meeting for spiritual riding groups, and following the Spiritual Service and Blessing of the Bikes on Sunday Morning, riders went their separate ways refreshed, informed and resolved to vigorously continue the defense of Biker Liberty into the New Year."

**MORE AIRBAG BIKES COMING:** While automotive airbags first appeared in the 1970s, it took decades for the technology to spread to motorcycles, and now ten years after the introduction of Honda's airbag-equipped Gold Wing comes another airbagger from the Japanese giant.

While the Gold Wing remains the only bike currently on the market equipped with airbag technology, Honda's latest inflatable is revealed in a new patent and demon-

strated with an airbag fitted to the firm's NC750S, which isn't sold in the U.S. marketplace.

The main difference from the Gold Wing bag is the shape and size, with the new design gaining a long, vertical extension above the balloon-shaped main part of the airbag to help counter the fact that most bikes will pitch forward in a frontal collision, throwing the rider upward as well as straight ahead. The idea is that the lower part of the airbag will cushion the rider's chest and stomach, slowing him down before his head impacts the extended upper section.

As on the Gold Wing, the new system is specifically aimed at frontal impacts and is therefore triggered by a sensor in the bottom of the fork. Highsides, lowsides, or any other accident where the impact is not directly from the front will not engage the airbag system.

Although airbags are never likely to be as effective on bikes as they are in the confined space of a car, where drivers can be surrounded by them on all sides; Honda hopes that the combination of modern safety gear, including airbag-equipped leathers and airbags fitted to bikes themselves, will hold some promise of reduced injuries in the future.

### E-MOTORCYCLE TAX CREDIT REINSTATED AND RETROACTIVE:

The E-motorcycle Federal Tax Credit, also known as the 2-wheeled plug-in tax credit for electric motorcycles, was included in the "last minute" tax extenders bill approved by Congress and signed into law by President Obama on December 18, 2015. It covers 10% of the purchase price up to a maximum of \$2,500, with an additional tax credit approved which covers electric motorcycle chargers with a 30% tax credit up to \$1,000.

The credit only applies to street legal motorcycles that can go over 45 mph. The federal tax credits are available in all 50 US states and apply to electric motorcycles and EV chargers purchased in both 2015 (retroactive) and 2016.

**MOTORCYCLE THEFT STATISTICS:** The National Insurance Crime Bureau has released its latest bike theft report, and while much of their annual report is predictable, such as most thefts occur in the summer, some statistics reveal some interesting nuggets of information:

Nationally, the NICB's "2014 United States Theft and Recovery report for 2014 and 2015" is better than in 2013. There were 42,856 motorcycle thefts recorded in 2014 (17,757, or 41% of motorcycles were recovered) which is a 6% decrease from the year prior. Considering motorcycle sales have increased 4% from 2013 (465,783) to 2014 (483,526), this is good news. The number of thefts decreased is a sign of steady decline in motorcycle thefts since 2011, with 8% fewer thefts in 2014 compared to three years prior. The top three states for motorcycle theft last year were California (6,355), Florida (3,981), and Texas (3,274). The state with the fewest thefts was Wyoming, with a total of 23 last year. There are 16 states that saw an increase in the number of motorcycle thefts in 2014 compared to 2013, with DC having the highest increase (54%). There are 35 states that saw a decrease in the number of motorcycle thefts in 2014 compared to 2013, with Wyoming having the highest decrease (-43%).

### WEIRD NEWS: RIDER LEARNS HARD LESSON IN JURISPRUDENCE:

A California man who lost a lawsuit over an erection has had his hopes for justice deflated once again, as a state appeals court in San Francisco affirmed an earlier judgment against him in a 2012 suit he brought against two motorcycling companies.

The plaintiff biker claimed an acute case of priapism, or painfully prolonged erection, due to seat vibrations, and sued both BMW and seat maker Corbin for product liability seeking damages due to negligence and infliction of emotional distress. The biker lost his case but decided to appeal, which turned out to be a big mistake, as the appellate court ruled that he failed to demonstrate any new intelligible argument and failed to comply with the rules of appellate procedure and ordered him to pay the defendants' costs on appeal, a sum likely to be in the tens of thousands of dollars.

## Tech Tips

### Feuling's Cam Plate Upgrade

Last month we talked about the cam chain tensioner shoes and touched on a few of the alternative replacements. Converting your pre-2007 Big Twin (or pre-06 Dyna) spring type tensioners to the later hydraulic style tensioners or the venerable S&S gear drive system is money well spent. This month we'll talk about the Feuling upgrade. For background, Feuling has been an industry leader in the v-twin hi-performance world. Years ago, the 4 valve heads for Evos were unprecedented! If that wasn't enough, take a peek at the W3 engine.



Jim Feuling's contributions to the industry are many, and although he passed away back in 2002, the company is still going strong.

Back to the upgrade! As with all things requiring disassembly and reassembly in the reverse order, follow your factory service manual procedure for cam plate removal. Unless you need to go into the top end for some reason (rocker inspection, leaky gaskets, head work, etc.) skip the step of tearing down the rocker assemblies to remove the stock pushrods. You can bolt cut these and replace with easy install type adjustable rods. Not all adjustable pushrods are the type that can be installed without rocker removal so check with the manufacturer. Common vernacular for these rods are "Easy Install" or "Quick Install." Although there are many to choose from, the most economical are Harley-Davidson/Screamin Eagle. They come in a kit with all the o-rings and the Evo style covers which allow you to access the adjusters. Buying from the other popular sources requires the separate purchase of the covers. Yes, you can use your stock Twin Cam covers but getting the wrenches in there to adjust is an exercise in epic frustration. The Screamin Eagle kit is excellent quality too.

Once your stock cam plate is out, remove the bearing retainer and press out the cams. Replace the inner and outer bearings while you're there. The outer bearings are a must. Once you put a side load on them the integrity is reduced. The inner bearings are an INA bearing and should be replaced with a full complement Torrington bearing. The easy way to do this is purchase one of S&S's bearing kits (cam install kit). This comes with all four bearings, the oil pump and cam plate o-rings, and a cam cover gasket.

Now break out your Feuling OE + Cam Plate/Oil Pump Kit and spend a few minutes admiring the beauty. The billet construction, fit and finish are a sight to behold!



Follow Feuling's instructions for installation, but before moving forward check out a couple of things. Jig up a dial indicator and check out your flywheel run-out.



Most have a few thousandths, but if it's excessive that might explain that annoying vibration that's been bugging you. Sure it begs the question – when riding a paint shaker on two wheels, how do we define an *annoying vibration*? Inspect the lifters and cams. Maybe while we're in there this would be a good time to install those cams you've always wanted.

The kit comes with the cam plate and the high volume/high pressure oil pump needed to run the new tensioners. Other parts to be purchased separately are the outer cam chain/gears, the hydraulic tensioners, and the bearing kit.

# Motorcycle Safety Report

**Let's Go 2016**

I'm kinda still waiting for the "El Nino" season. Yes, we got a little dose, but nothing to brag about, unless you're a weather reporter still guessing and messing for us. I'm not in awe yet but I think California's water issue is lessening, at least down here in the southland we've had a few good rains and cold weather. I almost got sucked into the big storm for months on end, but living in Southern California for over 50 years nothing is predictable with accuracy until it happens, then the news gets into a media frenzy like every year when our streets get wet, go figure!

We did have some really cold days (no problem for me) and probably around 10-14 days of wet weather. I am grateful for them. It's just the hype and inaccuracy making me think, should I ride or not? I love to plan out rides and any kind of adventure, but the news people kind of make you double check what you would like to do.

All I can say is this: if it happens, rain or extreme coldness, it happens. Just prepare yourself properly and don't let the John or Jane Doe's weather guessers spoil your weekend plans or whatever you do! Being prepared is smart, being unprepared is just dumb, no explanations necessary. It's all about the experience and that's a great thing, but the experience is like a two way street, it's either good or bad and there is nothing in between.

I practically grew up riding in the rain because for periods of time my bike was my only mode of transportation (lucky me!) and it was great! You have to respect the rain because once it's here, it's here. And yes I grew up with the poster dogs of riding in the rain with a six pack on your tank and no rain gear. If you wore rain gear, you'd be called a lot of names that I can't publish in this article! It was man up or wear a dress! Besides I didn't want my dad to kick my ass for being a P! Ah, life on two wheels.

Let me remind you of this important fact: Back in the day riding was safer, period! There weren't the pressures of mass traffic and stupid people of all ages. It's a 100 percent difference and then some nowadays. This is what I know, with all the electronic gizmos and vehicles that almost self-drive you. People, while driving, are more dangerous now than ever before. The DMV is enjoying the dollar it generates because they have lowered their standards for people getting a drivers' license - this is not a racial thing! There is a spike in license applications because of lower standards, all they require is the minimum requirements if you want to drive, and the biggest issue for me is the insurance minimum.

I've talked about insurance before and it really sucks for all of us! If you are involved in an accident



and the other person has the lowest of low minimum insurance, you are screwed! If you have the lowest of low minimum insurance as well, then you both are screwed. For this reason only, I've always recommended that you have the maximum insurance for your motorcycle lifestyle. You won't get that big pie in the sky dollar amount from somebody that doesn't have a pot to piss in. It happens every day; people just don't have the REAL financial responsibilities the state of California thinks you do because you have their minimum requirements! I think with all the new drivers on the road these days they should make them have the maximum insurance for a certain period of time, until they prove themselves, around 3 years is good. Put the pressure on the insurance companies and not the taxpayers is what I think!

Back to the rain. Riding in the rain, in my mind, is still safe. I am good with it. It's the other drivers or riders I worry about, and the too many idiots out there that think they are impervious to any dangers while driving in heavy rain. You see them flying down the highway with no regard to anybody's safety let alone theirs. You just have to let them go, their problem is not yours!

I think we all have been caught in the rain or bad weather because it was nice earlier in the day - that's life on two wheels. But if you know it's going to change and you don't mind then prepare yourself because misery loves company and misery sucks big time. I do ride with rain gear because of this and seeing how my dad passed away a while ago, I won't get my ass kicked!

Staying focused is the best way to handle weather changes, and yes, exercising safety should come to mind. Keeping a safe distance and being visible is very important, not panicking or making bad deci-

sions is crucial. We can and do hydroplane as well as our 4 wheel buddies can and our traction is compromised as well. Knowing what gear you're in helps out to, especially if you are down shifting, you don't want to have your rear tire do the temporarily skid because of the high rpm shift. You still need to use both brakes as you slow down or stop, even if you are banking left or right. It's about common sense at that time and also about your confidence in riding during extreme weather conditions.

All I know is if you have any doubts about your riding skills in inclement weather then don't ride. There are many other days of the year, and I won't call you any of the names that were directed at me years ago!

Cold weather is another bite for us riders as well. Sometimes no matter how well you dress yourself, that cold wind finds the smallest opening into your clothing and talk about being irritated, it's downright frustrating sometimes. I know, I used to live where that white stuff falls out of the sky! Layers, layers and more layers is the remedy, only to a certain extent this is true, sometimes getting too hot will make you colder - it's called sweating while it's cold outside, this includes your feet as well. If you're a sweater then you're a sweater, it doesn't matter what time of the year it is.

Your outer clothing is important, wearing the proper outer layer will help keep in warmth and prevent wetness from entering the other layers. The importance of having extra clothing is a good thing, especially socks. If your feet get cold down the road it's probably because your feet sweat and your socks are wet (not soaked) and the best solution is to change them periodically and you'll be happier. I know, I was in the Army and they like to train in cold weather. My proof is I have gotten frostbite on both feet and it's a life time ordeal if you ever had frostbite.

Riding while freezing can make you lethargic and it will slow down your reactions and that's not a good thing if you're in heavy traffic or zipping thru the mountains. If you feel like a statue while riding, you need to pull over and figure out how to get warm. It does depend on where you are; inside a warm building drinking hot coffee is really good, but if you're out in the middle of nowhere then doing calisthenics is a good way to warm up. Booze will not warm you up; you'll just be drunk and cold. Ride prepared for whatever Mother Nature throws at you.

Have a safe winter, especially all those who choose to ride no matter what, don't let any agency tell you any different because riding year round is So Cal life. Ride with safety and stay focused because we have 11 more months of awesome riding down here or for that matter anywhere!

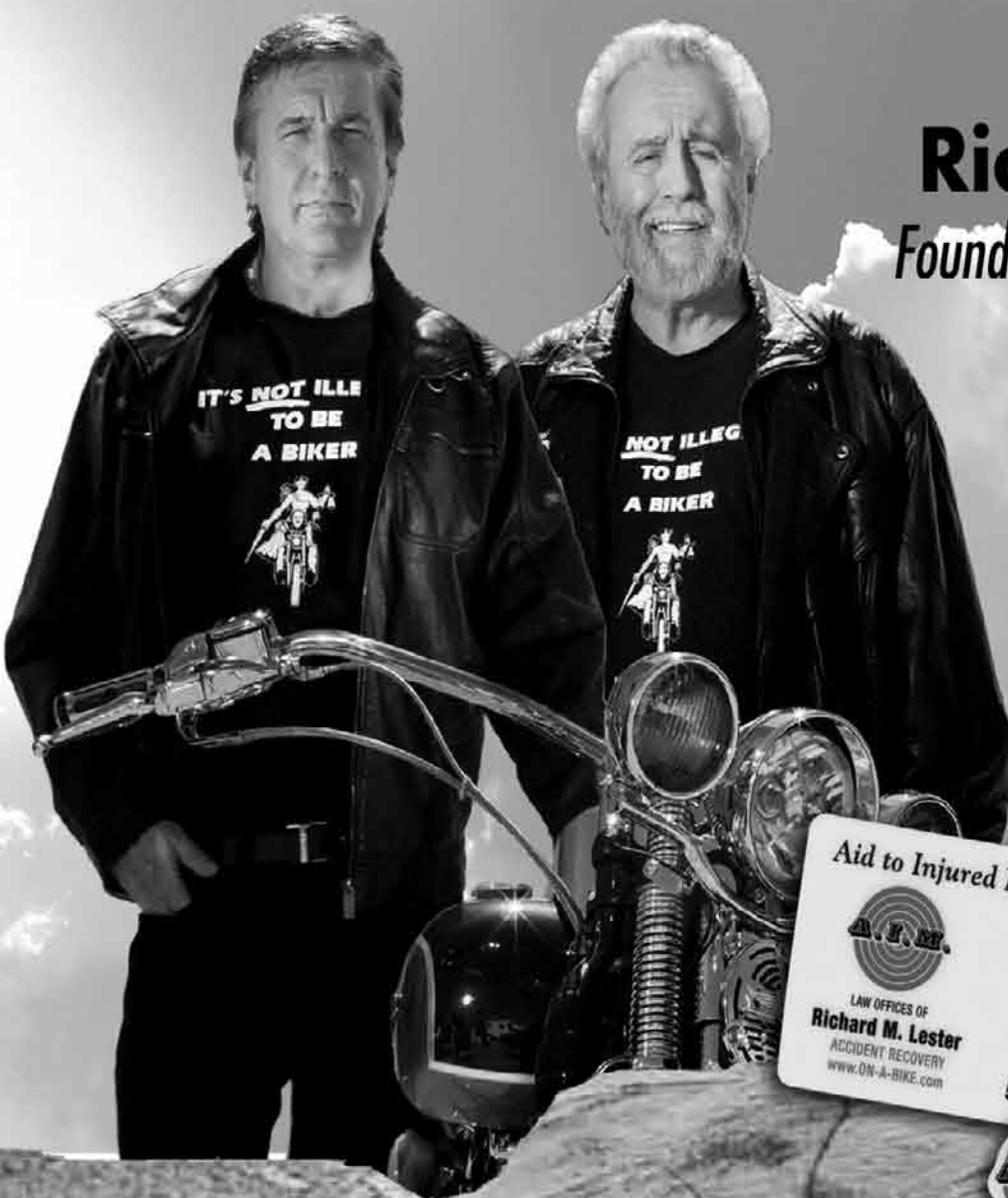
