

Lobbyist's Legislative Report

The Legislature's members will be back in their Districts recessing until August 21st. When they return, Climate Change – Cap & Trade Legislation is the big item the Legislature will be dealing with as the first part of the 2017-2018 session is winding down. Our Bills are moving through the process, as we maneuver through the various committees and both floors of the Assembly and the Senate.

AB 1027, by Assemblyman Dante Acosta (R – Santa Clarita), will allow already experienced, but unlicensed, riders to skip the 2 and 3 day instructional courses in order to instead take a CHP approved one-day/Intermediate course to get the DL 389 DMV test waiver. This allows them to omit taking the dreaded DMV “lollipop” riding test. It has passed the Senate and is now in process to be presented to Governor Brown – hopefully getting his signature.

Our other bill, SB 672 by Senator Jean Fuller (R – Bakersfield) will make permanent the requirement that ALL cities, counties and Caltrans

will have to install sensor devices that detect motorcycles and bicycles in intersections controlled by a traffic light when installing new ones or repairing them. Many motorcycle and bicycle riders have reported fewer intersections not detecting them since ABATE sponsored this pilot program bill 10 years ago.

The Off-Highway community has appreciated ABATE's support opposing SB 249 by Senator Ben Allen (D – Santa Monica) that will place extreme environmentalist roadblocks to the operation of California's OHV Program. The Program funding has been separated into another bill – SB 159, also by Allen, as the extreme environmental lobbying groups against us could not get the 2/3 vote threshold to pass even an already existing fee.

Along the way, Senators Bill Dodd (D – Napa), Senator (Retired Major General) Richard Roth (D – Riverside) and Assemblyman Rudy Salas (D – Bakersfield) Voted No on SB 249. Senators Mike McGuire (D – Healdsburg), Tony Mendoza (D – Artesia), and Assemblyman Todd Gloria (D – San Diego) abstained on SB 249, which is as good as a No Vote. This fight will be going on until the last day of the session, pitting Rural against Urban Democrats.

The California Air Resources Board (CARB) is reviewing the Red and Green sticker OHV Program for smog emissions from these types of vehicles. We have been monitoring all of the hearings and meetings of the stakeholders, which we are part of. At the last meeting in June, the CARB staff said they were also intending to look at OUR ROAD BIKE EMISSIONS AS WELL. So stay tuned, as this will continue until next year with a final decision possibly next February for tighter emission standards for both OHVs and Road Bikes!

MILLENNIALS ARE NEGATIVELY IMPACTING MOTORCYCLING

U.S. motorcycle sales for Harley-Davidson, which represents about half of America's big-bike market, were down 3.9% last year, and investment management firm Alliance Bernstein recently downgraded the Motor Company's rating while citing the millennial generation as a key contributor in the brand's downturn.

"Our data suggests the younger Gen Y population is adopting motorcycling at a far lower rate than prior generations," AB analyst David Beckel told AOL's Business Insider. "Gen Y's are aging into the important 'pre-family' cohort of riders and Boomers are increasingly handing over their keys to the smaller Gen X population."

Millennials have surpassed Baby Boomers in numbers to become the largest generation pool in the United States, and these 18 to 35-year-olds grew up during a recession, which has impacted their spending habits.

"I think we have got a very significant psychological scar from this great recession," according to Morgan Stanley analyst Kimberly Greenberger. "One in every five households at the time were severely negatively impacted by that event. And, if you think about the children in that house and how the length and depth of that recession really impacted people, I think you have an entire generation with permanently changed spending habits."

BIKE-TO-VEHICLE (B2V) TECHNOLOGY TO PREVENT MOTORCYCLE ACCIDENTS

Drivers involved in an accident with a motorcycle often claim they didn't see the bike. Their smaller size, quickness and maneuverability makes motorcycles more difficult to identify in traffic. Autotalks, the world leader in V2X (Vehicle-to-Everything) communication solutions, is launching its bike-to-vehicle (B2V) solution, a technology for the prevention of motorcycle accidents. The solution is based on the B2X (Bike-to-Everything) chipset developed by the Israeli company.

Research conducted by Bosch, a leading global supplier of technology and services, finds that motorcycle-to-car communication could prevent almost one third of motorcycle related accidents, which has encouraged the German company to develop what they call a "digital protective shield" for riders. Digital visibility would warn

the driver of a car about a motorcycle's close presence, even when it's not visible to the human eye.

The goal of the new technology is to prevent accidents from occurring, by providing warning notices on dashboards. The data would be exchanged by vehicle transmitters through public WLAN and ITS-G5. Potential hazards and nearby motorcycles would then show up on satellite navigation, including direction of travel, position, speed, acceleration, and vehicle type.

Advantages of the Autotalks' B2V solution include simple integration, low power consumption, the smallest form factor, highest range of operating temperature and smallest physical size, which results in its resistance to the strong vibration and challenging environmental conditions of motorcycles.

OREGON ENACTS R-O-W LAW TO PROTECT MOTORCYCLISTS

A "Right-of-Way" or R-O-W law has been enacted in Oregon, as House Bill 2598 was signed by Governor Kate Brown on June 20, 2017. The bill also known as the "Milkman Mike Act" or the "Driver Responsibility Bill" will become law on January 1, 2018 and expands the offense of vehicular assault to include contact with motorcycle, motorcycle operator or motorcycle passenger that causes physical injury.

"This means that if a reckless driver injures a motorcycle rider or their passenger, the driver can be charged with vehicular assault and will be a Class A Misdemeanor," reports the Oregon Confederation of Clubs. The punishment can be doing time up to one year in prison and a maximum fine up to a \$6,250.

"This is a great win for Oregon riders!!," states the Oregon COC on their website (www.oregoncoc.org). "Now we have something that has some teeth in it to punish drivers who are determined to be 'reckless'. We have had too many brothers and sisters run down by car drivers getting a ticket for nominal money or no ticket at all. At best they get a slight bump in their insurance rates. And in the case of no ticket, their insurance company never really has a clue they have a high risk client on their hands.

"All it took was a sharp attorney (Oregon A.I.M. Attorney Christopher Slater) to do a very simple thing. He had the great idea to look to see if there is existing legislation. He found legislation that covered bicyclists and pedestrians (ORS 811.060). From there it was easy to add a few words... 'motorcycle rider and passenger.' It was so simple it was brilliant. Much thanks to Christopher and his efforts. Many thanks to BikePac of Oregon and ABATE of Oregon who also worked hard to make this bill a reality.

"And may Milkman Mike rest in peace forever. This legislation is something he worked hard to achieve for many years. He was unable to see it done due to a health issue and we lost him several years ago. Mike was constantly working within the motorcycle rights community. He also worked as the coordinator for the Coalition of Independent Riders (COIR). He spent a great amount of time adding non affiliated and independent riders to his communication roster."

NORTH CAROLINA TO PROVIDE DRIVER INSTRUCTION ON LAW ENFORCEMENT STOPS

Similar to a measure recently adopted in Louisiana to teach new licensees how to interact with police during traffic stops, House Bill 21 "Driver Instruction/Law Enforcement Stops" has been approved unanimously by the North Carolina legislature and signed into law by Governor Roy Cooper on July 12, 2017.

HB 21 provides that "The Division, in consultation with the State Highway Patrol, the North Carolina Sheriff's Association, and the North Carolina Association of Chiefs of Police, shall include in the driver license handbook a descrip-

tion of law enforcement procedures during traffic stops and the actions that a motorist should take during a traffic stop, including appropriate interactions with law enforcement officers."

OHIO 'DEAD RED' LAW AMENDED FOR BICYCLES ONLY

During a lame-duck legislative session ending last December, the Ohio General Assembly passed House Bill 154, commonly referred to as a "Dead Red" law, allowing all vehicles and bicycles to treat a malfunctioning traffic signal as a stop sign and to proceed through a red light after a reasonable time has elapsed, as long as the intersection is clear and you must yield to oncoming traffic with the right of way. Signed by the governor, the new law was to take effect in March, but an amendment was introduced and fast-tracked as an emergency measure to remove all motor vehicles (cars, trucks and motorcycles) from the law, and House Bill 9 amended the red light section to apply to bicycles only.

Under the language of HB 154, if drivers think they have waited long enough at a red light, they can go through it, explained Representative Kyle Koehler (R-Springfield), primary sponsor of the amendment bill HB 9 "To amend section 4511.132 of the Revised Code to specify that the alternative protocol for proceeding into an intersection with malfunctioning traffic lights due to a failure of a vehicle detector applies only to bicycles, and to declare an emergency."

Unlike when a stoplight is out or blinking because of a mechanical failure, there is no way for a driver to know for sure if an otherwise functioning light has been signaled to change, so legislators worried that the law would allow motor vehicle drivers to treat intersections like stop signs. Lawmakers rushed to fix the law, and HB 154 passed both chambers unanimously and was signed into law as an emergency measure by Gov. John Kasich, taking effect right away.

While ABATE of Ohio maintains that all Traffic Control Devices should be in good working order at all times and is working with the Ohio Department of Transportation to report/repair malfunctioning devices (Red Light Hotline (614) 387-0722 or biker.report@dot.state.oh.us), the organization reports that "Legislation granting motorcycles the ability to treat a malfunctioning traffic signal as a stop sign is planned for the future."

Basically, "Dead Red" laws allow a motorcyclist stopped at an intersection who has not been detected by a traffic signal sensor to run the light legally, when done so safely. Currently, 20 states have enacted such laws, varying in specificity from 45 seconds to 3 minutes, or 1-2 cycles of the light, or "when safe": AR, ID, IL, IN, KS, KY, MN, MO, NV, NC, OK, OR, NJ, PA, SC, TN, UT, VA, WA, WY.

NEW JERSEY RECOGNIZES VETERAN RIDERS

On Thursday, June 22, 2017 the New Jersey Senate and the Assembly voted unanimously to pass Senate Bill No. 1750, and Assembly Bill No. 2729, to create a Veteran license plate for motorcycles.

This establishes "U.S. VET" plates for any honorably discharged Veteran. There will be an annual \$10 charge for these plates and all monies collected will be deposited in a fund to be used by the Department of Military and Veterans' Affairs for the support of programs benefiting New Jersey military veterans. "When the Governor signs this legislation, it will end an over eight year campaign by ABATE for these plates," announced Frank C. Maimone of ABATE of the Garden State.

HAWAII GOVERNOR VETOES BILL FOR MOTORCYCLISTS TO USE SHOULDER LANES

Legislation to allow motorcyclists to travel on shoulder lanes in congested traffic passed through the Hawaii legislature but was vetoed by Governor David Ige on July 11.

House Bill 727, introduced by Representative Henry J.C. Aquino (D-Waipahu), passed both the House and Senate with only two 'No' votes, and would "authorize the operator of a motorcycle or motor scooter to proceed cautiously upon the shoulder of the roadway, in the same direction at a reduced rate of speed of no more than ten miles per hour" until the adjacent lane cleared.

The intent of the measure was to alleviate congestion and reduce the risk of injury or loss of life, but in his veto message, Gov. Ige countered that "There is concern that this will compromise road safety. The shoulder lane is designed to accommodate stopped vehicles and emergency vehicles on highways, and bicycles on arterial roadways. While the intent of the bill is to reduce risk or injury or loss of life, there is concern that allowing shoulder lane use to these types of vehicles will instead create more danger for the operators of these vehicles."

VIETNAM TO BAN MOTORCYCLES IN CAPITAL CITY

The city of Hanoi, capital of Vietnam, has over 7.5 million inhabitants, and between them these citizens own more than 5 million motorcycles and half a million cars. In addition to the city progressively developing public transportation and banning certain vehicles from certain locations at certain times to combat congestion and pollution, Hanoi has stated intentions to ban all motorcycles in 2030.

INTERNAL COMBUSTION ENGINE BANS COMING FROM EUROPE, ASIA

A growing list of countries plan to ban conventional vehicles running on gasoline, diesel or other fossil fuels. Several European and Asian countries have already laid out ambitious plans to eliminate fossil fuel-powered vehicles:

- Norway & The Netherlands have designed the most aggressive plans, wanting to switch to electric vehicles by 2025.

- India wants to get all of its vehicles switched to battery power by 2030, not only ending the sale of internal combustion vehicles, but will convert or replace all vehicles on the road.

- France announced plans coinciding with the G20 summit to have 80% of its fleet electrified by 2023.

- Germany is pushing to end sales of gas and diesel cars by 2030.

- China is increasing sales of so-called New Energy Vehicles by putting strict limits on the number of new vehicles that can be registered in major cities, exempting NEV models.

Sales of all battery-based vehicles dipped globally in 2016, and in the U.S. sales of hybrids, plug-ins, and BEVs (Battery Electric Vehicles) collectively accounted for barely 3% of the overall new vehicle market.

WHAT IF 10% OF DRIVERS SWITCHED TO MOTORCYCLES?

In recognition of Ride to Work Day in June, the Motorcycle Industry Association in the U.K. released figures highlighting the benefits for everyone if just 10% of car drivers made the switch to two wheels -- including a 20% increase in parking spaces, a 40% reduction in road congestion and financial savings from less cars on the road.

The figures come from a Belgian study, which modeled traffic for one of Europe's congested roads and found that if 10% of car drivers swapped four wheels for two, congestion for all road users went down by 40%. If 25% of drivers rode, congestion was completely eliminated.

The INRIX Global Traffic Scorecard calculated the cost of congestion to the economy at around £30 billion a year (\$39 billion USD) – a figure that would reduce if more people switched to two wheels. Drivers could gain up to the equivalent of four days (32 hours) annually stuck in traffic.

Tech Tips


Spark Plugs

I used to think spark plugs were the most over changed maintenance part on the bike. My thought on this changed after I chased a misfire issue for several hours. I would pull the plugs and ground them, crank the engine over and observe a nice bright blue spark. After I would re-install them and start the engine, the same cylinder would go cold. Finally after repeating this process several times and ruling out all other issues, the answer revealed itself almost by accident. After removing the plug for the last time, the insulator crumbled in my hand and I noticed the electrode inside the plug was severely corroded. On the outside the plug looked good. Coincidentally, every time I installed the plug the electrode would break continuity and go dead. Every time I pulled the plug and grounded it to the head it would fire, a result of disrupting the rusty electrode pieces inside the plug.



The spark plug is simple in theory: It forces electricity to arc across a gap, just like a bolt of lightning. The voltage must be very high in order to travel across the gap and create a good spark. Voltage at the spark plug can be anywhere from 20,000 to 80,000 volts depending on the vehicle/ignition system.

The spark plug must have an insulated passageway for this high voltage to travel down to the electrode, where it can jump the gap and, from there, be conducted into the engine block and grounded. The plug also has to withstand the extreme heat and pressure inside the cylinder, and must be designed so that deposits from fuel additives do not build up on the plug.

Spark plugs use a ceramic insulator to isolate the high voltage at the electrode, ensuring that the spark occurs at the tip of the electrode and not anywhere else on the plug; this insulator does double-duty by helping to burn off deposits. Ceramic is a fairly poor heat conductor, so the material gets very hot during operation. This heat helps to burn off deposits from the electrode.



A common misconception is how heat range is defined. The “hot” and “cold” in plug vernacular has nothing to do with the spark. Some bikes require a hot plug. This type of plug is designed with a ceramic insert that has a smaller contact area with the metal part of the plug. This reduces the heat transfer from the ceramic, making it run hotter and thus burn away more deposits. Cold plugs are designed with more contact area, so they run cooler.



The bike manufacturer will select the right temperature plug. Bikes with high-performance engines can generate more heat, so in some cases may need colder plugs. If the spark plug gets too hot, it could ignite the fuel before the spark fires (pre-ignition); too cold and its ability to burn off deposits is diminished, which can lead to fouling. It is important to stick with the right type of plug for your bike.

Next month we'll look at reading plugs for diagnostics. Ride safe!



Motorcycle Safety Report

ALL Things Matter

In our lives we have constant change. It happens because it's a positive forward motion something that we endure whether created by man or nature. Some changes are really small and some are way huge - like if Harley Davidson went out of business! Where would I be able to buy anymore black HD t-shirts?

Don't get mad at me for saying this, laws change for the better. I'm sort of brainwashed for saying this but I do see their point and although I don't agree 100%. It's because of the policies we created over the years and they will forever change. If you don't believe me, ask a great, great, great, grandparent, they know.

I do recommend that as a responsible rider and/or driver of the roads these days that you visit the DMV's website and read their handbook. It's free and you also can read about new laws or amended laws. It's a good read, and in my opinion, a must read.

Riding a motorized bike is a skill. You develop your skill levels over the years, trial-by-error is a good thing, as long as it isn't devastating. I've always promoted dirt bike riding from youths to adults. It's a great way to learn all the skills you need on an asphalt road. You don't have to worry about the traffic of cages, and when you have a mishap, damage to you and/or your bike is usually minimal. Dirt bike riding helped me focus on riding and developing skills that are easily transferred to street riding. It's about how to handle your bike no matter what you ride or where you ride. I learned how to power brake, do controlled skids, gas out of a situation, avoid last second objects or different change of conditions. It goes on and on. I'm not saying you have to do this but, for me and many others it was a great education as well as being really fun.

How many of you out there test your brakes while riding? I learned this a long time ago and it really does matter. Practice hard braking from slower speeds and graduate up to speeds that you travel at. It's good to start at slow speeds so you can feel your bike and how it handles. I've also practiced locking my rear brake at low speeds to see and feel how my bike re-acts. I also increased the speed up to the point where I count on hard braking rather than a panicked foot to the metal stomp till myer stopped. Locking your rear brake will not help you stop faster or in a shorter stopping distance, only aggressive hard braking will. I know and understand you get panicked and react when someone pulls out in front of you, but if you get training or practice braking, it will become second nature to you. You can re-act correctly and not get into a situation where you could lose control. Practice braking often. You have nothing to lose, and you can talk about near misses rather than...you know.

Another thing about brakes, ABS will not stop any vehicle faster than a standard braking system (except of course, the Fred Flintstone Braking System!), ABS was designed to make



your brakes not lock up and lose control. After a study in 1996, the NHTSA announced it dropped the federal safety standard requirement for ABS because there was 0% decrease in the overall number of accidents when comparing ABS vehicles with standard braking vehicles.

One more thing: How's your tire pressure? Having low tire pressure could be disastrous if you're braking hard, period!

The natural change of seasons causes us to change our mindset while riding. My favorite seasons to ride are fall and spring. Summer and winter have their moments of good and bad riding because it's either too hot or too cold. Riding in the spring can be more of a hassle because if you are sensitive to allergies, then it could wreck a good day of riding.

I was born with really sensitive nostrils and let me tell you it spreads all the pollens, dust, and whatever is floating in the air into my head. My allergies affect my head space and timing in my brain and my eyes get so watery that it feels like my eyes are broken sprinklers while I'm riding. It impairs my riding and my eyes make me look like a stoner from the 70s. I just tilt my head up and blow dry my eyes, true story. What matters to me is getting relief during my ride, taking a hay fever pill and washing my face helps out a lot. I love riding the back roads of orchards and farms, the pleasant smell of plant life is abundant, but with it comes pollen up the cazoozee!

Riding in summer is life for a lot of us, but when the temperature is above 90, then you have to re-think a lot of things, especially if you are older and take medications. If you have other bodily issues like diabetes, then you really have to pay attention to your body. Stuff happens really fast and being prepared is important. Do you discuss your health concerns with other people you ride with? Do you ask others to watch over you because you're a diabetic with high blood pressure etc.? It was blazing here for a couple of weeks where the temperature were over a 100, and let me tell you, it could be really dangerous for some people, like me. When you are riding with other riders, you should be open to them and let them know of your conditions. In reality, everyone should look after one another, period!

Have you ever ridden on a favorite road and

one day it changed? Construction happens. Sometimes our roads get re-engineered or upgraded because of a new tax funding. This happens more than you think. Accidents, unfortunately, dictate dangerous situations that officials address for our safety as well. It's not big news because re-doing a road is not interesting.

What matters is that you ride with confidence and not thinking everything is Jim Dandy. Washouts happen, debris can be anywhere and then there's animal life. If you know there is some kind of road construction on the road you travel, be prepared to not ride that area thinking nothing changed. More stuff happens than you know.

I love riding the high deserts and those two-lane highways are very dangerous. If you think about it you are approximately 4-6 feet away from the oncoming traveling vehicles. You can feel the wind pressure hit you as you pass each other and an 18-wheeler pushes wind gusts against you. When I ride in these types of conditions I use my lane to change positions in my lane. I give an extra few feet of my lane just in case someone is looking to pass and my speed also changes as well. It really matters to me because I think about how in an instant your life could change. We all know about tailgaters, the faster you go, the faster the person behind you wants to go. If you're in a tight group of vehicles doing let's say 65 mph the person in the lead could cause a chain reaction accident by venturing too close to opposing traffic. You read about this all the time, and if you're on a motorcycle in this group of vehicles, it could be very costly to you.

I love riding the 138 highway and let me tell you there are as many 18-wheelers as cars sometimes. Cars are always passing the trucks in both directions. It gets hairy sometimes because you want to pass that truck as bad as the next persons in both directions! In my opinion, it's safer to ride these roads at night rather than in daylight, but the bugs may change your mind! Seeing headlights at night can help you judge how far away the oncoming traffic is versus the daylight when vehicles disappear when they are in a Whoop De Do a quarter of a mile away. Sometimes when I get to my destination in Apple Valley (family) I'm stressed out because I'm an aggressive rider and fast is my middle name - it used to be nincompoop (true)!

Another thing that really matters is the condition of your bike. Being a responsible rider is one thing, getting there safely is another. I always talk about going through your bike while cleaning or detailing it. Mechanical failures happens all the time and they are very unpredictable. What we don't know is the casualty rate that happens because of these failures. They aren't intended, they just happen. The more you reduce your liabilities, the safer you'll ride. It matters if you return home with great memories rather than "what the heck happened!" Everything matters at the start and end of a road trip, period! Ride with knowledge and understanding. How's your tire pressure?




