The Legislature passed its \$215 billion budget a day BEFORE the June 14<sup>th</sup> deadline. They now return to policy committees to finalize bills sending to them to the Appropriations Committee for voting in August, while working through Budget Trailer Bills in June.

In July the State Legislature recesses for the month to head back to their Districts. As California Assembly members and Senators will be

back in your area all month, stop into their local office and introduce yourself as a member of Motorcyclists Rights Organization, ABATE of California. Let them know The Lombardo Group represents you at the Capitol.

The Senate has now been filled with the final two Senators, welcome Senator Brian Dahle (R – Redding) and Senator Lena Gonzalez (D – Long Beach).

September 13<sup>th</sup> is the last day for the Legislature to be in session so it will be busy summer months of tracking, meetings and negotiations on behalf of Motorcyclists throughout the State.

## Bills at a Glance

### ABATE Supporting:

**AB-47 Daly (D – Anaheim) Driver records:** points: *distracted driving* would make the ticket for holding your phone while driving a moving violation and point on your Driving Record. Jim Lombardo Sr. testified in Committee on behalf of ABATE as we helped secure the 13-0 Vote, it now heads to Appropriations Committee. **Currently Referred to Senate Transportation.** This Bill was amended to not take effect until January 1st, 2021.

**AB 390 Frazier (D - Vacaville)/Grayson (D - Concord) Notice to correct violations: motorcycle exceptions.** Per new Rule approved this Year the Chair of Appropriations decided not to hear this bill, making it into a Two Year Bill. We are working with the Authors Office and Co-sponsors, SEMA (Specialty Equipment Market Associations) and Western Center on Law & Poverty toward a solution hopefully this Year.

### ABATE Opposing


**SB 767 Glazer (D – East Bay).** Off-highway vehicular recreation: Carnegie State Vehicu-

lar Recreation Area: Alameda-Tesla Expansion Area. This bill would authorize the department to dispose of the portion of the Carnegie State Vehicular Recreation Area known as the “Alameda-Tesla Expansion Area” to permanently preserve that land for conservation purposes. **Double Referred to Assembly Water, Parks and Wildlife Committee and Committee on Accountability and Administrative Review.**

## Measure to Designate May as Motorcycle Awareness Month Passes the Senate

May 2019 Sacramento – Senator Brian Jones (R-Santee) introduced Senate Concurrent Resolution (SCR) 52 today, which would designate May 2019 as Motorcycle Awareness Month in California.

Motorcycles account for less than 5 percent of registered vehicles in the United States, and California leads the way in training and safety for motorcyclists.

Jones provided an example of motorcycle riders' community involvement by participating at the "May Ride" event in his district that was attended by thousands of local riders to support our military men and women and raise money for the Armed Services YMCA.

In his speech on the Senate floor, Jones asserted, "As a safe and law-abiding motorcycle rider and enthusiast, I support motorcyclists' rights and safety... I encourage you to keep an eye out for motorcyclists and take extra precautions to keep our riders safe."

SCR 52 passed the Senate 37-0 and now heads to the Assembly.

### NCOM CONVENTION IN ORLANDO

**STRESSES UNITY:** The underlying theme of the 34<sup>th</sup> annual NCOM Convention in Orlando, Florida, May 10<sup>th</sup> -12<sup>th</sup>, was "Unity" and welcomed back many past supporters and saw lots of new faces in the crowded conference rooms of the Doubletree by Hilton - Universal host hotel.

During the General Session, Outsiders MC member David "Double D" Devereaux, founder of the Motorcycle Profiling Project and member of the NCOM Legislative Task Force, spoke convincingly of the need for Unity in attaining our common goals, particularly in regards to state and federal anti-profiling legislation, and NCOM Chairman James "Doc" Reichenbach echoed those sentiments to the assembled representatives of hundreds of clubs, organizations and NCOM Member Groups.

Florida and Mike Friend of Bikers For Christ. NCOM's highest honor, the Ron Roloff Lifetime Achievement Award was bestowed upon "JR" Reed -1%er of Sons of Silence MC and Smitty 1%er of the Outlaws MC.

### SUPPORT FEDERAL ANTI-PROFILING RESOLUTION IN U.S. HOUSE:

All motorcyclists are encouraged to contact their Congressional Representatives to ask for their support of House Resolution 255, a bipartisan anti-profiling measure introduced in the U.S. House of Representatives that is identical to Senate Resolution 154 passed by unanimous consent in the U.S. Senate late last year.

H.Res.255; "Promoting awareness of motorcycle profiling and encouraging collaboration and communication with the motorcycle community and law enforcement officials to prevent instances of profiling," was introduced March 26<sup>th</sup> by Rep. Tim Walberg (R-MI) and currently has 22 co-sponsors.

Both nonbinding resolutions, S.Res.154 & H.Res.255, call for cessation of law enforcement discriminatorily profiling motorcyclists by thwarting "the illegal use of the fact that a person rides a motorcycle or wears motorcycle related apparel as a factor in deciding to stop and question, take enforcement action, arrest, or search a person or vehicle with or without legal basis under the Constitution of the United States," as profiling is defined by each resolution.

Concerned riders can contact their U.S. Rep. by calling the Capital Switchboard at (202) 224-3121 and request that they join their colleagues in cosponsoring H.Res.255 to put an end to law enforcement unfairly targeting motorcycle riders for traffic stops, questioning and citations.

### MOTORCYCLE SAFETY AWARENESS MONTH CONGRESSIONAL RESOLUTION:

On May 1, 2019 U.S. Rep. Michael Burgess (R-TX) submitted House Resolution 338 in the U.S. House of Representatives; "Expressing support for the designation of May 2019 as Motorcycle Safety Awareness Month," which reads:

"Whereas motorcycling is a great American tradition enjoyed by an estimated 27 million people annually, representing almost 9 percent of the population;

Whereas motorcycles are a valuable component of the transportation mix;

Whereas motorcycles are fuel-efficient and decrease congestion while having little impact on our Nation's transportation infrastructure;

Whereas the motorcycling community promotes rider education, licensing, and motorcycle awareness;

Whereas the motorcycling community is committed to decreasing motorcycle crashes through training and education, personal responsibility, and increased public awareness;

Whereas approximately 91 percent of motorcycles are operated on highways in conjunction with other vehicles;

Whereas motorcyclist deaths occur more frequently than fatalities in passenger vehicles;

Whereas motorcycle awareness is beneficial to

all road users and will help decrease motorcycle accidents; and

Whereas the National Highway Traffic Safety Administration promotes Motorcycle Safety Awareness Month to encourage riders to be properly licensed, receive training, and to remind all riders and motorists to always share the road: Now, therefore, be it

Resolved, That the House of Representatives -

(1) supports the designation of Motorcycle Safety Awareness Month;

(2) recognizes the contribution of motorcycles to the transportation mix;

(3) encourages motorcycle awareness by all road users;

(4) recognizes that motorcyclists have a right to the road and that all motorists should safely share the roadways;

(5) encourages rider education and training for safe motorcycle operation; and

(6) supports the goals of Motorcycle Safety Awareness Month."

H.Res. 338 has been referred to the Subcommittee on Highways and Transit of the Transportation and Infrastructure Committee, and currently has 7 cosponsors.

### MOTORCYCLISTS AMONG THOSE BENEFITING FROM PUBLIC LANDS ACCESS:

Recreation industry leaders and off-road vehicle enthusiasts applaud Congress for the passage of the Natural Resources Management Act, S.47, now Public Law No: 116-9 after being signed March 12, 2019 by President Donald Trump, affirming the existence and proper management of millions of acres of public lands and parks, including Off-Highway Vehicle (OHV) areas, for years to come.

The law permanently reauthorizes the Land and Water Conservation Fund (LWCF) and the Every Kid Outdoors Act for seven years. Collectively this legislation will benefit thousands of parks, public lands, and waters as well as providing access to the outdoors to millions of off road motorcycle and ATV riders across the country.

The Land and Water Conservation Fund is America's most important conservation program, responsible for protecting parks, wildlife refuges, and recreation areas at the federal, state, and local levels. Many of the lands that NPT has transferred to the National Park Service were purchased with funding from LWCF, including Rocky Mountain National Park, Washita Battlefield National Historic Site, Glacier National Park, Appalachian National Scenic Trail, Kenesaw Mountain National Battlefield Park, and Zion National Park.

The sweeping Act reflects the bipartisan Senate-House agreement reached near the end of the last Congress to bundle together over 100 individual lands bills, striking a balance between creating new opportunities for natural resource and community development with limited, locally-supported conservation. It will improve public lands management, protect treasured landscapes, and increase public access for recreation while protecting private property rights.

Last year, the government released national data demonstrating the importance of an outdoor recreation economy that accounts for 2.2

percent of the nation's Gross Domestic Product and directly supports 4.5 million jobs.

**MONGOLS FINED \$500,000 & GIVEN PROBATION, BUT RETAIN TRADE-MARKED LOGO:** At a sentencing hearing on Friday, May 17<sup>th</sup> a federal judge in California fined the Mongols Motorcycle Club \$500,000 and put the club on probation for five years following its racketeering and conspiracy convictions, but rebuffed yet another attempt by prosecutors to strip the group of its trademark protected back patch logos, citing constitutional protections against intrusions on free expression and excessive penalties.

Last December, a jury found the Mongol Nation as a whole guilty of RICO charges in a decade-long case in which prosecutors said the group operated an organized criminal enterprise. That jury further decided at the time that the government could seize the Mongols intellectual property, but in February U.S. District Court Judge David O. Carter intervened and refused to approve the asset forfeiture.

Stephen "Bowtie" Stubbs, lead attorney for the Mongols, called the judge's decision to not strip its identifying insignia a victory for all motorcycle clubs, but said that the \$500,000 would be a "major burden" to bear for current members who had nothing to do with any of the alleged behavior of past members, and told NBC News that the club plans to appeal the entire case.

"The Mongols Motorcycle Club is very pleased that Judge Carter shut down another attempt by the government to limit symbolic speech," said Stubbs, of Las Vegas, who is a member of the National Coalition of Motorcyclists Legislative Task Force (NCOM-LTF) and also serves as legal counsel for the Southern Nevada Confederation of Clubs (COC).

Prior to the sentencing hearing, prosecutors tried again, requesting the Mongols be prohibited from preventing others from using their image, which Stubbs said the judge also denied.

**SHOW-ME FREEDOM OF CHOICE:** Missouri is the latest state looking to give motorcyclists the freedom to choose whether or not to wear a helmet while riding, and hopes to soon become the 32nd state behind Michigan in 2012 to allow adult Freedom of Choice. The legislative package, including other transportation provisions, passed the Senate 21-12 on Thursday, May 16<sup>th</sup> and on Friday the House advanced Senate Bill 147 to Governor Mike Parsons (R) on a 94-46 vote.

If signed into law, SB 147 would repeal their decades-old helmet law and allow motorcyclists 18 and older the option to ride without a helmet, provided they carry proper health insurance.

Like Michigan, which shook off the sting of two previous gubernatorial vetoes of their helmet law repeal bills before bouncing back to amend their mandatory helmet law, Missouri's legislature previously passed a helmet law repeal in 2009 which was vetoed by then-Governor Jay Nixon (D), and in 1999 a helmet repeal bill reached the desk of former Gov. Mel Carnahan (D) who vetoed it -- members of Freedom of the Road Riders (FORR-MO) and ABATE for Missouri are hoping this time's the charm!

"SB 147 has passed through both chambers,

and only needs a signature from the governor (who can be reached at (573) 751-3222)," reports [www.forr.net](http://www.forr.net). "Yes, everybody Happy," commented Tony Shepherd of ABATE, a past member of the National Coalition of Motorcyclists (NCOM) board of directors, who has worked diligently towards passage with FORR-MO Legislative Coordinator Joe Widmer.

**CONNECTICUT MAY EXTEND HELMET LAW FROM 18 TO 21 AND UNDER:** Helmet laws vary from one state to the other, with some rules being more flexible than others, and at least until now motorcycle helmets were not mandatory in Connecticut for riders aged 18 and over. Prior to January 1, 1990, Connecticut was one of just four states that had no helmet requirement, but if passed House Bill 6161 would increase the minimum age for compulsory helmet use from Under 18 to Under 21.

HB 6161 passed the House by a vote of 113-13 on May 14<sup>th</sup> and is now heading to the Senate for consideration and vote.

Language instituting a universal helmet law for all riders was stripped from a larger bill, and although they still express opposition to any further attempt to mandate helmet use by adults, the Connecticut Motorcycle Riders Association (CMRA) has already claimed a victory in defeating that measure; but advocates hoping to finally reinstate Connecticut's full motorcycle helmet law after 43 years still hope they can pass legislation next session, despite their setback.



# Motorcycle Safety Report

## June is the Halfway Point

The month of June is a traitor to one's expectations. Not one person on this rock can be 100% sure how to predict the weather accurately, but we have the educated guess and they aren't as educated as you might think. Just going outside you'll know rather quickly or better yet go to that destination and give a live weather report.

For the purest to the part time riders, June is officially the start of summer - June 21<sup>st</sup> to be exact. A lot of riders have their own starting date, but, hey, who's to say who is right or wrong - it's about riding. We have so many options - alone just you and the highway or getting out with your buds.

We have everything from the local scene (wherever you reside), to bike nights and week-end sponsored biking events to state events and nationwide events. We have so many choices your head could spin like a top if you were inclined to do so. This is a season about having fun, about freedom of the road, going out and enjoying life on two wheels. We know about the local hang outs and the ones that require this road trip!

We will ride 50 miles or 200 miles or more. It doesn't matter just get on your bike and ride. The fun is the adventure of the day or week or however long you must go and go you must. I have been doing this since I first started riding - going that is. The good thing about our zone in So Cal is it's almost a year-round thing. There are a few states that allow this and I'm glad to be living in the best one! The good news out here is that we don't have winter lockdown and that's a true blessing. I've lived back east in the frozen tundra zone and that white stuff that falls from the skies will hibernate you and your bike real fast.

The main question you should ask yourself is, "Is my bike ready?" Is it ready to put on some serious mileage without issues? Have you done a thorough safety inspection on your bike? Do you care enough to do so? For me I have my own requirements that I must fulfill constantly year round and especially if I'm going on one road trip after another on most weekends.

As I have stated before in previous articles, when I clean or detail my bike I also have all my

tools out to check all the vibratory nuts and bolts and screws and any piece of chrome that's a part of my bike - thank you V-Twin magic! Because I do this all the time I know what's going to get loose and what's not and I am so familiar with my bike it's like it's a part of me. True story!

Breaking down is such a buzz kill. I know because I've been on both sides of this phenome and stuff happens whether you like it or not, it just does. Breaking down can lead to accidents and sometimes it can put you in a very bad situation - like in the fast lane with fast traffic on a jammed freeway. Can you maneuver to the shoulder safely? People become real jerks when you impede on their speed. Reacting to this situation is critical.

Slow or stopped vehicles of all sorts become targets whether you're on the freeway, a highway or surface streets. Being on a bike is very scary sometimes because people just don't see motorcyclists hobbling to the side of the road that often. With the cell phone problems we've been facing, we've had a major spike in deaths and property damage and a heck of a lot more accidents. Here's the real thing that's bad, and law enforcement knows, many, many drivers don't care about the ticket. It's just an inconvenience to some and not getting caught will only let them do it as long as they aren't caught!

A simple flat tire while riding can put you in a dangerous situation where you have seconds to react and move to the shoulder while you're forced to slow down. The front or rear tire feels like you're riding through thick wobbly mud while you wrestle your bike safely to a very slow speed. The place this happens and the traffic can make it a real challenge just to get to the side of the road. Using good judgment can really make a difference no matter what the traffic condition is. This has happened to me a few times.

While I was riding on the freeway in the fast lane my brand new rear tire got a nail in it while I was doing around 70 mph. I reacted very quickly because my handle bars were doing the dance - the twist - faster than I was traveling. I went into emergency safe mode. My bike was automatically slowing down but I had to safely slow it down faster. I was forced to slow down but the traffic wasn't and I had to get over 3 lanes to get to the shoulder.

The traffic was heavy and merging right wasn't an option because of the speed of the other vehicles and besides everyone one was doing the infamous tailgating so you can't squeeze in front of me thing. I had to make a decision real fast because I was slowing down and the only option was to merge left to the center divider concrete barrier and the space was about 3 feet from the barrier to the fast lane. I knew it was a good choice because people just don't care about you as long as you don't infringe on their speed. If you do, then they can become an instant total jerk. Getting a flat tire really sucks and it sucks the fun right out of you faster than the air in your tire! Luckily for me the CHP was there in a few minutes and they shut down the freeway so I could get my bike to the right shoulder and out of a dangerous situation.

Like I said earlier, breaking down or getting a flat tire happens all the time even if everything is good (don't forget I had a brand-new tire). Being

able to react to these situations with a positive attitude is far more important than the mishap itself. While I waited for the tow truck to pick up my bike, I looked at the traffic and it seemed that everyone was pushing their speed, zig zagging while trying to get in front of one another through the use of multiple lanes. While I was watching the drivers I thought about how unsafe it really is. I was thinking we drivers are constantly jockeying to get to the front of the pack (until someone else is faster than you) and this repeats itself everywhere and all the time, it never ever stops. This is just California and I'm sure it's the same wherever there is a major city with freeways and or highways.

By the way, have you checked your tire pressure? Do yourself a favor and commit to checking it at least once a month. If everything checks out to be good, then it's one less thing you have to worry about. Just a reminder to all - it's a known fact that low tire pressure is responsible for 65% of accidents where they lost control. This statistic is for cars, trucks and whatever vehicle they ride or drive in. That's just too many accidents with nothing but bad news written all over it.

The good news about the tire pressure is that tire manufacturers put the tire pressure info on all of their tires, no matter what they are used for. With that I'll repeat myself from previous articles: Manufactures also say that proper tire pressure leads to proper tire wear and better handling. If you are a real old person you would say you get better gas mileage as well. I go through rear tires a lot - mainly because I love doing burn-outs, fat dark and long. It's an adrenalin thing that carried over from my dirt bike riding days. If you take the time to make sure your tires are as good as they can be, then you'll enjoy your rides and your ice cold one will taste a lot better.

We are all creatures of habit. Checking tire pressure just takes a few minutes of time. It's nothing compared to the benefits of a smooth ride versus horrible handling to possibly being stuck in the middle of nowhere - and it can happen to you! Think about it!

With the many choices of tires available, make sure you have the right ones for your bike. Usually the soft rubber ones don't work well with baggers and they have a shorter life span. The tires that baggers use are different from the ones used by them crazy riders. Do you know what are the best type of tires for your bike?

Having good tires with the proper tire pressure will allow you to have a good time without any worries (that is if it's the only problem you have with your ride). What I've learned over the years is that the less you worry about things the more you can enjoy life whatever you do. It's up to you and your attitude.

Ride safely and represent to the public that riding is a great way of life on two wheels.

### Department of Homeland Security Deems California REAL ID Compliant

**Sacramento** – The U.S. Department of Homeland Security (DHS) notified California on Wednesday that it is in full compliance with the federal REAL ID Act and regulation.

“California has been working toward compliance for a long time, and it is a testament to the hard work of many that this day has arrived,” said Kathleen Webb, acting director of the Department of Motor Vehicles (DMV). “We thank the Department of Homeland Security for its approval as we work to prepare Californians for the new federal identification requirements that begin October 2020.”

Starting October 1, 2020, DHS will require passengers to show a valid passport or other federally approved document, like a REAL ID driver license or identification card, to board flights within the United States and access secure federal facilities and military bases.

To date, the California DMV has issued 4.1 million REAL ID driver licenses and identification cards. After updated guidance from DHS, the DMV is [mailing letters](#) to REAL ID cardholders who submitted one proof of residency when they applied for a federal compliant driver license and identification card. When cardholders receive the letter, they simply need to verify their address, sign and date the document, and send it back in the prepaid envelope provided. This will satisfy the second residency requirement for REAL ID, and no return visit to a DMV office will be necessary.

Californians are now required to submit two different documents when applying for a REAL ID driver license or identification card.

To apply, individuals must visit a DMV office and bring the following documents:

- One Proof of **Identity** – Original or Certified (Ex: Valid passport, birth certificate, etc.)
- One Proof of **Social Security Number**
- Two Proofs of **California Residency** – Paper Copies (Ex: Utility bill, cell phone bill, bank statement)


