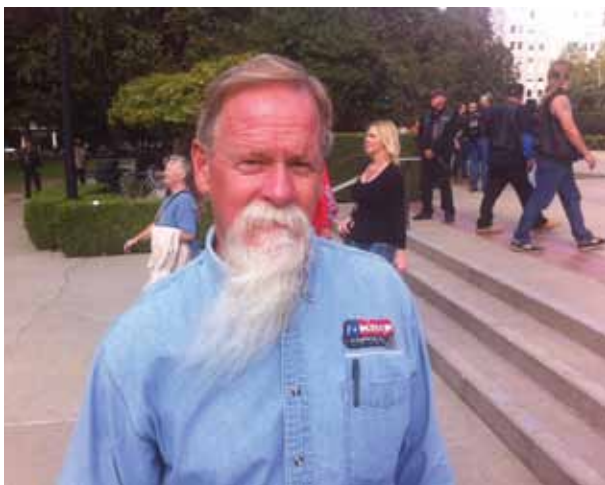

Executive Director's Report

I had the privilege to speak at the October Unification Rally in Sacramento and I would like to repeat some of the things I said while representing our ABATE of California.

First things first, I would like to send out a big ABATE "Thank You" to Assembly Members Beth Gaines, Curt Hagman, Brian Jones, and Dan Logue for picking up the bill for the sound system and related equipment that was required for our Rally.

There were many speakers waiting patiently for their turn at the podium and all of us were asked in advance to limit our time to about three minutes. The time limit would guarantee each speaker could have a chance to address the assembled riders and I really hadn't decided what I would talk about until the morning of the event. My wife and I had arrived in Sacramento Friday afternoon to a steady drizzle that turned into a hard rain during the night and continued on into Saturday morning. After breakfast we returned to our room to wait for the Rally start time and I began writing down a few thoughts. My wife asked me what I was going to talk about and I said "I've been asked too many times "What is ABATE and what's it all about?" and I think maybe it's time for a short history lesson". She just sat there quietly for a moment and then gave me that "Are you sure?" look and left me alone with my thoughts again. So for those of you who couldn't attend I'm going to repeat my history lesson one more time so when some-

one asks you what has ABATE "done for me" you will have a ready answer.

I'm going to cover about thirty three years of ABATE history in three minutes so please bear with me. Before we had motorcycle rights organizations or MROs as we call them now, the club members of California and a few independents were the only ones who saw the writing on the wall and actually did anything to protect our right to ride. Back in the 60's the Federal Department of Transportation was trying to outlaw modified or "chopped" bikes as unsafe for use on our highways. A nationwide effort was put together by the clubs and in 1975, then President Gerald Ford, signed into law a bill that stopped the withholding of funds to states without a mandatory helmet law. This was a huge victory for riders nationwide and led to the establishment of MROs across the country.

Today's ABATE of California was started 33 years ago by "Deacon" Dave Phillips in 1981 and incorporated in 1986. So what have we done in the last 33 years?

- (1) Passed the handle bar height or "ape hanger" bill.
- (2) Defeated a high performance super bike ban for the sport bike riders.
- (3) Opened up the "Diamond Lanes" to motorcycle use.
- (4) Stopped mandatory motorcycle "smog checks".
- (5) Increased the penalty for "Right of Way" accident violations.
- (6) Spearheaded "Share the Road - Look Twice for Motorcycles" on California freeway message boards.
- (7) Banned "motorcycle only" checkpoints in California.
- (8) And the list goes on and on!

In closing, ABATE has 33 years of experience, Lobbying expertise and the connections already in place to write and pass needed California legislation. But unfortunately, we can't keep doing it all by ourselves. The clubs and a few independents were the original freedom fighters of California and we need everyone's support to be successful. The word "I" will never get any person or group an outcome that benefits everyone that rides. "I" may have an idea but it takes "We" to fulfill that dream. Join ABATE now and help us continue to turn those ideas and dreams into reality for the riders of California!

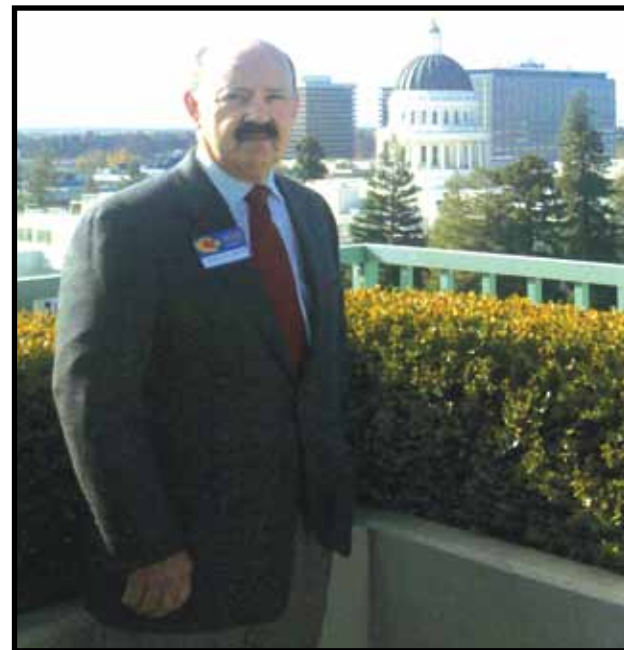
Lobbyist's Report

The Legislature returns December 1st and the Assembly will officially elect Toni Atkins (D - San Diego) as its Speaker and the Senate will select Kevin De Leon (D - LA) as the President Pro Tem. Both of the Democrat-controlled California legislative houses lost their Super Majority 2/3 vote margins in the November elections.

Interesting as to how much was made over both houses having Super Majorities, yet neither exercised them on any controversial votes. The final make up of the Assembly is not complete due to close vote counts in several Assembly races. The Senate has been decided with 26 Democrats and 16 Republicans. The Assembly will probably have 52 Democrats and 28 Republicans after final ballot counts.

This is the first increase for Republican Assembly members in the past two election cycles. The Republicans had lost members in both of the last elections; this time they held seats and look to have captured four, overall. It's a credit to the new Assembly Republican Leader, Kristen Olsen! She was the author of AB 1835, which removed mandatory helmet use for off road Side by Side riders. We were able to pass it off the Assembly Floor only to be forced by the Senate Transportation Committee to allow the helmet choice exception to only those riding on private property, which Governor Brown signed into law. However, that's the first helmet use repeal of any kind in California, since the helmet law madness began, here, in 1987.



At this time, the Committee Chairmanships have not been named for either houses and, obviously, no committee members have been assigned, either. This is important to see how our motorcycle bills will fare in the next two year session.

Thanks again to all of you that worked in the elections. I know Nick Benson was involved in helping elect Marc Steinorth in Assembly District 40 and Ed Rogers with other Local 24 members worked phone banks for Senator Vidak in the Fresno/Bakersfield area - **BOTH CANDIDATES WERE ELECTED! BOTH WERE BIG TARGETS FOR DEFEAT!** Job well done! **IT REALLY HELPS US IN THE CAPITOL!**

Several Congressional seats are still involved in ballot counts and recounts. I will have a complete report at the January 10th ABATE Legislative/PAC meeting in Southern California.

Thanks again for your contributions to the Lobbyist Fund. 'See you at the next Legislative/PAC meeting in January.

Recap of ABATE Board of Directors meeting held on October 26, 2014 in Sacramento.

Remember, this is a "recap" not the "official minutes", but I will do my best to bring you up to speed on what actually transpired at the meeting.

Tom Lubbers called the meeting to order and then announced the prior resignation of Jim Schlachter. Tom praised Jim's contribution and dedication to ABATE of California and said he would be missed by the Board of Directors although he will continue to assist our organization through his Local 17. Sarge Matthews, a long time former Board of Directors member, was then nominated and approved to fulfill the remainder of Jim's term by the Board.

After the Board of Directors member roll call, Greg "Coach" Coppes also announced his resignation because of his ongoing commitment to the upcoming elections. Coach had already informed the Board of Directors of his desire to not seek another term on the Board and we accepted his immediate resignation and decided to leave his seat open until the new Board of Directors members take office at the January meeting. Coach will be missed also and the Board thanked him for his help and hard work for the motorcycling community and we assured him of our commitment to assist him with the anti-profiling legislation he is spearheading at this time.

We had 14 Locals in attendance and 12 absent at the meeting. Board members Gill Mellen and Ed "Iceman" Mathis were absent and excused from this meeting. In addition we had five of our eight Regional Representatives present at the meeting.

Tom asked for a "moment of silence" for departed members Debbie Caballero (Local #17), Brian "Creep" Gabel (Locals #8 & 20) and Jim Jung-

wirth (Local #9).

"Lil" David Morena presented the Treasurer report and I presented the State Director's report and both were accepted. After Ruby Weber presented her MMA Liaison report, the Board of Directors approved a motion to approach the California MROs and Club Confederations to try to set up a meeting to discuss and possibly implement a statewide legislative agenda/"wish list" that would benefit the riders of California.

The Regional Rally Committee provided a financial accounting of their 2014 Mother's Day event and then the Board was informed of an event promoter who would like to either assist with or actually put on the State Run in Kernville in 2015. The Board set up a committee to look into the offer and then report back with their recommendations.

A motion was made and accepted to invite a representative from Russ Brown's office to our January Board of Directors meeting to discuss and answer any questions from the Board regarding an offer they have made to ABATE regarding possible involvement and support of our organization.


Nominations were asked for and accepted for the 2014 Freedom Fighter of the Year award which will be presented at our January Board of Directors meeting.


The last order of business was setting up a Training and Retention committee to prepare new Local Officers for their duties and ensure we have trained and willing replacements for retiring State Office holders when they step down.

The January 10, 2015 Board of Directors meeting will be hosted in southern California by Local 20 in Orange County.

Motorcycle Safety Report

Survivor

It's coming to that time of the year. Hopefully we all had safe and free rides all year long. "Safe" meaning without getting into the stats of riding life, the bad stats that is. "Free" ride is meant to be Freedom of riding, yep it's an ABATE thing!

In all my articles this year I stressed the importance of being educated and well prepared mentally as well as physically. Motorcyclists are still and will always be a minority on the roads of America. In California (January - December 2013), there were over 34 million registered vehicles versus 857,624 motorcycles on all the roads and highways. This statistic does not include visitors from out of state, anyone driving in California that is not registered in our state, and out of state truck drivers. These additional drivers greatly increase that 34 million figure. Let's just say over a million and we will be safe with that number.

I think that the state of California gives motorcycle safety the holiday treatment, a once or twice a year shout-out. My theory is this: Most government or organized events promote themselves for serving free turkey dinners on Thanksgiving and/or Christmas, but forget the other 363 days! One or two days a year promoting motorcycle safety is just a scratch soon to be forgotten. I don't know why California/DMV doesn't fund organizations like ABATE to help to continue to educate the general public on motorcycle safety. After all it's not just about us riders, right?

I have always stated that continuous education is important, whether new or just a repeat! You just can't blame the motorcyclist just because they are more vulnerable. It's in fact the opposite, but we get blamed because of our vulnerabilities! So the ones who dictate laws etc. use limited facts, very limited facts for the benefit of themselves. They think restrictions and control will solve problems, but the facts are simple, very simple if you ask me, public awareness! The California government and DMV have a great opportunity to educate and make ALL drivers/riders aware of motorcyclists. We have a great sign system on all our roadways, whether posted or electronic. We protect deer with deer crossing signs and falling rocks with falling rock signs! Why not share the road with motorcyclist's signs!

It seems to me that because we are a minority they throw us a bone just to get rid of us for a little while. I remember that we rejoiced when we saw the state use the electronic signs for just a little bit - "Share the road with motorcycles" etc. The fact is that it didn't last that long and it was like the holiday treatment I talked about earlier. If these signs were used during rush hour Monday thru Friday maybe people would drive with more caution in



regards to our safety. I'm sick of the "click it or ticket" flash or the "extreme water drought" flash. The lawmakers cry about the high cost of medical bills and the financial hardship motorcycle accidents cause but don't spend money to help educate all the people on the roads, go figure. I would like to see posted safety signs aimed toward motorcyclist's safety on all major highways and freeway systems.

For the year of 2013 there were over 24 million licensed drivers in California, now the state says that it will license approximately 1.4 million undocumented immigrants under the new law, AB60 signed by your Governor! On a side note, we used Nevada's law as a platform for this new law, 90% of them failed the written exam the first time around! I'm just reporting the facts with no prejudice aforethought! Add the thousands of new drivers monthly (mostly teens) and persons that drive illegally on our roads and I think we have a lot more vehicle drivers than what the California government says.

The good news is that the DMV will make millions and the insurance companies will make many millions! The bad news is that there will be a constant rise in accidents, lawsuits and a bunch of scary drivers on the roads! Properly insured drivers are a very good thing, un-insured drivers or the minimally insured drivers are a major issue for me. I suggest you know and understand what kind of insurance you have, especially for your motorcycle. Case in point is this: YOUR insurance company will be as cheap as possible for all claims against you or the other party when you get the cheapest (minimum as per law) form of insurance. And if the other person has the minimum as well, don't think you'll get the big slice of pie in the sky, because you WON'T! I know it's about economics and most of us live month to month, and to have the good insurance doesn't equate in our cost of living, but it should. We have to have uninsured motor-

ists insurance because there are so many drivers on the roads that don't have any insurance, I know that sucks. I guess in the insurance world it's true when they say "you get what you paid for"! So it brings me to this, for you the biker and driver of any such vehicles, you should have the best motorcycle and vehicle insurance possible. I understand the higher medical risks on the motorcycle versus the car, but because of the severity of physical damage you can get, let alone the property damage, the bills could set you so far back you'd be riding a model 5-D from way, way back! Fun Fact: It's a Harley

The important thing here is that you need to know what your insurance on your motorcycle and other vehicles is, what it covers for you and your property and/or the other person's property and themselves as well. Can you upgrade your bike insurance to the max? Find out is there another company that will give you additional insurance for your motorcycle. Bring in your policy and ask questions, don't be afraid or shy about this because after all is said and done, you got what you got! It's their job to inform you what your coverage is and what the payouts are etc.

To have good insurance is smart. You need this protection because the way I see it is and I'm not saying this to put down anybody or judge you on your financial situation, but this is a two way street - people who have nothing, give nothing, people who have, can have what they have taken! There are millions of drivers and riders that have the bare minimum insurance required and a lot of them have nothing to lose, i.e. houses, financial savings etc. What do you have to lose?

Being a survivor is an expensive endeavor, whether accident free or with one or two behind you, you will always pay, for yourself and others and that's the law - isn't freedom fun!

Now just one more thing: How's your tire pressure? As seasons change so does your tire pressure - this is free and done very quickly.

Please stay alert and be visible, especially to the newbies on the roads. Norm e.

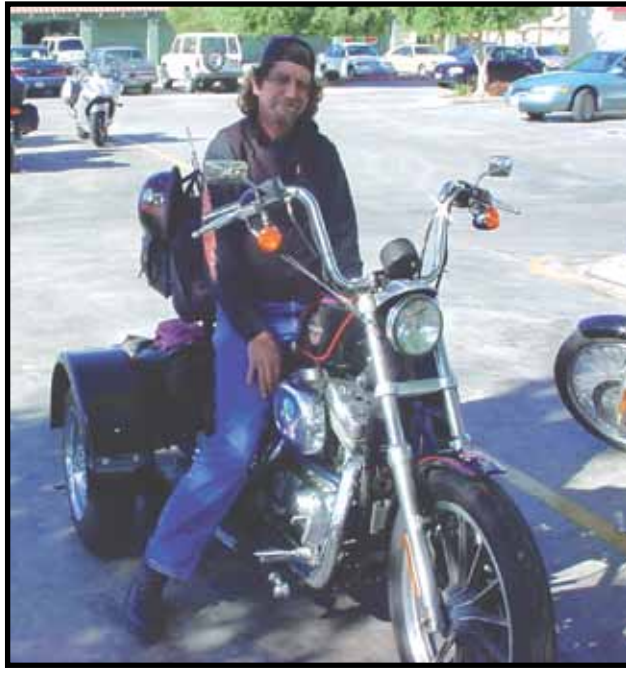

Though Polaris says they'd already received approval from the Lone Star State to sell their Slingshot there, according to a letter to Texas Polaris dealers posted on a Slingshot forum on November 4th they were notified by the Vehicle Titling and Registration Division of the Texas Department of Motor Vehicles that the DMV is taking the position that even if dealers are licensed to sell it as a motorcycle, owners of the Slingshot will not be able to register it because it is not street legal as far as Texas "motorcycles" are concerned.

The conflict hinges on the wording used to define a motorcycle in Texas. The Texas Department of Public Safety Motorcycle Operator's Manual says three-wheelers are defined by certain characteristics, one of them being "saddle seating," meaning "seating in which the rider/passenger straddles the vehicle," but the Slingshot's seats sit side-by-side. Because it doesn't have a "saddle," the DMV ruling prohibits the Polaris Slingshot from being registered as a motorcycle, so they will not be sold in the state until this "VERY urgent matter" is resolved.

The Texas precedence has the potential to sway other states to define the Slingshot similarly, a scenario Polaris is surely hoping to avoid.

Polaris has fought hard for their not-car classification, and have used the fact that their vehicles are legally considered motorcycles to ease their passage through regulatory waters, but this gray area has led to some other unintended legal consequences, such as operator licensing, vehicle registration and applicable helmet requirements. Ultimately, it has everything to do with the way laws are written and how "motorcycle" is defined therein, which varies from state to state.

INDIANA SCOOTER RIDERS FACE NEW REGULATIONS: Indiana officials are warning motor scooter drivers that starting in January they'll need license plates on those bikes. Legislators have approved Indiana's first license requirements for scooters, and under the new law drivers of scooters with engines of 50 cubic centimeters or less will need to buy license plates and pass a Bureau of Motor Vehicles test involving road signals and signs. Operators of scooters with larger engines will be required to follow motorcycle requirements, including holding a valid motorcycle license or learner's permit.

Evansville police officials told a legislative committee that scooters had often been involved in accidents and used in crimes such as robberies, but that the owners couldn't be found because they lacked any registration.

The new law doesn't require insurance for drivers of the smaller scooters, and the registration

bill proposed for the 2015 52nd Legislature for the state of New Mexico would create a system of taxation for riders who opt not to wear a helmet.

Specifically, "The department [Motor Vehicles Division] shall make available distinctive motorcycle validation stickers that signify that any person age eighteen or older who operates a motorcycle on which that sticker is affixed are not required by law to wear a safety helmet. The department shall issue validation sticker when a qualifying person pays the fee as provided for."

A standard validation sticker is just \$15 annually, but it would cost \$692 per year for the "distinctive motorcycle validating sticker" that allows the rider to go lidless...the additional tax revenue to be distributed as follows: \$541.60 to the trauma system fund, \$135.40 to the brain injury services fund, and \$15 as additionally provided by law. Otherwise, the rider and passengers must wear a helmet, even though New Mexico law currently does not require helmet use for those 18 and older.

"My concern is this will turn into a helmet law in New Mexico," said Annette Torrez, chairperson for the New Mexico Motorcycle Rights Organization (NMMRO) and a member of the National Coalition of Motorcyclists (NCOM) board of directors, who reported on the effort at a recent NCOM Regional Meeting in Baltimore, Maryland. "We found out that a lobbyist in New Mexico asked a senator to draft the bill, and though it does not have a sponsor yet, we are currently researching who is behind it."

TEXAS SAYS NO POLARIS SLINGSHOTS: The Polaris Slingshot, a brand new three-wheeled sports-vehicle now just arriving at dealerships across the U.S., lacks componentry necessary to be considered "a car" and in most states you register it as a motorcycle; but the Texas DMV says "Whoa pardner, not so fast."

MOTORCYCLISTS GAIN SOME RELIEF FROM CONGRESSIONAL HELMET LAW EFFORTS:

Driven by discontent, disillusionment and distrust, American voters saw red in November's mid-term elections and whisked control of the United States Senate to the first Republican majority since 2006 and won additional seats in the Republican-led U.S. House of Representatives, as well as favoring the GOP in numerous statewide races and a majority of gubernatorial contests nationwide.

While most of the electorate is simply happy to see an end to a record \$4 billion in campaign ads appearing incessantly on television, radio and newspapers, and in in-boxes and mailboxes everywhere, motorcycle riders should be especially glad to have won at least a temporary respite from helmet law threats from Congress and in states where Republicans have remained or gained in governance.

As recently as this summer, the Obama Administration included a thinly-veiled attempt to impose a national helmet law through the U.S. Department of Transportation's (DOT) surface transportation reauthorization proposal to Congress, but the measure was derailed by the Republican-controlled House. Three years ago, motorcyclists across America successfully opposed a proposed amendment to S.1449, the "Motor Vehicle and Highway Safety Improvement Act of 2011," that would have called for a National Mandatory Helmet Law for all motorcyclists.

Although federal agencies like the National Highway Traffic Safety Administration (NHTSA), the National Transportation Safety Board (NTSB) and Centers for Disease Control (CDC) will undoubtedly continue to advance their pro-helmet law agendas, lacking a Democrat majority in either chamber will likely curb enthusiasm for helmet law mandates from Washington, for now.

PAY-TO-PLAY HELMET LAW PROPOSED IN NEW MEXICO:

In a unique scheme to punish motorcyclists for exercising their right to ride without a helmet, a Discussion Draft of a Senate

will cost \$26.35, plus a \$10 excise tax.

Law sponsor Rep. Dave Wolkins (R-Winona Lake) said not requiring a driver's license for scooter operators was important because he felt it was necessary that those with drunken driving convictions still have a way to get to work.

MINIBIKE MANUFACTURER TO PAY RECORD \$4.3 MILLION FEDERAL FINE:

Baja Inc. of Anderson, South Carolina, has agreed to pay a record \$4.3 million civil penalty to settle a complaint from federal regulators that it delayed reporting safety defects on its go-karts and minibikes, the Consumer Product Safety Commission has reported.

The settlement resolves CPSC charges that the firm knowingly failed to report within 24 hours, as required by federal law, known defects and an unreasonable risk of serious injury involving 11 models of minibikes and go-carts sold nationwide from November 2004 through June 2010.

The defects in Baja's products, which consisted of fuel leaks and unintended acceleration, resulted in the recall in 2010 of 308,000 Baja Motorsports minibikes and go-karts, which is when Baja filed its Full Report with CPSC.

Although the company agreed to pay the fine, it did not admit any wrongdoing and said it was paying to "avoid the cost, distraction, delay and uncertainty" of continued proceedings.

Previously, the highest penalty the safety commission had issued was a \$4 million fine against Graco Children's Products in 2005 for failure to inform CPSC about dangers to children.

NEW ARMY RULES BAN BASKETBALL SHOES AND CLUB COLORS:

U.S. Military installations worldwide require military members and employees to utilize a variety of safety equipment to ride motorcycles on base that is not required by laws outside their boundaries, but some new Army rules in Hawaii sound way off base.

On Nov. 1, Military Police and leaders at all levels began enforcement of U.S. Army-Hawaii Policy Letter 11 on Motorcycle Safety, consisting of four major changes to the pre-existing policy, including changes to required safety equipment and prohibited equipment.

"When operating a motorcycle on USARHAW installations, riders must wear a DOT approved helmet, protective eyewear, abrasion-resistant gloves, long pants (excluding PT pants), long sleeves, and leather/canvass boots or sturdy over-the-ankle shoes," and such regs are typical of most military bases, but their new policy "prohibits riders from wearing high-top basketball shoes while riding."

Additionally, the new policy specifies the use of reflective gear at all times, and riders must wear

either a fluorescent (brightly colored) and reflective vest, jacket or upper outer garment, or they must wear a motorcycle specific jacket with padding/armor.

But what's most concerning is "Prohibited Equipment" that is NOT allowed to be worn: "Riders on-post are not authorized to wear any garment that displays an affiliation with a motorcycle club or other group that offers or solicits membership."

The new policy applies to all motorcycle operators on USARHAW installations. In addition, the policy applies to all 25th Infantry Division Soldiers, both on and off-post.

STUDY SHOWS LANE SPLITTING POSES NO ADDITIONAL DANGERS:

A series of new studies out of the University of California, Berkeley found that the practice of lane splitting poses no additional danger to motorcyclists. California is the only state that allows for the maneuver, which is the act of a motorcyclist passing slow or stalled traffic by riding in between cars along the lane lines.

Two year long studies were recently released by UC Berkeley and were commissioned by the California Highway Patrol and the Office of Traffic Safety, and determined that the seemingly risky move of weaving in-between traffic to be no more dangerous than just riding a motorcycle, when executed in a safe and prudent manner.

The state-commissioned research considered thousands of accident reports and found lane splitting poses no more risk than riding a motorcycle in a marked lane, with the exception when lane splitting (a.k.a.; lane sharing, or filtering) is done at speeds over 10 miles an hour in excess of traffic flow.

One report is a crash study that examined 8,262 motorcyclists who were involved in crashes while lane splitting between June 2012 and August 2013. The second report examined lane-splitting habits among various groups in 2012 and 2013.

Researchers found lane splitters are less likely to be rear-ended (2.7% of crashes vs. 4.6% for average motorcyclists), and lane-splitting motorcyclists involved in crashes were notably less likely than other motorcyclists to suffer head injury (9.1% vs. 16.5%), torso injury (18.6% vs. 27.3%), or fatal injury (1.4% vs. 3.1%).

Lane-splitting in California appears to be on the rise, with 62% of motorcyclists admitting to lane-splitting on both freeways and other roads,

a 7.5-percentage-point increase over 2013.

Data from the studies will be shared with the CHP, which this year began working on guidelines for lane-splitting. Authors say the report, the first of its kind about lane-splitting, will be followed up by more in-depth analysis, including looking at rider age, rider gender, motorcycle characteristics and collision and roadway characteristics.

In many countries, lane splitting and filtering are normal practices for motorcyclists, particularly in highly urbanized areas of Europe and Asia.

LANE FILTERING APPROVED DOWN UNDER:


Following consultation with riders, motorists and road safety groups, the government of Queensland, Australia decided to make changes to the laws regarding motorcycle riding, and beginning early next year motorcyclists will now be able to move around stationary or slow moving vehicles, as long as they are traveling less than 30 kilometers an hour (18.64 mph).

A trial in New South Wales found lane filtering could help ease traffic congestion and Transport Minister Scott Emerson agreed it should be rolled out in Queensland, but it will only be allowed for experienced riders and won't be allowed in school zones during school hours.

Among other "sensible changes," motorcyclists will also now be able to legally stretch their leg off the bike to help avoid fatigue, take both feet off the footsteps to reverse into a parking space and turn their head to do a shoulder check.
