
May is Motorcycle Awareness Month and we will have our "Share the Road" message up on Caltrans freeway billboards for the third consecutive year! A collaborative effort between ABATE's late Safety Officer, John Del Santo, and myself. It took over ten years to finally make this happen, but it finally **DID!** — Enjoy **OUR SAFETY MESSAGES** as you pass them on the freeway while they're up there this month!

Please attend the Leg/PAC meeting at La Quinta Inn in Sacramento, on Sunday, May 5 at 11 a.m. we will discuss Senator Jim Beall's SB 350 and other current legislation that affect motorcyclists, so **PLEASE ATTEND TO MAKE YOUR LOCAL'S POSITION AND VOICE HEARD!** SB 350 will codify lane sharing for motorcycles, which is currently **only** a regulation guideline that can be changed anytime (by unelected bureaucrats **WITHOUT A PUBLIC HEARING**). It now is being held in the Senate Transportation Committee and will not be heard until January 2014.

Due to serious concerns from ABATE and other MROs that **OUR** right to split lanes might be taken from us, Senator Beall has made SB 350 into a two-year bill. **Stay tuned for updates!**

AB 1192 by Assemblywoman Gaines to stop parking garages and parking lots from banning motorcycle use has also been made into a two-year bill.

Two bills for our **NEW** Off Road Division



to watch — Senator Mimi Walters' SB 234 and Assemblyman Tim Donnelly's AB 64 which will grandfather in side by side off-road vehicles manufactured before 2014 with aftermarket seats installed in these UTVs or ROHVs, as they are now called. Both bills have passed out of their first policy Committees and now await their fate in the Appropriation (fiscal) Committee and if they pass, they will be on their way to a full floor vote in May.

I Hope to see you at the Leg/PAC Committee May 5th and the FREEDOM RALLY May 6th on the East Steps of the Capitol at 11 a.m.!

Thanks again to all of you individuals and Locals that send contributions to the Lobbyist Account to keep me in Sacramento fighting for **OUR** Freedom to ride motorcycles!



Pac/Lobbyist Report

I have never been one to set goals because I have always thought they usually end in failure. When one sets a goal it is an "imaginary place" you want to be. The primary reason for failure is most of us never put an accountable mechanism in place to obtain that goal. With no accountability, we often predispose ourselves to accept failure as an option. We fail by simply readjusting our goal to fit our present circumstances and comfort level. Everyone has a "comfort zone" and when we enter that zone we often lose our drive and ambition and arbitrarily accept something less than what we set out to achieve. We begin the process of personal rationalization and find ourselves making excuses for accepting the status quo. Failure to reach our preset goal is then assured by making simple adjustments (usually downward) which coincide with our present "comfort zone" circumstances. When failure is seen as an acceptable option it is an easy path to follow and often becomes the shortest route to a "comfortable" goal.

Set your sights on winning. A winner never envisions, or accepts, anything else. ABATE is, and always will be a proven



winner and we are very proud of our heritage. We have done more for motorcycle rights in California than any other organization and we plan on keeping our winning streak alive. Right now we have several legislative bills moving through Sacramento that will bring immediate and desperately needed reforms to a poorly written piece of legislation that affects our off-road member riders and their families and I expect both our Legislature and our Governor to approve them. ABATE of California and our lobbyist, Jim Lombardo, have done a superb

job of working with the various legislative staffs and council, and enlisted the help and support of CORVA, ASA, and Cal 4 Wheel to make this legislation both possible and ultimately winnable. We will succeed because we have the legislative contacts, knowledge and infrastructure already in place, the drive and ambition to see the process through, and more importantly, a winning attitude.

What is next? You decide. ABATE is a member run organization and our Mission Statement clearly articulates our ABATE goals. You are the "accountable mechanism" in ABATE and you are the only thing that enables and ensures our ABATE success. Your membership and generous donation of your time and hard earned money ensures we are a viable and powerful entity for riders rights in California. If you are not already a member, please join us. If you are a member "Thank You" for making ABATE a winner.

Let us never accept failure as an optional road to travel on any journey we embark on. I've heard some people say "winning isn't everything", but if I'm going to play the game, I definitely want to be "in it to win it"

ABATE supported the establishment and the expansion of the award-winning California Motorcycle Safety Program (CMSP), and holds a permanent seat on the CMSP Advisory Committee.

ABATE assisted in the defeat of a proposed federal ban on sport bikes.

ABATE lobbied aggressively to repeal Section 2140.5 V.C. (Traffic-actuated, signals for bicycles & motorcycles) (AB1581) Approved by Governor Schwarzenegger October 8, 2007, Chapter 337.

AB 1205 – Dan Logue; 2/2009 Bill Introduced to modify the existing Mandatory Helmet Law; ABATE supported, bill failed to get out of Transportation Committee (2/2010).

AB 882 – Jean Fuller; Introduced a bill to post Victim Memorial Signs on Highways; ABATE supported; Bill passed both the Assembly and Senate floors; Governor Schwarzenegger vetoed the bill October 2009.

SB 435 – Pavley – Smog Check Bill for Motorcycles; Introduced in 2009, amended 8 times by ABATE's continuous lobbying efforts; The last amendment finally reduced it to a "noise bill" and it was signed by Governor Arnold Schwarzenegger on September 28, 2010; Chapter 407. Law effective beginning January 2013.

February 2010 – Between ABATE members John Del Santo, Jean Hughes, James Lombardo, Cal Trans, and others (along with years of correspondence); Changeable Message Boards on Freeways throughout

the State of California are now being used to alert drivers to "Share the Road, Look Twice for Motorcyclists" especially during the month of May to correspond with Motorcycle Awareness Month.

AB 1848 – Martin Garrick – Motorcycle Theft tools; ABATE supported this bill to close loopholes; Amends Section 466.65 of the Penal Code. Signed by Governor Schwarzenegger July 19, 2010.

AB 1952 – Niello; Amends VC 12509 and adds 12509.5 relating to motorcycle instruction permits. ABATE supported. Signed by Governor Schwarzenegger September 20, 2010.

AB 695 – Chris Norby – Bill to amend Mandatory Helmet Law introduced 2/2011 4/25/11 bill was granted reconsideration Amended 1/2012; passage failed in Trans Committee 1/9/12 in spite of ABATE's lobbying efforts and enormous rider support.

AB 1890 – Jose' Solorio – Revised mandatory placement location of transponders on motorcycles using toll roads and highways. Bill signed by Governor Jerry Brown July 10, 2012. Amends Section 23302 V.C.

AB 1047 – Kevin Jeffries – Forbids "motorcycle only" checkpoints – ABATE supported; Bill signed by Governor Jerry Brown July 13, 2012. Amends Section 2814.1 V.C.

AB 1535 – Linda Halderman – Installation of "Motorcycle OK" signs in HOV lanes. Introduced January 24, 2012. (Bill is being held under submission).

FEDERAL BILL INTENDS TO STOP MOTORCYCLE CHECKPOINTS: On April 15, Congressman Jim Sensenbrenner (R-WI) circulated a "Dear Colleague" letter to fellow members of Congress to garner sponsors for legislation he intends to introduce on May 6, 2013 "To stop motorcycle checkpoint funding."

"In the 112th Congress, I introduced H.R. 904, a bill to prohibit the Department of Transportation (DOT) from providing funds to state and local authorities for the purpose of creating motorcycle only checkpoints," wrote Rep. Sensenbrenner to his peers. "Section 1 of the Stop Motorcycle Checkpoint Funding Act contains the same language as H.R. 904. However, this bill also contains language to force the DOT to focus motorcycle safety efforts on crash prevention programs, not national helmet mandates."

Under GRANT RESTRICTION, Section 2 reads; "The Secretary of Transportation may not provide a grant or any funds to a State, county, town, or township, Indian tribe, municipal or other local government to be used for any program to check helmet usage or create checkpoints for an operator of motorcycle or passenger on a motorcycle."

In addition, the new legislation amends Section 153 of Title 23 USC by removing "motorcycle helmets" from the title. "This change will prohibit the DOT from providing grants to a State to enforce helmet laws," according to Sensenbrenner. "This will stop the DOT from manipulating State policies with federal money."

CONGRESSIONAL COMMITTEE APPROVES E15 PROHIBITION: The U.S. House Committee on Science, Space and Technology approved H.R. 875 by a vote of 18-17 on April 11, which would revoke the Environmental Protection Agency's approval of E15 alcohol-laden gasoline for sale to the public.

U.S. Representative Jim Sensenbrenner (R-WI) introduced H.R. 875 on February 28, which would require the federal EPA to stop the use of gasoline containing 15% ethanol (E15) until its harmful effects are investigated further.



NHTSA SEEKS TO SUBVERT PUBLIC SCRUTINY: The US Department of Transportation is looking to fast track adoption of rules, bypassing the public comment process and adopting rules directly. The National Highway Traffic Safety Administration (NHTSA) has proposed to give itself "direct final rulemaking" authority which would allow the agency to declare a regulatory proposal, which carries the force of law, to be non-controversial and rush it into effect.

"NHTSA believes this procedural option would expedite the issuance of, and thereby save time and agency resources on, rules that are not controversial," the agency's proposed rule states.

NHTSA is responsible for a number of major rules, including the corporate average fuel economy (CAFE) mandates that direct automobile manufacturers to meet certain mileage requirements. It also plays a major role in the design of vehicles by mandating various "safety" features such as rear-view cameras, "trunk entrapment" rules to foil kidnappers, and "quiet car" rules to require electric vehicles to make noise to alert blind pedestrians – Such rules cost the automobile industry billions of dollars in compliance costs, but could arguably be "noncontroversial."

Under procedures that allow a measure to take effect within sixty days of its publication in the Federal Register as a final rule,

the public would have just thirty days to file an adverse comment to slow the process down, otherwise the final rule would automatically become effective.

NEVADA CONSIDERS LANE-SPLITTING, FASTER SPEED LIMITS: The Silver State may soon adopt the Golden State's rule on lane sharing, as AB 236 has passed Assembly Committee on Transportation with only two committee members opposing the measure to allow motorcyclists to filter between lanes of slow-moving traffic. California is currently the only U.S. state that allows the practice, though "lane filtering" is commonplace throughout many other parts of the world.

Committee Chair and bill co-sponsor Richard Carrillo (D-Clark Co), a long-time rider, laid out one of the best reasons to split lanes -- avoiding a rear end collision -- saying "at the end of the day, I want to know that I'm going to come home and not be a part of the pavement or the back of somebody's truck or car. To me, this really resonates."

Next step – the bill goes before the full Assembly and the Senate.

In the meantime, the Nevada State Legislature may raise the maximum speed limit from 75 mph to 85 mph has passed the State Senate 15-6 on April 3 and the measure now goes over to the State Assembly for consideration. Introduced by Senator Don Gustavson (R-Sparks), a longtime advocate of bikers' rights who was awarded the NCOM Silver Spoke Award for Government, SB 191 would fast track NDOT to up the speed limit to 85 mph some open stretches of freeways, matching some 85mph speed limits posted in Texas.

MOTORCYCLE LICENSE NOT REQUIRED IN ALABAMA, UNLESS BILL PASSES: Every state but one requires a motorcycle license or endorsement to operate a motorcycle, but in Alabama anyone 16 and older with a regular driver's license can also drive a motorcycle in the state.

An oversight in the 1990s led to the gap in the law and now DPS is supporting legislation to fix the mistake. The state Senate in February passed a bill to require motor-

cycle drivers to have a Class M endorsement on their license. The bill is pending in the House of Representatives.

Under current law, drivers can ask to take the knowledge test to get the Class M endorsement on their license, but the law does not require the endorsement to operate a motorcycle. Those who don't have the Class M endorsement are only legal driving a motorcycle as long as they are riding in Alabama.

Rep. Allen Farley (R-McCalla), House sponsor of the bill, said he would also eventually like to see a skills test. Forty states require a skills test for a motorcycle license, according to the National Conference of State Legislatures.

ABATE RECOGNIZED BY ARKANSAS LAWMAKERS: ABATE members from around the state gathered in Little Rock at the Arkansas House of Representatives on April 4, 2013 for the reading and vote on HR1040, which reads in part: "The House of Representatives commends ABATE, the Arkansas Bikers Aiming Towards Education organization, for raising awareness of motorcycle safety issues; for promoting goodwill and mutual understanding among motorcyclists, law enforcement personnel, and the general public; for being an information resource for its members; and for working to benefit the less fortunate through various events."

OREGON PROPOSAL WOULD MAKE IT A CRIME TO BE LINKED TO A "GANG": In an attempt to crack down on violent criminal activity, Oregon lawmakers are considering a bill that would make it a crime just being linked to what it defines as a "gang".

The big question is how would authorities decide who's a gang member and who's not, and the bill says any group of three or more people whose main purpose is criminal activity, has a commonly known name or symbol and regularly engages in criminal acts would be considered a "criminal street gang."

Police currently track gang members, but there's no law against belonging to any particular organization even if that group is repeatedly tied to criminal activity, but House Bill 2679 and its companion, House Bill 2851, would give authorities another tool for cracking down on gang members because under the proposed law, just being a member would be a felony and subject to stiffer sentences.

The Oregon American Civil Liberties Union told lawmakers it is concerned that the definition of a "criminal street gang" is too vague. "The breadth of the bill and the confusion that will result from its definitions, or lack thereof, risks violating a defendant's due process rights because that defendant is not on notice of what activity is criminal," said the ACLU, adding that current laws are strong enough and urged lawmakers to not advance the bills.

MOTORCYCLE CLUB PUBLICATIONS BARRED BEHIND BARS: Last month we reported that the NCOM Brothers Behind Bars monthly newsletter was being banned from prisons in Australia, but now word comes from one of our own New England states that biker-related printed materials are being systematically rejected.

Referring to a note received from a Connecticut inmate, The Aging Rebel quoted on his website www.agingrebel.com; "Here at our prison, last year they began to bar books about or by motorcycle club members. This includes the book "The Aging Rebel: Dispatches From The Motorcycle Outlaw Frontier" by Donald Charles Davis. These books are purely being banned because their subject matter includes motorcycle clubs. They use the 'catch-all' 'promotes criminal activity' while still allowing books on the Mafia, murder, kidnapping and corruption of government officials, all of which apparently promote NO criminal activity."

Some people may be surprised to learn that among the other rights prisoners forfeit is the right to read what they want, but as TAR expresses; "The high court began to back track in 1987, in a decision called Turner v. Salley. After that case, the First Amendment right to read could be 'reasonably regulated' if prison officials asserted a 'legitimate neutral interest' and the Supreme Court ruling established something called the "Turner Test."

In a letter from the Connecticut Dept of Correction, the Media Review Board determined that "The aforementioned publication was originally rejected in its entirety on November 9, 2012 under Section 6. It encourages or instructs in the commission of criminal activity. This publication was thoroughly reviewed and is determined to have met the criteria for rejection. The publication will not be allowed inside a correctional facility."



Motorcycle Safety Report

by Steve Guderian, Safety Officer

Can You Help a Fellow (Rider) Out?

"In order to make the right decisions, motorcycle riders need the right information"

OK, I am going to step out of my normal routine here to go over something that I think is an important observation. That is, what I am about to discuss is based on experience and observation not facts or research, which is what I normally do. Before I go on I am going to tell you what I have seen and you can see if it matches your observations and experience: Generally, riders who are actively involved in a group or a club tend to crash less than solo riders.

This observation first caught my attention about two years ago. The HOG group I rode with has a lot of rides, and a lot of riders who put a lot of miles on motorcycles. As a group we were riding over half-million miles a year without any significant or major crashes. A few months ago I was talking with some people and realized that motorcycle cops and clubs have 3 things in common: 1) They ride aggressively. 2) They have low overall crash rates. 3) They have a mentoring program.

So my theory right now is riders who are involved with other riders or groups where they share a strong safety background or strong safety messages tend to be better overall riders. These riders are better in the sense that they tend to crash less. The theory also goes on that this is experience independent. That is, a lone rider may have dozens of years of experience. But, if he doesn't have another rider to sit down and talk with he could have a higher potential to crash than a newer rider who does ride with somebody whom he can ask question of or share problems with. And, having another rider who can help with problems or questions is most important when the new rider is gaining experience. This is how strong riding habits are set in the beginning.

Here is another thought that goes along with this, if we can help new riders through mentoring or just being there for them whenever they need it, maybe we can develop better riders and reduce motorcycle



crashes. Rider safety is not about the parking lot training they take in order to get their license; it is about the safe roadway experience and habits they develop after they get a license. It is after the new rider leaves that parking lot training when the learning and the need for help is really necessary.

Wouldn't it be great if something so simple as being there for a new rider to help them gain safe riding experience could actually save rider lives? Wouldn't it be even better if the riding community itself did this so that we could actually open the eyes of the feds and show them that their grand plan for the last 20 years is not doing so well?

I have to tell you, there is a kicker in this new riding mentoring theory; right now we don't have any idea on what a mentoring program should look like and how it should be done. Motorcycle people are working on it, but getting them together is like herding cats. So, it looks like having the guidelines for a program are not in the near future. But just because there is nothing formalized doesn't mean we can't try to help new riders out now. If you do have an opportunity to help out a new rider, here are some things to keep in the back of your mind;

Mentoring is not teaching, it is guiding and helping. You don't teach a new rider about things, you help them learn about things from their growing riding experiences. You watch them and help when they need it. Of course it is important that you point out why something might not be safe or the best thing to do and provide a better option.

Encourage questions, ask questions to start a conversation and then listen to what this new rider is saying. You don't have to know the answer to every question that might be asked. It is OK to say, I need to

ask somebody else about that and get back to you. This lets new riders know that nobody can know everything and everybody can use a little bit of extra help, no matter how long they have been riding.

And this is absolutely the most important thing to remember, when riding with a new rider they don't have the same skill level as you, or the same level of confidence about riding. You have to ride at their level, whatever it may be, and then help them build the experience and confidence so that they can increase their skill level.

This last item is even more important when riding with a spouse, loved one or significant other who is new to riding. It is so much fun to have the person whom you really want to love what you love to do. I do know about this. But, as the experienced rider it is your responsibility to know what their riding limits are and to make sure that you ride within them. I have reviewed a few crash cases where the more experienced rider was leading and was not paying attention to how well the new rider was doing. The experienced rider ended up creating a situation where the new rider tried to keep up but ended up overriding their skills and crashing. These are generally very serious crashes due to the limited skill set of the lesser experienced rider.

Here is something that you can try when riding with a person whom you really want to help gain safe riding experience; let them lead. If you are going to ride in a staggered formation, let them lead and then make sure that you are not pushing them. Let them see what is out there in front of them. Letting them lead also does something that is so very important for new riders, it gives them the opportunity to get their head up and scan ahead to see what is out there on the roadway and in the environment in front of them. If the newer rider is following then chances are they are watching the rear tire of the lead rider rather than scanning ahead. And, when break time comes, talk to the new rider. Ask them how they felt, ask them if there were any scary situations. Remember, you're there to guide them; but you may just have to push them a little so they can be guided.

I am going to mention one other thing that for my wife and I, as well as some other couples who have used it, has proven to be a very useful and effective tool for gaining riding experience; don't ride in a staggered position, ride side by side whenever the roadway is wide enough, and the conditions are safe to allow it. My wife fought me on this because she believed it was so unsafe. I asked her how she knew this, where is the data that says this? Since she couldn't answer the questions, I got in trouble. But, again, cops and clubs have been riding side by side without any issues way longer than we have been riding staggered. Finally she said she would do this for me just so she could show me that it would not work out. Now we ride side by side all of the time, except in the twisties, narrow roads or any time conditions make one of us uncomfortable. Any time one person feels uncomfortable in any situation, they can always move back. Communication is simple when you are next to each other.

As for my wife, she said that riding side by side with me made her pay more attention to the roadway and what she was doing. She also said that since we all pretty much ride in a wheel track anyway there was more room between us than she thought there would be. I will also say now that I believe riding side by side in small groups is safer than riding staggered. I have

no data or research to prove this. But I am also not aware of any data or research that says staggered riding is safer than side by side. As I said, I have no data or research that compares side by side to staggered riding. But I do have some unrelated areas that suggest side by side is safer. There are also situations where riding side by side is better than riding staggered. In the urban riding environment, I cannot think of a situation that would be safer riding in a staggered position than it would be riding in a side by side position.

For those of you right now saying that intersection and left turn collision are the number one kind of collision for motorcycles and riding staggered would only cause one rider to get hit rather than two. I will tell you this; you are very wrong on intersection collision being the number one crash situation now days. The data shows it is down to about number 4. And, the odds are far greater than you think that two bikes will be involved in a collision situation when riding staggered. I will go one further, I would argue that riding side by side gives you a better chance of being seen in the first place so that you don't experience that left turn in front of you to start with. My argument for this would be a fact and roadway human factors based argument.

So there you go, my first ever non-data supported safety message for you to think about. With more and more people want-

ing to learn to ride, there will be more and more new riders out there needing help. If you can, help them and think about what I have just talked about. Additionally, there will also be more and more couples out there riding together where one will have more riding experience than the other. For these riders and safety's sake it is so very important that they work together as a team. It is important for all riders to be comfortable when they are riding. So if anything I have talked about doesn't seem right. Then by all means don't do it. On the other hand, if you think you can safely try something that I have talked about, see how it works for you, and the new rider you are guiding.


By Craig Griswold Brakes (Part II)

Last month we covered some history on the evolution of HD's brakes, including the change from drum to disc as well as mechanical linkage to hydraulic operation. We also explained the differences in brake fluids. On the business end of all this is the brake pads.

There's a physics lesson in here somewhere; something about converting kinetic energy into heat energy via friction. That's nice. So how does that help us select a set of brake pads? No need to dive that far into the weeds! Most manufacturers/suppliers have a nice, clear explanation of brake pad type for a given application.

Many moons ago there was an asbestos laced compound that was used for drum shoes. It worked ok, but the ensuing health hazards associated with the dust motivated science and engineering to find a better way. These days, for most applications, there are several different materials to choose from. So here's the scoop.....

SINTERED: This is the material most stock applications utilize. Sintered pads are a metallic compound that provide excellent braking performance. Compared to other materials, sintered pads have a more "aggressive" feel; that being less pressure applied to the lever or pedal for an equal amount of performance. They do well in the longevity department as well. The



drawback, albeit minor, is that they are a bit tougher on rotors and will wear them out a little faster. They are not a good selection for polished or chrome rotors. Sintered pads are the modern version of what most folks recognize as "semi-metallic." A little improvement in materials and manufacturing, and sintered is in!



ORGANIC: Providing a softer feel, organic pads will wear a bit faster, but are much easier on rotors. This would be a good selection for chrome "show" rotors and for those who don't mind sacrificing the aggressive braking characteristic of sintered pads for rotor longevity. While glass and rubber are the basic elements of early organic brake pads, Kevlar is the material of choice in today's organic brake pads. Another term you may hear, which is vernacular for all of the above is Non-Asbestos-Organic or NOA.



EXPENSIVE OTHER: OK, we're riding street bikes so let's keep this in prospective. There are a few other materials out there. Ceramic comes to mind. This is an over the top, high performance material that is perfect for extreme racing applications. Low heat, excellent braking performance, incomparable longevity, easy on the rotors.... yada...yada...yada. The cost to benefit ratio lends itself to some real consideration. Since most of us are not riding our FLHT-CUI.ABCDEFG....in the international F-1 circuit, my recommendation would be to stick with the sintered or organic types. There's just no reason to get silly.

In conclusion, if you like that stop on a dime feel when you grab a handful of brake, go with sintered. If you are into a softer feel or maybe are running bling rotors on that blinding show bike, stick with organic. If in doubt, call a reputable shop or one of the leading manufacturers and grab a few opinions. Modern brake pads are well made and won't disappoint.

Ride safe!


