## Bills At A Glance

Presented by The Lombardo Group, ABATE Lobbyist

AB 43 FRIEDMAN (D – GLENDALE, CHAIR OF ASSEMBLY TRANSPORTATION). TRAFFIC SAFETY: This bill would require, beginning June 1, 2022, and every 6 months thereafter, Caltrans to convene a committee of external design experts to advise on revisions to the Highway Design Manual. This bill would extend the period of time a prima facie speed limit may be justified by an engineering and traffic survey, as specified, if a registered engineer evaluates the section of the highway and finds that there has been an increase in traffic-related crashes. (TRACKING/MEETINGS WITH STAKEHOLDERS)

AB 122 BOERNER HORVATH (D – OCEANSIDE) VEHICLES: REQUIRED STOPS: BICYCLES: This bill would require a person riding a bicycle, when approaching a stop sign at the entrance of an intersection, to yield the right-of-way to any vehicles that have stopped at the entrance of the intersection, have entered the intersection, or that are approaching on the intersecting highway close enough to constitute an immediate hazard, and shall continue to yield the right-of-way to those vehicles until reasonably safe to proceed. (TRACKING/MEETINGS WITH STAKEHOLDERS)

AB 232 GALLAGHER (R – YUBA CITY) OFF-HIGHWAY VEHICLES: RECIPROCITY: Existing law requires every off-highway motor vehicle that is not registered under the Vehicle Code to display an identification plate or device issued by the Department of Motor Vehicles, with certain exceptions, including an off-highway motor vehicle with a currently valid identification or registration permit issued by another state. Except as otherwise specified, a violation of the Vehicle Code is punishable as an infraction.

This bill would permit application of that exception only if the other state recognizes an identification plate or device issued by the department as valid for use in that state. (SUPPORTING)

\*Passes Senate Transportation Ayes 17. Noes 0. Referred to Committee on Appropriations

AB-1512 BAUER KAHAN (D – ORINDA) OFF-HIGHWAY VEHICULAR RECREATION: CARNEGIE STATE VEHICULAR RECREATION AREA: ALAMEDA-TESLA EXPANSION AREA: This bill would require the department to preserve, in perpetuity, land known as the "Alameda-Tesla Expansion Area," which is currently part of the Carnegie State Vehicular Recreation Area, for conservation purposes, including for nonmotorized public recreation, as provided. The bill would require the department to work with other entities to have \$9,000,000 appropriated, transferred, or donated to the Off-Highway Vehicle Trust Fund for these purposes, as specified. (OPPOSE)

(Dual Similar Bill, SB 799 Glazer, same District - Bill Vetoed by Governor in 2019.)

SB 66 ALLEN (D – SANTA MONICA) CALIFORNIA COUNCIL ON THE FUTURE OF TRANSPORTATION: ADVISORY COMMITTEE: AUTONOMOUS VEHICLE TECHNOLOGY: This bill would require the secretary to establish an advisory committee, the California Council on the Future of Transportation, to provide the Governor and the Legislature with recommendations for changes in state policy to ensure that as autonomous vehicles are deployed, they enhance the state's efforts to increase road safety, promote equity, and meet public health and environmental objectives. The bill would require the council to gather public comment on issues and concerns related to autonomous vehicles and to submit, no later than January 1, 2024, a report to the Legislature with, among other things, recommendations for statewide policy changes and updates, and to continue to update the report, or submit a new report, of its recommendations biannually thereafter, or more frequently at the secretary's discretion. The bill would require the council to create subcommittees focused on one or more specific topics and to form one subcommittee led by the Office of Planning and Research focused on furthering the state's environmental, public health, and energy objectives, as specified. (TRACKING/MEETINGS WITH STAKEHOLDERS)

## Bills At A Glance continued

SB 227 JONES (R – SANTEE) OFF-HIGHWAY VEHICLES: This bill would require, for the issuance or renewal of a competition identification, a specified configuration for the vehicle identification number and product identification number for an off-highway motor vehicle or ATV that is model year 2022 or later and is used solely for competition, not on a public highway. The bill would impose restrictions on the operation of a competition motorcycle or ATV on public lands, including, among others, a requirement that a rider possess a current and valid competition card from a competition-sanctioning organization when practicing for a sanctioned event on public lands. Because operating a competition motorcycle or ATV on public lands in violation of those requirements would be a crime, the bill would impose a state-mandated local program. (SUPPORTING)

SB 799 GLAZER (D – ORINDA) OFF-HIGHWAY VEHICULAR RECREATION: Carnegie State Vehicular Recreation Area: Alameda-Tesla Expansion Area: This bill would require the Department of Parks and Recreation to preserve the portion of the Carnegie State Vehicular Recreation Area known as the "Alameda-Tesla Expansion Area" for conservation purposes, as specified. The bill would make implementation of this provision contingent upon at least \$9,000,000 being appropriated by the Legislature in the annual Budget Act or another statute, transferred, or donated to the Off-Highway Vehicle Trust Fund for its purposes. (OPPOSING) (Dual Similar Bill, AB 1512 Bauer Kahan, same District as Senator and the Assemblywoman that had their Bill Vetted by Governor in 2019.)

SR-41 CABALLERO (D – SALINAS) MOTORCYCLE PROFILING: According to the Department of Motor Vehicles, there were 857,273 motorcycles registered in California in 2019. Motorcycle profiling is the illegal use of the fact that a person rides a motorcycle or wears motorcycle-related apparel as a factor in deciding to stop and question, take enforcement action, arrest, or search a person or vehicle with or without legal basis under the Constitution of the United States. Rallies to raise awareness and combat motorcycle profiling have been held in multiple states and six times at the California State Capitol since 2011.

## Executive Director Report by Rick Robison

Well, here we are! The first half of 2021 is in the books. Here at ABATE of California we have been struggling through 2021. We need the support of our members throughout California to continue this fight!

In May, myself and a small crew from ABATE of California (Local 20), Jody Maxwell (Board member) and Jeff Sterling, went to the MRF Bikers on the Beltway in Washington DC. Compared to previous years, it was a very different trip as DC was heavily affected by Covid-19. At this event, we normally meet face-to-face with many representatives from California to speak to them about our rights as motorcyclists in the great state of California.

This year it was all about Zoom meetings and Conference calls. The Capitol and the other 3 associated buildings were essentially on "lock down" There were a few States that did have in-person meetings with their representatives, though. Those were States that ABATE/MRF representatives have built relationships with over the years. For California, we made phone calls and sent out emails for a few weeks before the event trying to get some in-person meetings.

We faced the same thing that most attendees to this event got "Due to Covid-19, at this time we are not conducting in-person meetings" We did have a couple of calls with representatives, but nothing like it had been in the past...CONTINUED NEXT PAGE

## Latest Legislative Information From ABATE



California has always allowed valid "out of state" OHV registered vehicles to use our public lands. It has come to our attention that some of our neighboring states have recently implemented a "non-resident" fee for OHV's being operated in their state. By no longer honoring our California registration these states are reneging on a long standing tradition in the OHV community. These new regulations will be expensive and prove onerous to every legally licensed OHV owner that travels and recreates in other states. Our ABATE OHV Division is asking for your help and financial support in fighting this type of legislation. Assembly Bill 2761 sponsored by Assemblyman Gallagher (Republican—Yuba City) seeks to remedy this issue of reciprocity and ABATE of California is asking you to help the OHV communities of our states restore equal access to OHV areas for all legally licensed users.

In addition to AB 2761, Abate of California is proposing two other bills for our elected official's to consider this year. Our first bill would require DMV to allow rider's to take both the M/C skill's test and their DMV written exam during their CHP certified M/C training classes. After a rider successfully completes and passes both tests the school would submit the information to DMV and they would issue a valid M/C endorsement card by mail to the rider that is valid for the duration of their current California drivers license. Upon license renewal the M/C endorsement would then be added to their new license thereby saving the student the time and expense associated with visiting and testing at their local DMV office.

Our second bill would seek to exempt all M/C riders and especially our Military Veteran riders from being accessed a toll fee when traveling on a toll road within the state of California.

Senator Caballero introduced Senate Resolution SR 41 the Motorcyclists Anti-Profilng Resolution! SR 41 is set in Senate Rules Committee July 8th. We're urging all members to send letters/emails to your Senate member - <http://findyourrep.legislature.ca.gov> - to support SR 41. If passed, it helps the passage of Congress HR 255 "Promoting awareness of motorcycle profiling and encouraging collaboration and communication with the motorcycle community and law enforcement officials to prevent instances of profiling" BACK IN DC!

When ABATE's Lobbyist met with Rocky Fox, MRF's Lobbyist, he was excited if we could pass SR 41. He said it would be of GREAT HELP getting more California Congress Members to sign on as Co Authors of HR 255. So, let's get to work!!!!

The Legislature Passed the State Budget on time for the 5th consecutive year since the voters passed the initiative that allows for a 41/21 simple majority vote by both Houses! One incentive was the Legislators would not be paid until the Budget was passed - that being said, it didn't make the States' Budget any better just on TIME! Flush with cash due to President Biden bailout money, California and other States are flush with CASH! Which of course means NEW government programs, however when the state income drops there's a big fight on what and where to cut of course after all these new state programs.

Legislative Policy Committees are meeting and hearing the other Houses' bills, for instance AB 232 Gallagher (R - Yuba City) Off-highway vehicles: reciprocity and SB 227 Jones (R - Santee) Off-highway vehicles. Take a look at our Bills at Glance Section for in depth update on potential new laws for 2022.

## ABATE of Washington April Safety & Education by Texas Larry Walker

"Texas" Larry Walker is a Nationally Certified Rider Coach for novice, intermediate, and advanced training. He is the Senior Instructor for Navy Region Northwest, a long-time motorcyclist rights advocate, with well over 40 years of riding experience.

May, it's always declared to be Motorcycle Awareness Month, but what does that really mean, and where do we fit in that picture?

We have all heard the stories, "That dirtbag came out of nowhere." "That idiot just cut me off so that he could get his precious latte." "The moron just pulled out in front of me."

My question is this; are they really so cavalier as to not care about riders or is there some underlying reason as to why they do not see us? The answer can get really complex if you let it, debating various situational scenarios, but it normally distills down to a couple of factors.

The first one is that many drivers simply do not see motorcycles because they do not have any sort of connection to motorcycles. When their brains are telling them to search for potential points of conflict in traffic, motorcycles are not really in their consciousness, ergo they do not land on the immediate scan list. The primary thrust of declaring May to be Motorcycle Awareness Month is to get motorcycles in the minds of the driving public so that we make their immediate scan list. Nuff said on that factor.

The other factor hits a bit closer to home. When someone tells me, either in person or on some media platform, about their near miss, pucker moment, or crash, I almost always ask them what they did to get into that situation. My bottom line being did they give the other driver any chance at all to locate them in the mix? It is a proven fact that there is a 1.5-2 second lag from the time the image hits our optic nerve until it can be translated into actual action.

If we want to have other drivers see us, how can we help them do that? Do we get too close to the box truck or other large object so that we are hidden from view of oncoming or entering traffic? That may create the optical illusion that there is a huge hole behind said large object, which may result in someone moving into our path of travel.

Are we moving so rapidly that we become hard to detect and track? On a rural road we need to have a bare minimum of 2 seconds to allow a decent driver to detect us and take, or not initiate, action. At 60 MPH that translates to needing a minimum of 180 feet of clear space ahead of us. When we are doing the banzai through freeway traffic, using the cars as slalom pylons, when do the drivers actually perceive our presence? I'll go more deeply into this game of "traffic chess" at a later date, but I hope that you get the picture.

We need to make it easier for the rest of the motoring public to find us in the mix as quickly as they can.

## Senate Resolution 41 - By Senator Caballero (D - Salinas) Motorcycle Profiling

### SR 41 – Motorcycle Anti-Profiles Resolution

#### SUMMARY

SR 41 will establish a meaningful and constructive dialog between representatives of the motorcycle riding community and local and state law enforcement agencies around the issue of motorcycle profiling, and to work towards reasonable and realistic solutions to prevent it. SR 41 urges local and state law enforcement agencies to include statements condemning motorcycle profiling in written policies and training materials.

#### PROBLEM

According to the National Motorcycle Profiling Survey, there are several thousand reported incidents by motorcycle riders of law enforcement officers unreasonably stopping and detaining them for long periods for reasons unrelated to any traffic violation. These traffic stops are an effort to collect intelligence on motorcycle clubs and members, as well as search riders and their vehicles for items that law enforcement claim are illegal, all without due process. In many cases, riders were placed in handcuffs or ordered to sit or lay on the ground while officers search their clothing and motorcycle. In some cases, field information cards (PIC) are used to collect information that is later turned over to gang unit officials who use the information to document associations and sometimes add names to the CalGang State Database without any justification.

#### BACKGROUND

As of January 2021, the annual National Motorcycle Profiling Survey conducted in 2020 by the Motorcycle Profiling Project found that of those who reported being profiled by law enforcement in California, 45 percent were members of religious clubs, 10 percent were members of veteran clubs, 28.57 percent were members of traditional motorcycle clubs, and 34 percent were independent riders.

The National Motorcycle Profiling Survey also showed that between 2014 and 2019, participants reported that they felt that the reason they were profiled was because they were either riding a motorcycle or wearing motorcycle-related clothing or colors. In addition, the number of riders who felt this way increased from nearly 20 percent in 2014 to nearly 50 percent in 2019.

SR 41 (Caballero) | Updated: 6/14/2021

Many states including Maryland, Louisiana, and Idaho have passed laws to address the issue of motorcycle profiling. In addition, the United States Senate unanimously adopted a resolution promoting awareness of motorcycle profiling across all 50 states.

#### SOLUTION

SR 41 will bring together representatives of the motorcycle riding community and representatives from state and local law enforcement agencies to discuss the issue of motorcycle profiling and to work towards reasonable and realistic solutions to prevent it. This resolution also encourages law enforcement agencies to include statements condemning the profiling of motorcycle riders in their official policies and training materials.

END MOTORCYCLE PROFILING

Motorcycle profiling is a pervasive problem in California. Motorcyclists are often targeted because of an overly-broad outlaw biker stereotype. The historical pattern of evidence is documented and irrefutable. Individuals and groups of motorcyclists are regularly the victims of selective enforcement from coast to coast, particularly California, even during political and charitable events, solely based on their appearance, not their conduct.



**Motorcycle Profiling is Unconstitutional:** Profiling relies on appearance to establish suspicion as opposed to the legal requirement of conduct. A motorcycle pretextual stop may lead to the motorcyclist being detained, cited, motorcycle seized, or both because of constitutionally protected expression and / or association.

**The Solution:** Motorcycle Profiling Senate Resolution 41 (SR 41) is being introduced to the CA Senate by Senator Anna Caballero on June 10, 2021. Resolutions are a highly effective method to bring awareness to issues like Motorcycle Profiling and serves as a stepping stone to future mandated legislation. This resolution seeks to create awareness of the state-wide issue of motorcycle profiling in CA and open doors of communication between state and local law enforcement agencies and our motorcycle community in an effort to establish a dialog to discuss the issue and how to prevent it going forward. This non-binding bill requires no training, presents no fiscal impact and doesn't prevent law enforcement from doing their job. In addition, the language is similar to Senate Resolution (S. Res 154) which passed unanimously in Washington DC last December and is expected to be re-introduced in the House of Representatives during the 2021 legislative session.

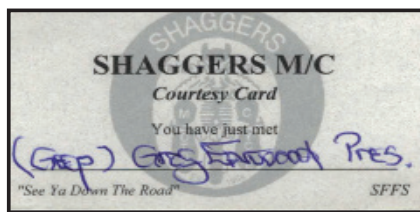
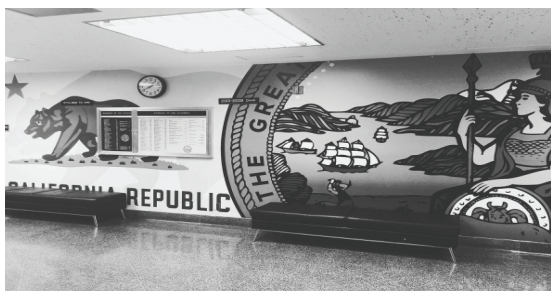

Some of the nation's finest Freedom Fighters will address legal and legislative topics of concern to all riders, from helmet laws to anti-profiling to lane-splitting, autonomous vehicles, the fate of internal combustion and much more.

**OREGON LANE SPLITTING BILL GOES TO THE GOVERNOR:** After years of legislative attempts, Oregon may soon join with neighboring California and a host of other states that have approved of lane splitting for motorcyclists. The state House of Representatives on Monday, May 17, gave its blessing to Senate Bill 574, a bipartisan proposal that allows motorcyclists to operate in between lanes of traffic under certain circumstances. After a 42-14 vote in the House, preceded by an 18-6 vote in the Senate, the bill now heads to the desk of Governor Kate Brown (D) for her consideration.

According to one news source, SB 574 has received more testimony than nearly any other piece of legislation this session, as proponents flooded legislators' inboxes clamoring for the idea. Their argument: That allowing motorcyclists to bend the normal rules during traffic jams would be good for both safety and improving congestion. Oregon state representative Ron Noble (R-McMinnville), who is himself a rider and who also carried the bill in the House, told Oregon Public Broadcasting KVAL, "It will provide me personally with another option to ride safe."

As described in a Legislative staff report: "Lane Filtering" is "meant to allow motorcycles to continue moving when the general flow of traffic is slowed or stopped, and is meant to prevent overheating of motorcycle engines, rider fatigue, and protect the safety of riders by preventing them from being rear-ended in areas with high levels of traffic congestion."

Under SB 574, motorcyclists are allowed to split lanes only on multi-lane highways with a speed limit of at least 50 mph. When traffic slows to 10 mph or less on those roads, motorcyclists are permitted to ride between cars, at no more than 10 mph faster than the flow of traffic. The law does not apply in school zones or work zones.

California has long allowed lane splitting, under different circumstances than Oregon's bill, and Montana recently passed a law of its own. Utah allows lane filtering when traffic is stopped at an intersection. Hawaii permits motorcyclists to utilize the shoulder when traffic is congested.

**BIKER ANTI-PROFILING MEASURE INTRODUCED IN CONGRESS:** More than two years ago, the U.S. Senate unanimously passed a nonbinding resolution condemning the discriminatory profiling of motorcyclists by law enforcement (S. Res. 154), and now the U.S. House of Representatives has once again introduced a similar bipartisan measure in the 117th Congress, H. Res. 366; "Promoting awareness of motorcyclist profiling and encouraging collaboration and communication with the motorcycle community and law enforcement officials to prevent instances of profiling."

Sponsored once again by Rep. Tim Walberg (R-MI), the anti-profiling resolution was introduced in the U.S. House of Representatives on April 30, 2021 to thwart "the illegal use of the fact that a person rides a motorcycle or wears motorcycle related apparel as a factor in deciding to stop and question, take enforcement action, arrest, or search a person or vehicle with or without legal basis under the Constitution of the United States," as profiling is defined in the resolution. H.R. 366 acknowledges nationwide motorcycle registrations "growing from 3,826,373 in 1997 to 13,158,100 in 2018," and notes that "complaints surrounding motorcyclist profiling have been cited in all 50 States."

Co-sponsored by Congressman Michael Burgess (R-TX), Congresswoman Cheri Bustos (D-IL) and Congressman Mark Pocan (D-WI), the bipartisan resolution denotes three actionable items: (1) promotes increased public awareness on the issue of motorcyclist profiling; (2) encourages collaboration and communication with the motorcyclist community and law enforcement to engage in efforts to end motorcyclist profiling; and (3) urges State law enforcement officials to include statements condemning motorcyclist profiling in written policies and training materials.

All concerned motorcyclists are encouraged to contact their Congressional Representatives to ask that they join their colleagues as a cosponsor of H.Res.366 and help put a stop to law enforcement unfairly targeting motorcycle riders for traffic stops, questioning and citations.

In the meantime, efforts are underway to again include anti-profiling language among other pro-motorcycle provisions in the Biden Administration's multi-trillion dollar federal highway bill.

**U.S. MOTORCYCLE SALES WAY UP:** New-model motorcycle sales among leading brands increased more than 37.2% in the first quarter of 2021, according to the Motorcycle Industry Council Retail Sales Report. The Q1 sales, compared to the same period last year, were up by double digits in every category: on-highway, off-highway, dual-purpose, and scooter.

"This is the fourth straight quarter of strong sales numbers, indicating continued and growing interest in riding among new and returning riders," said Erik Pritchard, MIC president and CEO. "Combine the new-motorcycle sales performance with the pace of tire sales and we know that more riders are putting on more miles."

Year-to-date sales of dual-purpose motorcycles were up the most, by 47%. Off-highway sales were up 45.4%. Scooter sales rose 34.6%, and on-highway motorcycle sales increased 31.4%.

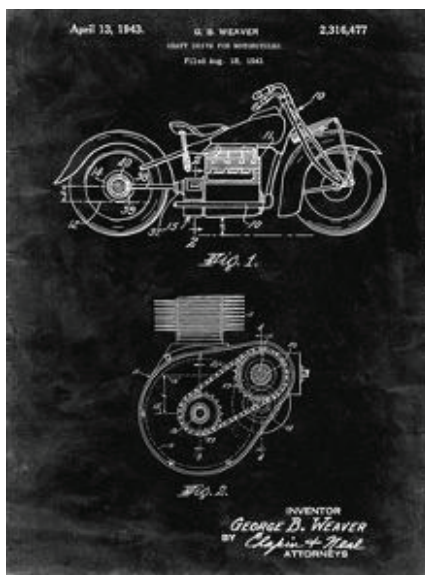

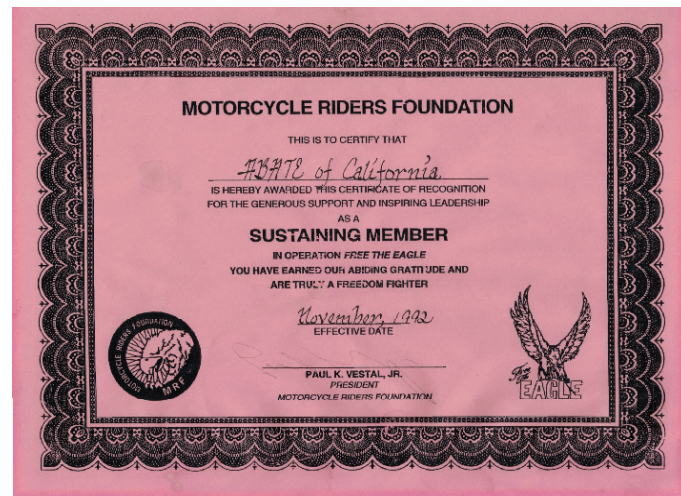

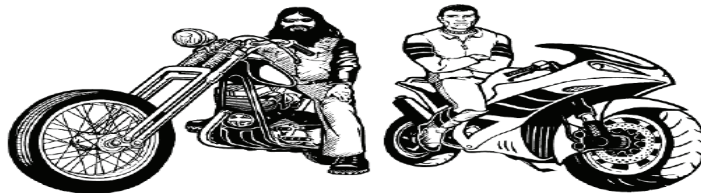
