Lobbyist's Report

The Legislature is starting to get busy with hearings! Between now and July bills must move out of the policy committees to which they were assigned, and their house of origin, or become two year bills. So far, AB 334, introduced by Assemblyman Ken Cooley (D-Rancho Cordova), the motorcyclist anti-profiling bill, will be heard in the Assembly Public Safety Committee, which is chaired by Assemblyman Bill Quirk, who is also the author of the motorcycle lane sharing bill, AB 51. The date for hearing AB 334 is March 24th, at 9:00 a.m. in Room 126. Please send letters to your Assembly Member

in **Support of AB 334**, and copy the Chair of the Committee, Assemblyman Bill Quirk.

Assemblyman Quirk's lane splitting bill, AB 51, has not been set for a policy committee hearing in March, and will most likely be heard in April. I have met with Assemblyman Quirk's staff and presented our proposed amendment to remove any speed restrictions when motorcyclists "share lanes". The staff will be presenting our proposed amendment to the author and will get back to me with his decision.

So far the rumors of an anti-motorcycle roadside noise test bill are just rumors so far, but I am watching the numerous "**SPOT BILLS**" to see if this language is put into one of them.

SB 192, authored by Senator Carol Liu (D-Glendale), will require **ALL** bicyclists, **including adults**, to wear helmets! We could oppose on principle. That is up to the ABATE PAC Committee to decide.

There are many Special Elections underway, as members are running for safe, non-term-limited seats in Congress which create various Senate and Assembly district vacancies, to be filled by special elections as members change houses and jurisdictions.

Stay tuned to the big changes that are happening in Sacramento this Session/Year. **THANKS TO ALL WHO SUPPORT THE SPECIAL DEDICATED LOBBYIST FUND** that keeps me fighting for motorcyclists' rights in Sacramento!

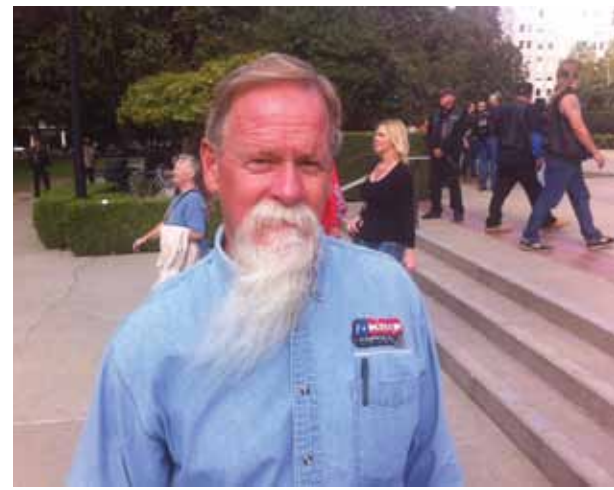

Chuck Pedersen, our Legislative Director, Jim Lombardo, our ABATE Lobbyist and our ABATE PAC members have been very busy with the three Assembly bills that have been introduced so far this year that will directly impact motorcycle riders in our state. Briefly they are Assemblyman Mike Gatto's AB 8 which concerns "hit and run accident" legislation, Assemblyman Bill Quirk's AB 51 which concerns "lane sharing" by motorcycles, and Assemblyman Ken Cooley's AB 334 which prohibits "profiling" of motorcycle riders in California.

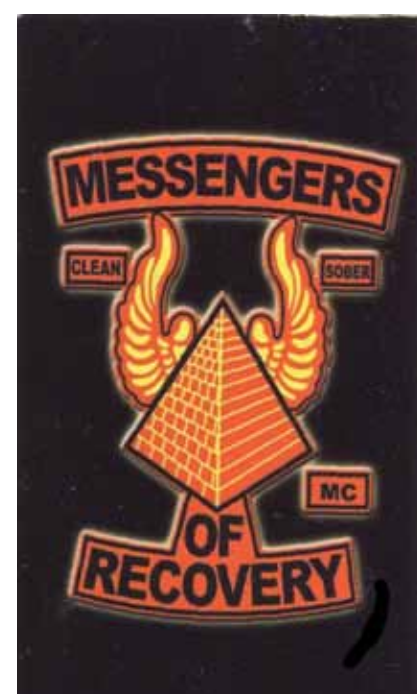

Motorcycle Safety Report

Foolish Behavior is Stupid

There's always been one in the crowd, a fool that is. Being a fool has been around since the caveman days (I just watched Caveman ala, Ringo Starr) and today it's far worse than we really think. Being foolish was in skits and shows then elevated to the silver screen. The public of the world desired to see foolish behavior and its consequences for their amusement. It was casual entertainment and it was physical as well as behavioral, sometimes very extreme.

The definition of a FOOL is: "A person lacking in judgment or prudence, a harmlessly deranged person or one lacking in common powers of understanding." The word fool has many, many descriptions, too many to list.

The next word is STUPID! First definition is: "Not intelligent, having or showing a lack of ability to learn and understand things." Second is: "Not able to think normally because you are drunk, tired, lacking intelligence or reason and slow of mind." So you say, "Norm why are you telling us this?" First of all, I'm defining the difference between the two and from what I know is this: Being foolish is a whim. You could be smart and educated then you do something out of control because you put yourself in that position. Being stupid - well maybe you get into trouble not knowing what you're doing or lack of experience that you thought you had.

The meat and potatoes of this is we see these behavioral patterns every day and we could be the ones who are called these names and or be the ones that say them as well. YouTube and Facebook are the catalyst now and you can find all the videos of said such person or persons about anything! But I will keep this to just motorcycles. If you miss it live you can find it on youtube, you won't be disappointed and you might be entertained even though it could be devastating to the said such rider(s).

So recently I was going through an intersection and noticed a car waiting to turn left (they saw me entering) and all of a sudden a biker who was behind them swerved around them to turn left as I was going through the intersection. Lucky for him to dodge out of my way (I was doing 45 mph) just in the nick of time. I was instantly honking my horn because I didn't have time to flip him off. True story! I thought what a fool he was; was he so impatient to put his life in danger?

Another time I saw a man, with a woman passenger, at an intersection. The guy opens up full throttle to pop a wheelie and the lady gets tossed and then him as well and his bike does the one legged hoppity floppity dance. True story! Another fool! Where the heck are they coming from?

I saw this as well; one of my friends that was riding with us kind of drifted away momentarily as we all banked right during a turn and he went straight. I kinda saw him lock his brakes as he went off the



road. Stupid! Another friend of mine wasn't as experienced a rider as we were and he didn't negotiate a left banking turn and wiped out as he went off the road onto a dirt shoulder. Another example of being stupid, I'm not saying it was me, but like people tell a doctor, I have a friend that has this rash.....

Okay it wasn't me, but I've done that before during my youthful days as a biker and it was more embarrassing than anything else. Out of anger we call ourselves stupid or we are yelled at for being stupid. Whether you're successful or fail at something on your motorcycle ALL people take notice. Some people may ooh & aah you and some might say, "Look at that dumb ass." Then again, you might get a ticket from someone that can.

I look at our democratic system of fairness (I'm tripping) and wonder why my insurance is so expensive or why do we have laws that infringe on our freedom, them stupid fools!!! It makes you think. Mass punishment comes to mind. Just Saying! So this is what they say and I know it to be true: The actions of a few penalizes the majority.

Through my experience I know where I stand and how good of a rider I am, even though I had many accidents when I was young. I started riding when I was around 13. It was a learning process and lucky for me nothing serious. But I had a few friends that weren't as lucky as I was - they are fully decomposed by now - serious stuff for being either stupid or foolish! Why do we feel like we have to show off? It's got its place and moment, but for the most part it's very abused because a lot of riders lack experience and practice. Think about it. It takes repetitive practice to master some of the stuff out there. There's always the one who thinks he can do it on a whim and you know what happens - they get famous on YouTube! I sure hope not. When you have discernment you'll know your limitations - it's a fact.

Every year is critical nowadays for motorcyclists. We're under the microscope of life and it is being

defined by the few and not the majority. When I think about motorcycle safety it's about knowing where you stand as far as experience goes. Even though we can be the safest rider out there, there will be times when someone else will prove us wrong by accident, no fault of yours. It's just a way of life in today's modern world - the numbers are Huge! It's just about the millions and millions of drivers and riders out there on all the roads today, so something's gotta give.

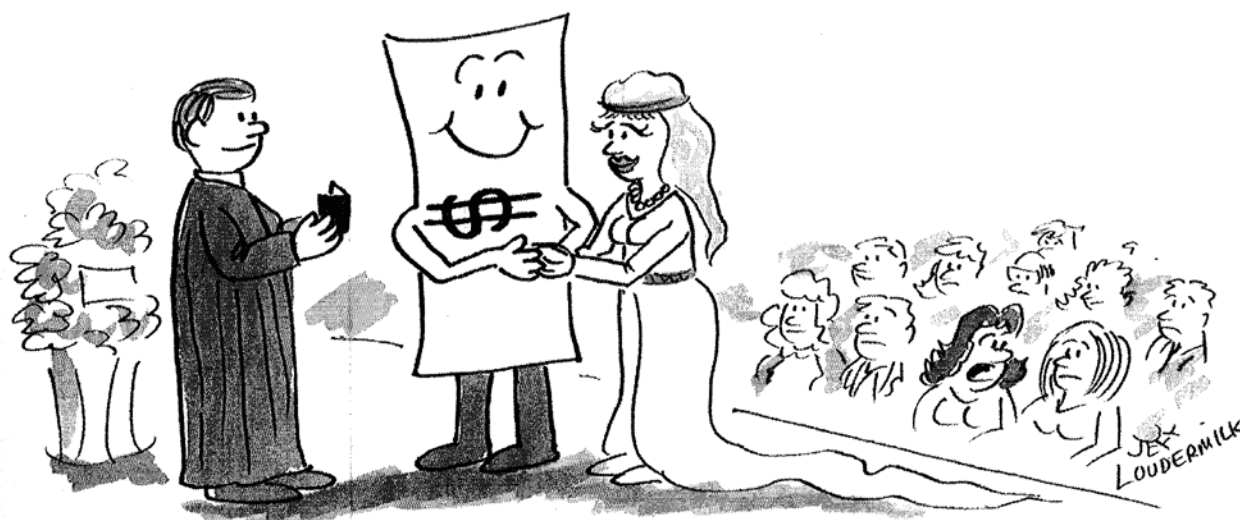
We also say things like "clowning around" or "showing off." The word descriptions of foolish behavior and stupid behavior are plentiful. I have been guilty of both and sometimes you get away with it and sometimes you get bit really good!

This time of year is a great gateway to our riding season. For some, it's been a while since they've ridden and for others it has never ended, nevertheless it's a great time to check all aspects of your bike and rework your skill level - kind of like pre-game warm-ups. I've said in the past articles and I'll say it again, know how your brakes work and practice locking your rear tire at slower speeds then graduating up to speeds in the double digits. This will help you understand how your bike reacts as well as you.

Practicing slow speed turns is not easier than it looks. Knowing how much speed and torque you need for higher speed turns is important as well, you know, being in the right gear, and having the proper RPM's to propel you through the turns. Sometimes if you go too slow through a turn or you are in the improper gear then your bike gets heavy and you can't shoot the hole and you will drift off the road or you'll have to brake really hard to stay on the asphalt! I've done that before and have seen it a lot. If you are riding through unfamiliar roads then you have to pay attention to all the road signs, especially the ones that designate the speed which was established to be safest to negotiate the turn. And yes I do have friends that take a new road as a challenge and pass me so fast, then you see them leaning far more than you'd dream of doing and gunning it out and disappear slowly from your sight. You'll hookup with them at the bottom or the top of the hill five minutes later. Don't worry, your skill level is not the same as theirs and don't try and do their level - it's good to meet them after the fact. It's a big pill that I had to swallow, but I know my limitations. Remember I said earlier that I have friends that have decomposed, true story!

Going to a riding school is a great way to advance your skills. Talking to other riders and understanding what they say is great as well. ANTI-PROFILING MEASURES SPREAD NATION-WIDE - NCOM-LTF UPDATE: This is one of the most exciting and productive Legislative seasons we have had in a very long time, as a unified community and as a freedom seeking culture. We are moving towards our goal of Critical Mass in establishing a National Movement to end Motorcycle Profiling with eight States in the process of Bill sponsorship, committee hearings or have already passed anti-profiling protection. The National Coalition of Motorcyclists (NCOM) is solely sponsored by the Aid to Injured Motorcyclists (A.I.M.) nationwide legal services program and serves as an umbrella organization for more than 2,000 NCOM Member clubs, organizations and associations worldwide, representing well over a quarter of a million politically active motorcyclists. LANE SPLITTING COULD MOVE BEYOND CALIFORNIA: California is the only state in the U.S. where motorcyclists are allowed to cruise between lanes of cars, a practice called lane-splitting that is normally used to cut through stalled or slow-moving traffic. But now, an effort to legalize lane-splitting in other states, such as Washington, Oregon, Texas and Tennessee, is gathering momentum amid a push by motorcyclists and by some lawmakers looking to relieve highway congestion.

Bills to extend the practice to other states has sparked a safety debate, and although no one has tracked exactly how many highway accidents are caused by lane-splitting, a study from the California Office of Traffic Safety last year found that motorcyclists' injuries were kept down as long as they split lanes in slowly moving traffic and exceeded the speed of other traffic by less than 10 miles an hour. Further, the study found that motorcyclists were less likely to die or be injured in lane-splitting crashes when compared with other kinds of collisions.

The lane-splitting measures in Washington (SB 5623 & HB 1515), Oregon (SB 172 & SB 420), Texas (SB 442 & HB 813) and Tennessee (HB 1102) all set varying limits to motorcyclists' speed and speed differential. Most of those bills are in committee, although Washington state's measure has passed the state Senate 35-14.

HANDLEBAR HEIGHT LAW REPEALED IN SOUTH DAKOTA: Good news for those riding to the 75th Anniversary Sturgis Rally this year, as South Dakota has abolished their handlebar height law, so as of July 1st ape hangers will now be legal and no more 20-dollar-tickets for bars taller than shoulder-high.

On Tuesday, February 24, 2015 Governor Dennis Daugaard signed Senate Bill 85, joining 13 other states with no handlebar restrictions (Arkansas, Colorado, Idaho, Iowa, Kentucky, Minnesota, Montana, Oregon, Pennsylvania, New Mexico, North Carolina, Virginia and Tennessee).

Pointing out that there are no national laws that regulate handlebar height, nor commonly agreed upon standards between states, ABATE of South Dakota emphasized personal comfort and style over safety concerns, given that no scientific studies identify any negative impact.

"A great team effort," cites ABATE state coordinator Jiggs Creasy. "Not a single opponent testified and not a single vote against it (SB 85 passed unanimously in the Senate 34-0 on 02/05/15 and passed the House of Representatives 69-0 on 02/17/15)."

UNITED FRONT HELPS TO DEFEAT HELMET LAW PROPOSALS IN NEW MEXICO: In a unique "Pay-to-Play" scheme to punish motorcyclists for exercising their right to ride without a helmet, a Senate bill proposed in New Mexico would have created a system of taxation for riders who opt not to wear a helmet.

Specifically, SB 308 would have created an annual motorcycle \$697 license plate sticker that allowed the operator and passenger to refrain from wearing a helmet, for a fee. It and a full blown helmet law (SB 327) were both heard in committee on the same day, and each bill died.

"February 24, 2015 is a day that will live in New Mexico Motorcycle History as two helmet bills died in the Senate Public Affairs Committee," said Annette Torrez, Chair of the New Mexico Motorcycle Rights Organization and a member of the NCOM Board of Directors. Torrez had issued a call to action, requesting assistance

from the National Coalition of Motorcyclists (NCOM), the NCOM Legislative Task Force (NCOM-LTF), US Defenders, Motorcycle Riders Foundation (MRF) and the American Motorcyclist Association (AMA), all of which came to the aid of NM riders to help defeat the onerous proposals.

"Together we can accomplish the possible and the impossible," said Torrez. "Now we can put our efforts into SB 651, the Careless Driving Bill to increase penalties for a person who commits careless driving that result in death or great bodily harm."

RED LIGHT BILLS ADVANCE IN GEORGIA & OREGON: "Today marks the first time either Georgia General Assembly body has voted YES on Red light relief for Georgia Riders," said ABATE of Georgia state director Ned Williams, referring to Senate Bill 76 "Motorcycle Mobility Act" which passed the state Senate 51-4 on March 11. "So now we are ramping up for a fight in the house ..." and ABATE is calling for motorcyclists to contact members of the Georgia House of Representatives "and ask them to VOTE YES on AB76."

Likewise, a bill to allow motorcyclists to proceed through an inoperative or malfunctioning traffic-control signal has cleared the Oregon state Senate unanimously which will permit "a bicyclist or motorcyclist to proceed at a stop light under certain conditions." Senate Bill 533 is now headed to the House floor with bipartisan support, and is designed to bring relief to bikers who find themselves at stop lights that won't change by allowing them to safely proceed through a red light that "fails" to trip after "one full cycle."

MASSACHUSETTS RIDERS OPPOSE PROPOSED BAN ON BIKE RIDES IN YARMOUTH: Massachusetts Motorcycle Association (MMA) members are organizing opposition to citizens' petition articles that will be before voters at the upcoming Yarmouth Annual Town Meeting. One article would ban motorcycle rides through town and the other involves a noise bylaw.

Rick Gleason, Massachusetts Motorcycle Association legislative director, said, if enacted, one of the articles would ban charity rides in town. That would include, he said, one of the town's biggest rides, Big Nick's Ride for the Fallen. "If this ban is put in place and enacted and if the attorney general stands by it and says that it is just, it's going to force the organizers to reroute the ride," Gleason said, adding that people who come to town for the charity rides spend money locally on hotel rooms and meals. "We do not support this ban. There are a couple of big rides that begin or end or pass through Yarmouth. We would hate to see the town miss out on the opportunities and the monies that are generated during these charity rides," he said.

SCHOOLS IN CHAD CLOSED OVER VIOLENT HELMET LAW PROTESTS: Schools and universities in the Chadian capital of N'Djamena were closed on Tuesday, March 10, 2015 and remained shut "until further notice" after student rallies against motorcycle helmet laws left at least one person dead.

The closure announced by the government of Chad in central Africa comes a day after students took to the streets to protest against a rise in helmet prices ever since their use became obligatory in N'Djamena effective March 1 and motorcyclists are now required by law to wear a helmet.

The protesters set fire to several vehicles and blocked access to schools and universities, an Agence France-Presse (AFP) journalist reported. Clashes broke out after security forces used tear gas to disperse the protesters. Hospital officials contacted by AFP said "three people were killed, and several others were injured."

DRUG DRIVING LIMITS SET FOR FIRST TIME: Limits on the consumption of illegal drugs before driving have been set for the first time under new legislation introduced in the United Kingdom, and drivers and motorcyclists face up to six months in prison for exceeding very low limits set on eight illegal drugs including cannabis and cocaine. The limits set for medicinal drugs exceed normal prescribed doses.

The legislation, which covers England and Wales, also sets limits for eight prescription drugs including morphine. Police will use new roadside drugs testing kits to measure cannabis and cocaine in saliva. Tests for other drugs including ecstasy, LSD, ketamine and heroin can be done at police stations.

A conviction will lead to a minimum one-year's driving ban and a fine of up to £5,000. Police will delay enforcing the new law until satisfied the procedures "withstand legal scrutiny."

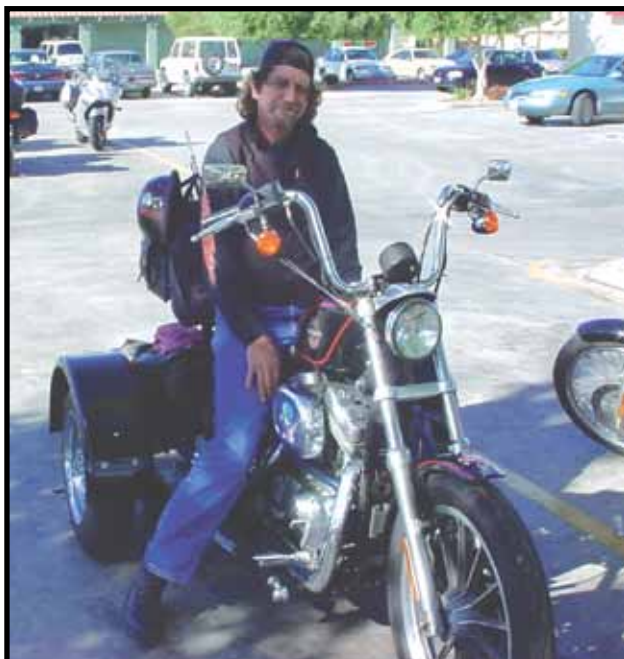

The Sporty

A friend of ours mentioned that I don't write too much about Sportsters. Good point! No excuse, this is one of my favorite models. Although most of my tech tips are applicable to all models, we haven't spotlighted Harley-Davidson's venerable factory hot rod. A worthy subject by all rights, this is the Motor Company's longest running model (1957). So let's get a glimpse of the history and talk about some things that make it different (many would argue better) than it's big twin counterparts.

The predecessor to the Sportster was the K model, which was produced from 1952-1956.



Lots of similarities, but the K ran a flat head engine. In 1957 H-D introduced the overhead valve Sportster, pretty much the one we know and love today. These were known as the "iron heads."



This version stuck around until 1986 when Harley revamped the model line with the all new Evolution motor.



Still running this line to present day, there have been some significant technical changes. Besides the normal improvements that were also implemented to the big twins like better brakes, fuel delivery, and electronics, later models eventually went to a rubber mounted drive train (2004) and fuel injection (2006). Compression was also bumped to a respectable 9.7:1. One change most of us may never understand was the deletion of the transmission trap door (bearing housing). Removing the transmission gear set on models prior to 2004 was relatively simple. Opening the primary and removing the clutch assembly provided access to the trap door.



Once the pulley was removed from the other side, the entire gear set could be removed through the left side. In the absence of this set up, the gear set now resides inside the engine cases. The entire engine must be stripped, including splitting the cases, to access the transmission. To H-D's credit, the XL transmission is very reliable and virtually bullet proof. That said, there are the occasional failures and the labor for the repair is much more expensive.

Some of the best improvements to the big twin models have come from the Sportster line. Most of these were implemented in the 1999 Twin Cam drive train. The gerotor style oil pump added improved oil delivery and return scavenging. The XL unit construction of the engine and transmission assembly is a superior set up and the Motor Company finally figured out a way to bolt the two together on the big twins. Prior to the Twin Cam, these models relied on the inner primary as a stressed member to connect the two. Higher horsepower applications resulted in cracked primaries and broken motor mount bolts, especially with the rubber mounted models. The Carlini Torque Arm was the only answer for that design flaw. Another up-check for the Twin Cam passed on by the Sporty is the reason for the former's namesake. Mother Harley was fighting the angular displacement issue of the big twin pushrod valve train since the beginning. This was especially problematic with the front cylinder exhaust tappet as it endures the greatest side forces due to the angle of its pushrod, more so than the other three. It's a common practice to just replace the lifters every 20,000 miles on Evolution and older models. H-D reduced the pushrod angle by utilizing two cams (not their first try at this by the way). By contrast, if you look close at the XL's right side you'll notice the pushrods are oriented almost parallel to their respective cylinders. No angle to stress those lifters thanks to each valve having its own cam.



I hope this gives you some good insight on Harley-Davidson's popular and longest running model. With the success of the Sportster there's no doubt it will be around for many more years.

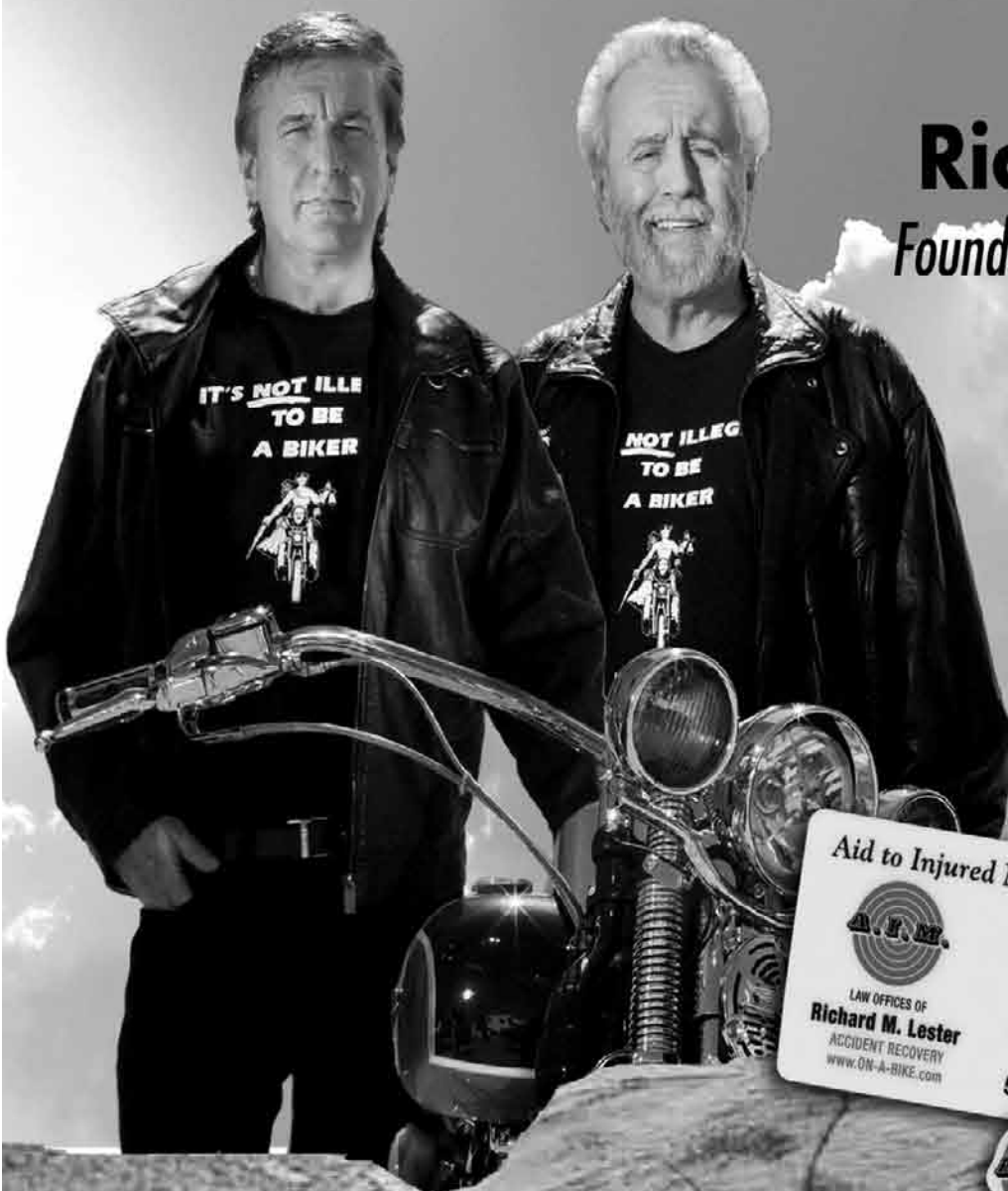
