
The Legislature returns August 4 to finish out the last half of the 2013/14 Legislative Session. There are still several thousand of bills before each house and they have until August 31 to kill or pass them and, if passed, send them to Governor Brown for his signature or veto.

This is the time of year that bills are gutted and amended to do something **TOTALLY DIFFERENT** than was in them when they were introduced in January and February of this year. Things like orange or yellow vests for motorcycle riders! Roadside noise and/or smog checks! Even a ban on lane sharing could come up in a gut and amend bill.

I am reading bills daily to make sure that if these types of Anti-Biker legislation show up, to quickly send out Alerts and calls to action to deal with them.

I hope to see many of you in Fresno for the Leg/PAC meeting on July 26. I will be discussing the outcomes from the June Primary and we will be outlining our strategies for electing many more motorcycle-friendly candidates in November.

Congratulations to one of **ABATE'S GREAT FRIENDS** and author of AB 1835, our Off Road Helmet Repeal Bill, Assemblywoman Kristen Ol-



sen (R- Modesto) who was elected to be the Assembly Republican Leader for the 2015/16 session. I look forward to working with her the remainder of this session, and next year as well!

Thanks, again, for sending contributions to the Lobbyist Fund to keep me in the Capital protecting Riders' Freedoms!



State Legislation to Create a Veterans Cemetery in Orange County by Spike, Local #20 Orange County

Gill Mellen (Local 20) and I met again with Sharon Quirk-Silva, Assemblywoman for the 65th District. The event, a pancake breakfast at the Walter D. Ehlers Recreation Center in Buena Park, was to discuss the Orange County Veterans Cemetery Act (AB 1453) and how you can get involved.

There was a great turn out, a full house, with veterans, bikers, local dignitaries and supportive citizens. Assemblywomen Quirk-Silva spoke about issues and the process then introduced the people and committees, including ABATE, involved and supportive of AB 1453.

The bill doesn't specify a location in Orange County but Bill Cook, Chairman of the Orange County Veterans Memorial Park & Cemetery Committee, has worked to get a veterans cemetery at the former El Toro Marine Corps Air Station since it was closed 15 years ago. Assemblywoman Quirk-Silva said the Great Park is a perfect location, "Well, I certainly think it is," she said. "And I think many people in Orange County do believe that it not only would be a great tribute to our veterans but it's the right location."

With so many veterans in our biker communities we shall keep a watchful eye on this bill.

Gill told us that law enforcement is no longer al-

lowed to search cell phones without a search warrant and the best way to keep them out of your saddlebags is to have locking bags.

Spike is still recovering from his accident but was able to attend the meeting and he said that the accident was an eye opener. He talked about how insurance companies are quick to take your money but are not so quick or honest about paying claims. The "value" of his bike is an average estimate of all bikes across the nation of similar kind but the cost to replace a bike is higher than other states but insurance companies will take an average across the nation and try to pay you the lowest price if you're not paying attention. He also said that if you have any add-ons to your bike like chrome, windshields and other things, keep all the receipts! If you don't have receipts to show the insurance company you won't be reimbursed for those costly improvements. Make sure you have good coverage on your bike and don't take it for granted, know what it covers.

Motorcycle Safety Report

Escaping the Statistics of Life

July is a great month for riding; I have seen more motorcycles on the road than all of the previous months. June was just the start for summer riding adventures. While there is a small percent that truly rides most days because a motorcycle is their main mode of transportation, summer time with the great weather everywhere brings out a lot of bikes on the road.

There are a plethora of motorcycle events everywhere and mostly it's a weekend thing. Also during the summer there are many establishments that have a "bike night" event that's usually on a weeknight, and many, many people are drawn to these events whether it's local or a major riding distance.

We all pretty much gear up and prepare for our weekend jaunts. Sometimes I'll put on about 100 miles of riding for the day, other times it's 200 plus miles, which is a whole day of riding including checking out a certain event. I consider that a great day. I don't brag about how many miles I racked up and a person boasting how far he or she has ridden doesn't interest me; just riding is good enough for me and I leave my ego at home!

Planning is the first stage of safety awareness! With the technology today we can plan a route in a matter of minutes. We will know where everything is and the exact mileage to get there. If you have memory issues you can have robot lady talk you to your riding destination. I remember the days where I would tape a drawn map to my gas tank so I wouldn't get lost and this is not a safe thing to do, thank God for GPS!

Have you ever missed an exit and or cut across three lanes of traffic to get to that exit, sometimes leaving your buds still riding on the freeway? I'm guilty of that one. I realized not every one is as daring as I was and this is why I think planning in advance is a safety thing.

Having the right mindset is equally important. If you don't feel good about riding that day, then don't. Riding with a negative mindset or a super high anxiety level is not good for you or anyone riding with you. After all there are still 364 other days before you. Fear is probably one of the worst things a rider can have. It can kill you and or maim you for life. It leads to freezing up while in a situation which requires you to use your skills and it leads to non-action! Or fear can make you over-react when regular action is all that is needed. Example: You are flying through a canyon and you realize instantly you can't make that turn, you grab your brake handle and stomp on your brake pedal frantically because you see yourself crashing. You've abandoned your skills in a split second when all you had to do was aggressively use your brakes to come to a complete stop.

What to do with fear? How do you overcome fear? Well it's not easy that's for sure. Turning fear into respect is the solution. We all have been doing this with many things in life, all our lives. The first thing is you have to understand and acknowledge that riding motorcycles is dangerous and that what you must do to survive it is understand



everything you can about it. Lack of education is easier to say than your ignorance is the catalyst of your fear. There are too many unknowns out there that could be in your face in an instant, i.e. a car turning in front of you, a major mechanical issue while riding, a large animal jumps in front of you while cruising in the mountains and so on. There are things you cannot practice to prevent you from having an accident but you can be fearless when things are out of your control. This is a hard thing to do especially if you've been down before, and it does take time to get back on your bike or?

One of the greatest things you can do is to get educated and practice and you must always get educated and practice and practice. I talked about practicing hard breaking, but that's just the beginning. Getting to know your bike is so important, the characteristics are different with every bike as well as the conditions you ride in. Have you practiced riding slow, I mean really slow with out putting your feet down? Try doing it without herky-jerky movements. It's funny seeing bikers do the duck walk because they can't balance their bikes at slow speeds. Try stopping going up a steep hill, then continuing up the hill. How many times will you pop your clutch? There are so many little things you can practice or try for the first time, and it's important!

You need to develop respect for yourself! For your abilities! When you do you'll be able to control your bike at all times and enjoy why you love to ride. Here are some stats that are true. I like sharing the truth even though it's disheartening at times, but it's real. This information is from NHTSA.

These statistics are for the year 2012 and 2011. I've researched other sites and they all have different numbers but are close to each other: 4,957 people died in motorcycle crashes, up 7.1 %, and 93,000 were injured. NHTSA includes passengers in these statistics as well as the driver of the motorcycles. There were approximately 8.5 million

motorcycles on the road in 2012, that equates to 55 out of a 100,000 registered motorcycles was involved in a fatal crash, versus 9 out of a 100,000 in car accidents. Fatalities among motorcyclist age 50 and older increased by 119 in 2012, an increase of 7.7%. Approximately 100,000 motorcycles were involved in crashes in 2011 including property only crashes. The average age for riders killed was 42. They also say in their report that older riders appear to sustain more serious injuries than younger riders. They also say declines in vision and reaction time along with the larger sized bikes that older riders favor, which tends to roll over more often, and increased fragility among old people as the causes, which I think is BS!!! The 60 and over group are two and a half times more likely to have serious injuries than the younger group (20-39) and the middle age group (40-59) and older group were also more likely to sustain fractures, dislocations, and other injuries than the younger group.

NHTSA says that in 2012, 27% of motorcycle riders involved in fatal crashes had a blood alcohol concentration over 0.08% (the national definition of drunk driving). Other vehicles were a combined 47%. They also said that 34% of motorcycle fatalities were because of speeding and 24% who were involved in fatal crashes were riding without a valid operating license.

Here is another interesting fact from NHTSA, during the weekday 2,600 motorcyclists were killed and on the weekend it was 2,345, the injured was 55,884 during the week, and 37,136 during the weekend. The highest numbers of deaths occur between 3-6 pm on the weekday and 6-9 pm during the weekend. The injuries are the same time as well. In 2011 the total fatality rate was 43,495 and injuries were 2,756,000 and property damage was 6,612,000, the grand total was 9,412,000 for 2011, for the motorcycle it is 100,000 and the percent rate is 1.1 percent.

These numbers are staggering for the mind and make me think about all of those who died. The reasons are many but the truth is that it's dangerous out there. In 1899 the total vehicle death was 26! Who'd ever think that we would, at these levels, accept these statistics? As the roads of America get even more congested with all kinds of vehicles I never think about the statistics and the fear of riding or driving. I am more interested in being as safe as possible, educating myself as much as possible and passing on information to the best of my ability. We have old laws and new laws that are supposed to keep us safe, but accidents happen. And then there are the ones who are irresponsible about what they do - drunks, stoners, racers, and now cell phone users, etc. Should we fear these people? We can't avoid them, they're everywhere. I used to be one of them. It didn't take me long to realize what I was doing and after seeing the real results, I changed my mind real fast. You all know and have experienced this or seen the results and tragedy it leaves behind.

Just remember education and practice reduces fear. If we are a true brotherhood, then you have the chance to pass on the information to all, including non-members. Maybe they'll get it and be a part of ABATE! Be fearless when you ride. Be smart when you ride. Have fun and enjoy the roads of America. And did I say Ride Safe? You bet!....norm



MOTORCYCLE BILL AIMS TO BRING EQUAL TREATMENT IN SOUTH CAROLINA: South Carolina Governor Nikki Haley recently signed a Motorcycle Equal Access Bill that mandates equal treatment toward motorcyclists across the state in all public areas.

This legislation, sponsored by Rep. Todd Atwater (R-Lexington), amends the Code of South Carolina to keep local law enforcement agencies from denying access to motorcyclists on public highways, bridges, parking garages and essentially any publicly funded areas.

A lot of local motorcycle groups supported this bill, many feeling that law enforcement has not treated them right for a long time and they say they're ready for a change. "There's few municipalities, in particular, that want to stop motorcycles from parking in publicly funded taxpayer areas," said one ABATE spokesperson. "If tax payers are paying for a garage, then they should not be allowed to tell us we can't park there."

Under the bill, cities and counties have to make reasonable accommodations for motorcycle parking in lots and garages.

"All this bill is about is equal access, this is making sure that when you go to any city in this state that if you have a motorcycle you have a place to park," said the governor who is also an ABATE member, adding; "As long as I have been in office, ABATE has been my friends, and that's because they fight for all the right things; they've always fought for safety, they've always fought for individual rights, they've always fought to make sure that people have the liberties they should have."

MISSOURI LIFTS BAN ON SUNDAY CYCLE SALES: Due to so-called "Blue Laws" influenced by early religious edicts, vehicle sales are prohibited on the Sabbath in several states, but Missouri recently joined a growing list of states that are repealing these outdated bans.

Governor Jay Nixon signed HB1735 on Monday, June 23rd that will lift a ban on Sunday sales of motorcycles, all-terrain vehicles, personal watercraft and other items typically sold by power-sports dealers.

The legislation was championed by motorcycle riders and at least one Harley-Davidson dealer from the Kansas City area, who told lawmakers that he was losing Sunday business to a competitor in Kansas.

When the measure takes effect August 28, Missouri will join Indiana, Pennsylvania, New Jersey, New York and Maryland in removing their Sunday sales bans over the past few years.

Other states that currently prohibit the Sunday sales of motorcycles and automobiles are Colorado, Illinois, Iowa, Louisiana, Maine, Minnesota, Oklahoma, North Dakota and Wisconsin.

The Missouri legislation does not repeal the state's ban on Sunday sales of cars and trucks.

UTAH LAWMAKERS URGED TO "GET AHEAD" OF OUTLAW BIKERS: A perceived proliferation of outlaw motorcycle "gangs" in Utah has led a veteran police officer to warn lawmakers that they need to get ahead of the curve.

"There's been a 300 percent increase in the members of outlaw motorcycle gangs in Utah, compared to what we experienced five years ago," Utah County Sheriff's Sgt. Lane Critser told members of the Legislature's Law Enforcement and Criminal Justice Interim Committee on Wednesday, July 16.

Critser, who has worked in gang enforcement since 2008, said the proliferation of gangs and gang members could be attributed to multiple factors. Utah is an "untouched" state, meaning no gang has claimed territory as its own. Also, law enforcement in Utah is unaccustomed to dealing with outlaw motorcycle gangs on a regular basis, he said.

"It's like a gold rush. Everybody is trying to get here and establish dominance in the state so they can run a variety of their criminal activities and make their money in the state," Critser testified to the committee.

The state also is becoming increasingly attractive to members of outlaw motorcycle clubs because Utah is largely rural, said Rep. Paul Ray (R-Clearfield), pointing out that a number of clubs have hosted runs in Utah, including one where several members racked up citations for multiple violations in numerous counties en route to Weber County, and "By the time they got there, they just



turned around and went home. They didn't want to deal with it any more," Ray said. "Really, you've got to make it expensive and uncomfortable for these guys and they won't want to stick around."

While he offered no details, Ray said he intends to introduce a gang initiative during the 2015 legislative session.

BERLIN BANS HELLS ANGELS LOGO: Outlawing the motorcycle club's symbols represents the latest weapon in a fight to stop Germany's 'rocker wars.' In the latest salvo of a battle to rein in outlaw motorcycle clubs, authorities in Berlin are hitting the global Hells Angels brand where it hurts most: the logo.

Last month, the signature winged death's head and "Hells Angels" label featured on the motorcycle club's "cut," or leather vest, were banned in the capital as the symbols of a criminal organization.

According to GlobalPost, a Hamburg judge outlawed Germany's first Hells Angels charter in the city in 1983, but the Hells Angels as an organization have never before been banned across Germany. Now the prohibition of the iconic logo has come about through an ironic twist.

When a former member of the banned Hamburg charter appealed to the court in April to be allowed to wear the club's "colors," the judge interpreted the original ruling to mean that the Hells Angels logo is illegal not only in Hamburg, but throughout the country.

"Now, all the other regions in Germany are thinking about that judgment," said detective superintendent Matthias Frohn, deputy head of the Berlin police division responsible for curtailing the city's motorcycle gangs. Frohn says it remains to be seen whether the broader ban on the club's logo will be enough to finally scatter the gang.

MONGOLS REFUSED INCORPORATION: The Mongols Motorcycle Club has been formally refused permission to become a registered incorporated body in South Australia. Despite claims by the club that it hosts recreational and charity events and that it was only formed because of its members' interests in American motorcycles, Acting Liquor Licensing Commissioner Dini Soulio has refused their application.

Senior legal sources told the Herald-Sun newspaper that they believe the Mongols' move was largely tactical and aimed at thwarting the provisions of the Serious and Organized Crime (Control) Act should police obtain association or control orders against any members in the future.

SA Attorney-General John Rau has endorsed the decision, made on public safety grounds, to reject the Mongols' incorporation application.

A Mongols source said the club was considering a legal challenge to the ruling "in the same successful way as two previous legal challenges" involving anti-bikie legislation.

NCOM Region 1 comprises the states of Alaska, California, Hawaii, Idaho, Oregon and Washington, and this annual Coming Together will feature a seminar on the Defender Program & Freedom of the Road Throughout the Nation talk by Paul Landers, U.S. Defender Lt Commander and Liaison for COCs Texas; "Profiling the Big Win in Washington" by "Double D" & Twitch - Outsiders M/C, Washington State COC; and a seminar on Legal Issues by Washington Aid to Injured Motorcyclists (A.I.M.) Attorney Marty Fox and Oregon A.I.M. Attorney Sam Hochberg.

A Regional Meeting will include discussions from participating state organizations, and continue with a Con-

federation of Clubs Meeting with reports from representatives of each Confederation present, and conclude with a Christian Unity Seminar and Meeting.

SAVE THE PATCH (Excerpted), by Spike: The familiar rumble and roar of a pack of bikes, which is music to our ears, may be a faintly distant tune in the future. The loudest noise on the streets right now is the buzz and the buzz on the streets is "SAVE THE PATCH".

'SAVE THE PATCH' is the culmination of many factors including decades of ever increasing discrimination and persecution to Bikers, their organizations and their lifestyle in general. We as bikers have widely been subjected to unwarranted highway stops, refused admittance into establishments and misrepresentation by law enforcement and the media. The U.S. Department of Justice last year filed a lawsuit seeking to seize control of the trademarked logo of the Mongol Nation Motorcycle Club LLC, arguing that the Mongols are a criminal organization and that the mark is used for intimidation; but the Mongols and their attorneys argue that the government is overstepping its bounds with the lawsuit, which they said would infringe on the rights of club members. "They're trying to destroy the right of men to associate and indicate their association," said Joe Yanny, an attorney representing the Mongols. "It's absolutely ridiculous. In addition to being a violation of club members' free-speech rights, more importantly, it's a due-process issue."

The lawsuit breaks new ground in terms of trademark law, the attorney said, adding that it may end up at the Supreme Court. Unlike a business trademark controlled by a single entity, the Mongols' logo is a "collective membership mark," and "It's legally owned by one entity, but held in trust for the members. It's the votes of club members that ultimately determined who is allowed to wear the club's patch."

Bikers throughout the state and nationwide identify with the message being sent out and the ramifications, if the patch is lost, it will affect us all. In southern California, widely respected members of all major clubs have met to discuss ways to save the patch. A Facebook page "SAVE the PATCH" has been set up since October and it states: "It has become time to further protect and defend our rights to ride, associate, and enjoy our lifestyle for all motorcycle riders and enthusiasts. To wear our respective clubs membership insignia, which have been trademarked, copyrighted, and incorporated by these organized entities. Representatives from a few of these clubs in Southern California have come together to make the initial steps in presenting and organizing the support of all motorcycle clubs and riders to stand up and work to prevent the freedoms we all value and enjoy from being eroded further, by an ever more intrusive government apparently bent on tyrannical control, we all need to become involved and work to defend that which we all enjoy about our lifestyle, be it as a club member or independent riders."

The good news is, the passion to ride, the passion for freedom and the passion to preserve the life style is more than enough to unite the Biker world in whatever stance it takes to SAVE THE PATCH. WEIRD NEWS: WHAT'S A "BIKER"?: Do you identify yourself as a "biker," a "motorcyclist," or a "rider"? To some motorcycle riders, the terms are fairly interchangeable. To others, the terms are more finely nuanced, as the people behind the Oxford English Dictionary recently discovered.

Last February, the online edition for the Oxford English Dictionary rewrote its definition for "biker" after receiving complaints from motorcyclists. Riders took exception to the old definition which read: "a motorcyclist, especially one who is a member of a gang: a long-haired biker in dirty denims."

In a poll of 524 motorcycle riders, nearly three-quarters of them said the definition was inaccurate, while 60% said it was "dated and irrelevant." Another 21% had a more passionate reaction, saying they were "outraged and offended."

In response, the Oxford University Press, which publishes the OED, updated the definition to read: "a motorcyclist, especially one who is a member of a gang or group: a biker was involved in a collision with a car."

We're not sure that's much better, but then we don't represent ourselves to be the "most comprehensive dictionary of the English language."



Tech Tips by Craig Griswold

Charging System

One of the easiest systems to troubleshoot on your bike is the charging system. You would be amazed with what can be diagnosed using nothing more than a simple multimeter. A basic digital meter will set you back less than a hundred bucks and unlike the old analog meters (remember the old Simpson?) that required setting the proper operating range lest you blow the thing to pieces, digital meters are auto ranging and super user friendly. Set the function and start measuring.

How do you check the charging system? Grab that user friendly, relatively low cost meter and set it to **DC voltage**. The symbols for voltage will be a "V" with either a sign wave (AC or Alternating Current) or a "V" with a set of parallel lines (DC or Direct Current). Higher end meters may have a push button to select AC or DC (see photo 1).



Place the leads across the battery terminals and note the reading. A fully charged battery should read 12.8 VDC, but may be lower depending on state of charge and the aforementioned charging system. Either way, this is your static reading. Now start the bike and take a reading. If the reading is the same with the bike running, the charging system is out to lunch. Bring the RPM's up to around 2000 and see if there is any change. Even at idle there should be an increase, but the specification is always for 2000 RPM. The reading should be between 13.5 and 15 VDC. It's that easy. In the time it takes you to pull your seat off and fire up the meter, then poke the battery, you now know whether or not your charging system is doing its job. Since you already checked the terminals to make sure they're tight (watch the wrench when you're monkeying around with the positive; if you touch it to the frame or anything else that's grounded, sparks are flying.....more on that in a bit), where do we go from here?

It's safe to say that the vast majority of charging system failures are a bum stator. You're bike (unless it's a '69 or older HD) has an alternator that is made up of two components. A magnet that rotates (the rotor) around a fixed coil of wire (the stator). Most folks want to go for the easiest thing to get to which is the voltage regulator. It's very tempting since its just hanging out there in the open, two fasteners and off it goes. Before you waste a hundred bucks on a regulator, grab your meter, set it to resistance (symbol is the Omega or horseshoe looking thing) and do a quick check on the stator. First, place one probe on either of the pins (or sockets) from the stator, and the other to the engine case (polarity makes no difference, see photo 2).



It should read open or zero continuity. If not, the stator is grounded. Now place both probes on the stator pins. It should read close to zero ohms. If the resistance is off the charts (like in the millions of ohms or open) the stator has a break in the coil. If these check out ok, then set the meter to **AC voltage** and with the bike running, measure the voltage output of your stator by placing the probes on both pins/sockets (see photo 3).



It should be around 16- 20 VAC. Increase RPM and you should see a gain of about 10-20 VAC per 1000 RPM. If not, there could be an issue with the rotor. Although not as common, rotors do have the occasional failure. Magnets can come apart, splines can strip. Take a peek and rule it out.

If the stator and rotor checks out, THEN go to the voltage regulator. There really is no way to test the regulator. The idea is to check everything around it, and if all else is good, well...it must be the regulator. One last thing before you run to the shop and buy a new one. Make sure the ground is good. Earlier voltage regulators grounded through the body directly to the frame. Newer bikes have a ground wire.

In almost all cases (there are exceptions) when the stator (rotors can fail too, but it's not as common) goes south, the charging system fails to charge. When the regulator goes bad, the system will overcharge. Not always! Just in most cases. As a side note, one can see why the stators would die after a while. They're in a pretty harsh environment baking in a hot primary and pretty much parked right up against a hot engine case. More times than not the insulation on the wires just gets old and brittle and eventually shorts to something metal, which is usually the engine case (photo 4).



Getting back to that remark on the battery; when disconnecting the battery cables always disconnect the negative terminal first. That's your ground to the frame and all things attached. With the negative out of the picture, you can accidentally touch your wrench or screwdriver to metal while disconnecting the positive and nothing's going to happen. No sparks, no welding a wrench to the palm of your hand, no bad words, you get the picture. As the famous instructions always say "assemble in reverse order" Positive first, negative last.

Recently the off-road community was caught totally off guard by the passage of Assembly Bill 1595 that severely impacts the ability to modify and use "upgraded" off-highway side-by-side vehicles.

AB 1595 prohibits the use of (approved/sanctioned racing style) seat belt harnesses, prohibits the addition of full roll cages, and requires mandatory helmet use in these and ONLY these vehicles.

Portions of this law go into effect on January 1, 2013 and all parts of the law will be enforced on July 1, 2013. AB 1595 will have an immediate and very negative impact on side-by-side safety and prevent the use of many of these family recreational vehicles that have been upgraded with additional safety equipment.
