Lobbyist's Report



What a **GREAT RALLY** in Sacramento on May 6th — **OVER** 500 bikers showed up to celebrate *May Is Motorcycle Awareness Month* on the East Steps of the Capitol, just outside Governor Brown's office. We had lots of great and inspirational speakers led by fellow rider, Senate Republican Leader Bob Huff, the author of SCR 41 which declares May as Motorcycle Awareness Month.

Fellow co-authors and riders also addressed our crowd. Speakers Senator Jean Fuller from Bakersfield and Assemblyman Brian Jones from San Diego were also resolution co-authors. Other speakers were the Vice Chairman of the Assembly Transportation Committee, Eric Linder, Assemblyman Tim Donnelly from Hesperia, who represents ABATE's headquarters. He also arranged for our podium and his office's American flag to be displayed on the Capitol steps for our rally.

Other speakers were Tom Lubbers, Chairman of ABATE's Board of Directors, Greg Covell, our Executive Director, Ron Givens on behalf of the MMA and myself!

SB 350, the lane sharing bill by Senator Jim Beall has officially become a two year bill and cannot be taken up until next session in 2014. I will be reporting in the *Bailing Wire* of any changes, or proposed changes, to it so stay tuned.



Our two side by side, or Recreational Off Highway Vehicle (ROHV), bills that grandfather in aftermarket seating for pre-2014 models, and allow handholds for occupants in ROHVs are included in not one, but two, bills that are moving through the Legislature. AB 64, by Assemblyman Donnelly, is on the Assembly floor having already passed out of the Transportation and Appropriations Committees. SB 234 by Senator Mimi Walters which also permanently grandfathers in side by side pre-2014 model year non-stock seating, and makes occupant handholds available for legal riding in ROHVs by children has passed the Senate and is awaiting action in the Assembly Transportation Committee. Both are emergency bills which take place immediately upon

Executive Director's Report

Greetings: Last month I had the opportunity to go to the NCOM (National Coalition of Motorcyclists) meeting in Reno. Quite impressive. Nowhere else can you meet and talk to so many people from all over the USA that are involved in the political and legal issues confronting motorcyclists. Issues covered profiling, no colors bars, helmet laws, lane sharing, women in motorcycling and sport bike issues. I was able to speak with riders from Texas to Washington, Arizona to New York and Maryland, Florida to Michigan. Not to my surprise many in attendance were members of a diverse litany of motorcycle clubs, riders clubs, MROs (Motorcycle Rights Organizations) and SMROs (State Motorcycle Rights Organizations). From my stand point the many state ABATEs were generously represented and supported.

Over and over I was reminded that the COCs (Confederation of Clubs) and ABATE need to be working together more in the political arena. "We must hang together or we will surely hang separately". Some of our smaller states are making great headway in this effort. Unfortunately in California due to our size, population and directional confusion, working together is still a work in progress, I hear time and again that the past is the past and we must look to the future – easy to say but,



hard to do.

Change is always difficult and requires open minded leaders to make the move and take the first steps toward a "meeting of minds" here in California. With seven COCs, hundreds of M/Cs (Motorcycle Clubs), multiple MROs, uncounted R/Cs (Rider Clubs), and thousands of associations and independent riders, perhaps this "California Meeting of Minds" could become a reality. It could address the issues specific to our state to educate and inform all riders in California and to formulate a coordinated path toward solutions all can get behind and support. Just an idea to consider. "Complacency and apathy is easy and comfortable, but in the long run the cost of doing nothing is fatal." I am ABATE of California - are you? Keep Your Eyes Wide Open.



The Executive Director also spoke of eliminating the Regional Director's positions due to lack of communication from most of the R.D's. Whether that's a done deal - or not? Maybe you should attend the July Board meeting to find out.

The Northern Regional Rally that was to take place in August had to be cancelled for two reasons: 1. There were not enough pre-registrations received to even pay for the campground and 2. The Run Chairman, Bob Blatz, who is also an ABATE Board member, said he would be moving out of California in a couple of weeks. So ABATE lost a Board Member.

Bob was also a Regional Director, had served as the Local 15 President and Bob wrote the California reports that would be sent to the Motorcycle Riders Foundation to be printed in their bi-monthly magazine.

Then in this issue of the Bailing Wire ABATE's Safety Officer, Steve Guderian, who is also a Board Member, has resigned from both of those positions.

It was also learned that long time (21 years!) Member, Scott McCool from Ventura Local 13 and who served as Local 13's President for a lot of those years too, would be moving out of state. There is someone stepping up to be President of Local 13.

We would like to thank Bob Blatz and Steve Guderian and Scott, too, for all that they have done and tried to do for ABATE. As you can see, some wore a lot of "hats" to strengthen ABATE.


We are going to need someone to be the ABATE State Safety Officer, to submit articles for the Bailing Wire and there are some additional requirements of a Safety Officer. Contact a Board member IF you are interested.

As for losing two Board Members: Ed Mathis aka "Iceman" would be the alternate for replacing Bob if Ed agrees to it. The Board, of course, needs to do the motion and acceptance to be "proper". Why Did ABATE of California Start an Off-Road Division?

Recently I was asked why ABATE of California would want to start an Off-Road division and basically what is the correlation between the two forms of motorcycling. My first thought was that it seems very obvious that both are one and the same as ABATE is supposed to protect the rights of ALL motorcyclists. But then I thought to myself, well, a lot of our ABATE locals are in areas that simply do not support Off-Roading so they may not see the correlation or the potential to help our organization grow. What I have done here is try to put together a piece that will hopefully answer a lot of questions.

Recently, Assemblyman Paul Cook (now Congressman) decided to reincarnate Dick Floyd by using a "gut and amend" bill to sneak in under the radar AB 1595 that mandated that all drivers and passengers of Side X Sides would be required to wear helmets and also, they would be severely restricted from modifying their rides. If that sounds familiar, it should, because Dick Floyd also passed a helmet law on us that is still in place to this day. Other freedom hating politicians have been trying to limit our rights to modify our rides.

Having lived in a big Off-Roading area for the past 40 years, I knew immediately that Off-Roaders were going to need some help with this. But many on road riders did not even know what a Side X Side was. A Side X Side is really the next step from a two wheeled off-road motorcycle for people that are aging or have had surgeries or other issues that still want to enjoy the wind in their face and the great outdoors in the same manner as a lot of us "On-Roaders" that have switched from two wheels to trikes. Although I am using Side X Sides for this article, the same concerns are shared by the hundreds of thousands of two wheeled Off-Road bikes.



Remember, the purpose of our fight is not what type of motorcycle you ride, it is about the FREEDOM to ride, dress yourself, and modify your ride without being hassled. I have also shown a "starter" motorcycle with training wheels! It is Off-Road where most children first learn to ride. Of course we want to attract the kids while they are young to teach them the right way to ride and fight for their rights.

I have pictured a stock 2008 Yamaha Rhino Side X Side here and my 2008 Rhino that has been modified with many of the common sense safety features that many Off-Roaders have done to their Side X Sides.



Some of these features include full length stronger roll cages, reinforced steel roofs, strategic grab bars, spare tire holders, etc.

The issues facing Off-Roaders and On-Roaders are really one and the same. Freedom to ride a ride that is set up to our own personal taste, freedom to ride where we want to without being hassled and the freedom to dress ourselves for that ride.

Speaking of riding where we want to. An issue recently came up when I was pulled

over by two truckloads of gun packing San Bernardino County Code Enforcement Agents. They informed me of where I could or could not ride and how many people I could have in my staging area! It seems that they do not want large groups of Off-Road vehicles in one area without a permit! Sound familiar? It seems that the powers that be do not allow us to ride in certain areas. The entire city of Hesperia is off limits to off-roaders!



The areas that Off-Roaders are "allowed" to ride can be very confusing as shown in this picture that is halfway between Barstow and Victorville.

So how many new members can we potentially get from an Off-Road division? The answer is to go out on any given weekend and see the families gathered for a weekend of Off-Roading as in this picture! Imagine the possibilities for ABATE if we had even a percentage of the over 1 million Off-Roaders in California as members!



Do legislators care about Off-Road issues? Here is a picture of Senator Jean Fuller with my wife and I. Senator Fuller used to ride street and now has a Rhino of her own! She shares the love of Off-Roading with many other legislators and her staff. She has had her staff working with me on chipping away at Paul Cook's AB 1595. She wrote SB 334 that would delay implementation of AB 1595 until 2015 to give us time to write a bill that would eliminate Paul Cook's insanity. The answer is YES, legislators want to help

us with this battle. Right now Senator Mimi Walters' bill – SB 234 – that will once again allow modifications to Side X Sides has cleared both the Senate and the Assembly unanimously! There is no opposition in either house from either side of the aisle! With bi-partisan support in both houses, the possibilities are endless!

Space limitations forbid me from listing every reason for this venture, but more details can be seen on website presentations that I created that many legislators have looked at and used to make more informed decisions. (These are case sensitive files) I have also included a link that shows law enforcement banging an Off-Roader's head against the ground. http://www.examiner.com/article/video-shows-yucca-valley-sheriff-s-captain-allegedly-using-excessive-force?cid=db_articles For many years, On-Road riders had their heads slammed onto the hoods of patrol cars, etc. Although I have not heard of this happening for some time, it is not to say it doesn't, and this is just another parallel that On-Roaders share with Off-Roaders.

In conclusion, it all boils down to the fact that Off-Roaders share the same concerns as On-Roaders. If we all join

together, there can be no stopping us. If we all stand divided, we will all fail. Locals that are unfamiliar with Off-Road issues can have one or more of the millions of Off-Roaders attend your meeting and share their concerns. Enlist them and create an "Off-Road Rep" as an officer position to educate and keep your members informed while simultaneously keeping them apprised of On-Road issues.

But if we all work together, we can make this happen and make ABATE a powerhouse of people that truly represents ALL motorcycling interests!

COAST TO COAST BIKER NEWS

NCOM CONVENTION HITS JACKPOT

IN RENO: Freedom is an ongoing gamble, with bikers' rights activists wagering to win against an often stacked deck, always in favor of the House, but everyone came away a winner at this year's 28th annual NCOM Convention over Mother's Day weekend, May 9-12, 2013 at the posh Silver Legacy Resort-Casino in Reno, Nevada.


But it was work, not play, on the agenda for hundreds of attendees from across the country there to discuss topics of concern to all riders; such as biker profiling and discrimination, motorcycle-only roadblocks, knowing your rights, and mobilizing motorcyclists to advocate motorcycle-friendly legislation and defeat anti-biking bills.

The traditional "Ringing of the Bell" ceremony paid homage to those freedom fighters who have gone before us, while for the first time a Veterans' Rights seminar was conducted by NCOM's newly-formed Veteran Affairs Special Committee in an effort to reach out to true defenders of Freedom.

The National Coalition of Motorcyclists (NCOM) is solely sponsored by the Aid to Injured Motorcyclists (AIM) nationwide legal services program and serves as an umbrella organization for more than 2,000 NCOM Member clubs, organizations and associations worldwide, representing well over a quarter of a million politically active motorcyclists. NCOM has successfully outreached to numerous segments of the motorcycling community in an effort to unite for our rights, both legal and legislatively, and has become a unifying voice amongst North America's motorcycle rights organizations (MROs), motorcycle clubs, women riders, religious riding organizations, touring groups, trikers, sportbikers, and minority motorcyclists.

This year's NCOM Convention was hosted by the Northern Nevada Confederation of Clubs, and all motorcyclists were welcomed and encouraged to participate in the many meetings, seminars and group discussions that focused on legislative efforts and litigation techniques to protect our riders' rights and preserve Freedom of the Road.

During the Silver Spoke Awards Banquet on Saturday evening, several honorees were recognized for their contributions to "Improving The Image of Motorcycling", including; **GOVERNMENT:** Wisconsin Governor Scott Walker; **MEDIA:** Becky Cakes – Classic Parts Hotline; **COMMERCE:** Chris McIntyre – Eagle Rider Motorcycle Rentals; **LEGAL:** Boyd Spencer – AIM Attorney for



Pennsylvania & New Jersey; **ENTERTAINMENT:** Max "Pitstop" Martini – Actor/Boozefighters MC; **SPECIAL RECOGNITION:** Christine Paige – Sturgis Motorcycle Museum & Hall of Fame, and Suzanne "Baglady Sue" Austin – Comedian; and NCOM's highest honor, the Ron Roloff Lifetime Achievement Award, was presented to Frank Ernst of ABATE of Minnesota and a member of the NCOM Board of Directors.

"STOP MOTORCYCLE CHECKPOINT FUNDING ACT" INTRODUCED IN CONGRESS: Congressman Jim Sensenbrenner (R-WI) has introduced "a bill to prohibit the U.S. Department of Transportation (DOT) from providing funds to state and local authorities for the purpose of creating motorcycle only checkpoints."

Filed on May 7, the Stop Motorcycle Checkpoint Funding Act, H.R. 1861, "also contains language to force the DOT to focus motorcycle safety efforts on crash prevention programs, not national helmet mandates," according to Rep. Sensenbrenner. "This will stop the DOT from manipulating State policies with federal money."

Contact your federal representatives and request they support H.R. 1861, and that they sign on as a co-sponsor of Sensenbrenner's bill. You can call members of Congress through the Capitol Switchboard at (202) 224-3121.

NTSB RECOMMENDS LOWERING DRUNK-DRIVING LIMIT TO 0.05:

The National Transportation Safety Board has issued a recommendation that states lower their drunk-driving thresholds from a 0.08 blood-alcohol content to 0.05 BAC. The recommendation is one of several the NTSB made to curtail drunk driving, which the federal investigative agency claims is involved in a third of America's 34,000 traffic deaths each year. The agency acknowledged in its report there is no one "silver bullet," but estimated that 500 to 800 lives per year could be saved with the proposed lower limit.

Chairman Deborah Hersman admitted the NTSB is aiming even higher; "Reaching zero deaths from alcohol-impaired driving."

Not everyone agrees. "This recommendation is ludicrous," said Sarah Longwell, managing director of the American Beverage Institute. "Moving from 0.08 to 0.05 would criminalize perfectly responsible behavior."

Currently, all 50 states have set a BAC level of 0.08, though most countries in Europe including Russia, most of South America and Australia, have set BAC levels at 0.05 to constitute drunken driving.

The NTSB only makes recommendations on transportation safety issues, and has little actual regulatory power. It will be up to federal agencies, Congress and state lawmakers to take action. The last move from 0.10 to 0.08 BAC levels took 21 years for each state to implement.

WEATHER & ECONOMY DRIVE UP TRAFFIC FATALITIES:

For the first time in nearly a decade, the number of traffic deaths went up last year according to the National Highway Traffic Safety Administration (NHTSA), which cited warmer weather and an improving economy for the 5.3% increase in fatalities to 34,080, the highest since 2008.

The rise follows a steady decline in fatal accidents since 2005 when 43,510 people died, culminating in a 60-year-low of 32,367 in 2011, but NHTSA Administrator David Strickland said, "With a rebounding economy there's increased discretionary driving, which is clearly always the leader in terms of dangerous driving scenarios."

U.S. motorcyclist deaths outpaced the overall national numbers with a projected 9% more fatalities in 2012, up to more than 5,000, and in addition to climatic and economic factors the agency also blames a long-term decline in helmet laws with only 19 states requiring usage, down from 26 states in 1997.

"The most notable thing was the warm weather," said Dr. James Hedlund, a former NHTSA official and the author of the report by the Governors Highway Safety Association, as thirty-four states east of the Rocky Mountains notched record average temperatures from March to May 2012, and forty-eight states recorded their warmest average temperatures on record.

The report also cited two economic factors that may have contributed to an increase in the number of miles traveled via motorcycle in 2012 and thus a higher probability of accidents: a better economy and high gas prices. "An improving economy produces more discretionary income with which to buy and ride motorcycles," said the study. Several states reported an increase in the number of registrations in 2012, and Hedlund has found that over the past three decades, the number of registrations tracks closely with the number of deaths.

GHSA's recommendations for cutting motorcyclist deaths include reducing alcohol impairment, reducing speeding, increasing driver awareness, and ensuring that motorcyclists are licensed. According to GHSA, NHTSA data shows that in 2010, nearly a quarter of riders involved in fatal accidents did not have valid licenses.

CONNECTICUT RIDERS DECRY PROPOSAL TO REGULATE EXHAUST SYSTEMS: An unexpected effort in the General Assembly to crack down on noisy motorcycles is being met by opposition from the motorcycle industry. Under language added last week to a bill involving off-road ATVs, the sale, registration or operation of a street motorcycle having non-stock pipes would become a fineable offense. Most after-market exhaust systems are not EPA-certified.

The new provisions, if approved, would require federal Environmental Protection Agency noise emission control labels to be displayed on all motorcycles, and would institute fines of up to \$250 per offense for non-compliance.

OHIO LAWMAKERS CALL FOR BAN ON TRAFFIC CAMERAS: Following a biting ruling by a judge who called traffic cameras a scam, legislation was introduced on

February 20th in Columbus, Ohio by Representative Ron Maag (R-Lebanon) to eliminate the use of photo monitoring devices to detect speed and traffic signal violations. He and Rep. Dale Mallory (D-Cincinnati), one of many bipartisan co-sponsors, believe the removal of "speed-trap" cameras is necessary and must be addressed immediately since there is no existing state law regulating traffic enforcement cameras, so communities operate their programs under local ordinances.

Their hard-line stance against the cameras comes on the heels of Hamilton County Common Pleas Court Judge Robert Ruehlman's permanent injunction, which prohibits the further use of speed cameras in Elmwood Place, a Cincinnati suburb. Ruehlman granted the injunction citing there was a lack of due process for alleged violators.

Judge Ruehlman's decision was unequivocal. He made national news headlines when he called the speed camera system in Elmwood Place "a high-tech game of Three-card Monty.... It is a scam the motorist cannot win." Between the camera enforcement, the lack of proper signage, and the fees for administrative hearings, Ruehlman declared that the town of Elmwood Place had violated drivers' due-process rights, and may be the first case in the U.S. that specifically addresses the constitutionality of traffic cams.

In Ohio, there are at least 16 municipalities that use some kind of red light or speed camera, according to the Insurance Institute for Highway Safety. In the United States, there are more than 650 municipalities operating either red-light or speed cameras.

Nine states have passed laws prohibiting the use of red-light cameras, and 12 outlaw speed cameras, according to the Governors Highway Safety Association, while 29 states have no law on the books. Some Ohio legislators hope to make the Buckeye State the Lucky 13th state, and House Bill 69 has been assigned to the House's Transportation, Public Safety and Homeland Security Committee for further discussion and vote.

POKER RUN LEGALIZATION BILL IN ILLINOIS: Companion bills SB 1960 and HB 2520; the "Poker Run Act," have been introduced in Illinois to legalize poker runs for the charities that bikers do and for Not For

Profit organizations.

"No segment in our society raises more money for charities and local citizens that are down and out on their luck than bikers," said Bob Myers, State Legislative Coordinator for ABATE of Illinois, who went on to explain; "Since 'Land Based Gaming' has become law, the Illinois liquor and Gaming agents have been tearing down our fliers in restaurants and bars claiming they are illegal as they use poker cards, spinners, dice, and marble spinners to complete the run."

ABATE intends to use the legislation to correct problems with "poker" runs and other events that the Gaming commission and Liquor Control Board are treating as gambling. Poker runs shall include "dice runs", "marble runs" or other events where the object is to build or obtain some matter of a score with which the participants use in a competition. Poker runs shall not constitute a game of chance under the Illinois Gaming Act or Liquor controls Act and shall not be regulated under those Acts.

THREE-WHEELERS MAY BE EXEMPTED FROM LOUISIANA HELMET LAW: Louisiana was the most recent state to (re)impose a mandatory helmet law for all motorcyclists back in 2004, but the House Transportation committee recently advanced legislation that would exempt a new concept vehicle from the legal category that requires drivers to wear helmets.

HB 218's exemption would apply to the three-wheeled Elio Motors vehicle, which is preparing for production at the Shreveport plant that once made pickups for General Motors. Because the Elio has three wheels, it's considered a motorcycle under federal and state safety regulations.

"It definitely affects our sales because a lot of people don't want to order the car if it requires wearing helmets," said Joel Sheltrown, vice president for governmental affairs at Elio Motors, adding that "We're not bound by automotive standards, but that is our goal."





SAFETY ARTICLE

Take Me To Your Leader

(There is an important announcement coming right after I cover this topic.)

“In order to make the right decisions, motorcycle riders need the right information”

So, here is a really important question for everyone to think about: Who is the leader in motorcycle rider safety? Or asked another way, who is the leader in looking out for motorcycle riders?

For me, a leader in motorcycles is the place or person any rider, well, any person for that matter, can go to in order to get any information they want about motorcycling. It is also the place where any rider or other person can go to voice or talk about any concerns, issues or problems and expect a reasonable answer in a reasonable amount of time.

So, I ask you again, who is the leader in motorcycling here in California? If you know the answer to this question, would you please email it to me, because I don't know who it is and I really would like to.

Some of you may be wondering why this is important; I will give you a couple of reasons. First, if you were to do a search on it, you would be directed to the California Motorcycle Safety Program (CMSP) website for rider training in California. In fact the top sites all have to do with the CMSP. But, isn't "California Motorcycle Safety" a bit bigger than just rider training in California? I believe so, but let's continue on. When you look at the training associated with CMSP you see that the only training listed is that which is done by the Motorcycle Safety Foundation (MSF). Specifically, the only motorcycle rider training list is the training done by the MSF.

I know for a fact that there is some outstanding advanced rider training offered in CA. I also know that there are many who believe that advanced rider training creates a better and safer rider. So here are two valid questions that need answers; why isn't any other training listed on the CMSP



rider training site, and why isn't somebody looking into the benefits of secondary or advanced rider training? It seems to me that a leader would be involved with providing reasonable answers to these questions for motorcycle riders in CA. If the CMSP rider training site is for all riders in the state, then shouldn't all riders have the opportunity to learn about other available rider training? What good is it for any rider trying to learn about "California Motorcycle Safety" to only get information about training from a single source of rider training? These are not only important questions; they are valid questions to ask, so how do we get an answer? Maybe if we had a leader.

The second thing is a pretty big one. Today is May 15, 2013 and May is Motorcycle Safety Awareness month. CA has the most registered motorcycles in the nation and is always in the top 3 states of rider fatalities. This is the month for state motorcycle safety people and agencies to try and make a difference for riders in this state. So, what have all of you seen so far? Anything? Anywhere? Myself and a couple of friends are keeping track of what is going on. So far we have seen the "move over for workers" message on the message board, and less than 5 press announcements. So, as of right now in motorcycle rider safety awareness month we have 14 days of nothing; virtually no press coverage and empty message boards. Maybe the big push is coming at the end of the month. But, since the entire month of May is Motorcycle Safety Awareness, it seems to me that a little something at the beginning of the month might be a bit more effective?

Again I ask, "Take Me To Your Motorcycle Leader!"

As for the announcement, this safety piece will be my last one because with this safety piece my resignation from the ABATE Board of Directors and as the ABATE Safety officer will be effective. Without going into a lot of detail, I am going to help out some other riders looking to form a motorcyclist action group and it is not fair to ABATE and its members for me to split my attention.

Although I will be away from ABATE of CA I am not gone and I will always be around to help out any rider, any time with any safety issue or question. My email address will be the same it has always been.

I wrote of many things, probably in too many words, over the months for ABATE on rider safety. What I would like to leave everyone with is a few things I look at as concepts for rider safety:

1. In order to make the right decisions, motorcycle riders need the right information.
2. The most basic fundamental right of all motorcyclists is the right to the safest riding environment possible.
3. Motorcyclists have the right to contact the state agencies and representatives responsible for motorcycle rider safety, and they have the right to a reasonable and timely answer.
4. Motorcycle rider safety is every ones responsibility.
5. Always question anything anybody tells you is the best or safest way to ride or do something on a motorcycle. Make them prove what they are saying is right with facts, not just words.
6. Riding rules are never absolute and will not universally apply to all riding environments. Let where you are riding tell you how you should ride. Don't change the riding environment to fit the rule, let the environment tell you the best form of a riding rule.

I would like to wish all of ABATE of CA members good luck, safe riding and safe journeys where ever they may be. It has been a pleasure to be part of this great organization and to have had the opportunity to work with all of its members.

TECH TIPS

The Great Oil Debate (Part I)

Few things generate more debate in the automotive/motorcycle world than the subject of oil. In this series, we'll clear up some of the bad information floating around, break down oil in technical terms, and talk about maintenance.

Many moons ago, oil selection with regards to quality, varied greatly. Anything from real cheap non-detergent oil to the more expensive synthetics and everything in between made selection a little more complicated. These days, there's no shortage of choices, but most name brand oils are of excellent quality. As long as you are using the right oil for the application, you'll be in good shape.

Let's start by clarifying some of the "facts" and "rumors". First, there's the synthetic vs. fossil oil argument. Here's my



take: Synthetic is superior, hands down. It's also twice the cost, give or take. So is it worth the extra cost for the better oil? I tell folks that if they follow their recommended factory drain intervals, and ride in mostly average riding conditions (mainly speaking to extreme temperatures), a good fossil oil will do just fine. Have a tendency to overshoot that 5,000 mile service? Live in Phoenix? Wrestling with heat management issues like so many new Harley Twin Cam owners (thanks EPA)? Try switching to a synthetic. In most cases, synthetic will drop your oil temps 10-15 degrees. If you're not on a real tight budget and just want to run the top of the line stuff, that's OK too.

There are many to choose from. Some of the most well known in the V-Twin world are AMSOIL, Mobile-1, and Harley's SYN3 to name a few.

This is a good merge into some of the industry's best hum dingers. Synthetic IS NOT TOO SLIPPERY! Your bearings WILL NOT SKID. This was a favorite back before Harley started selling synthetic oil. Slippery oil is good. It's what oil does. Nuff said! My other favorite is "once you start running synthetic, you can't go back." I don't know what chemistry major came up with that one, but here's the deal. You can go back and forth all day long. Not only that, there is no analysis that we have seen that indicates the two can't be mixed. Synthetic oil is designed to chemically duplicate fossil oil. Would I recommend mixing fossil with synthetic? Not as a routine, just because there's no reason to. In a pinch, however, it's not going to hurt your bike to run what's available to get you off the side of the road and back home.

In conclusion, today's modern oils are excellent. If you're brand loyal, run with it. Shopping for the best price, go for it! Get the right oil for the application and you'll do just fine. Next month we'll dive into that (applications) and explain some of the other technical aspects (viscosity, additive packages, etc.). Ride safe!
