## Legislative Directors Corner

### Making Your Voice Heard in the California State Legislature

Part I in a III-Part Series



In our last Bailing Wire, our Chairman, D-Man shared his experience visiting local legislators as part of our "Meet Your Legislator" events through

the months of October – December. The intent of those visits was to introduce himself and ABATE, to begin the process of developing a relationship (one that needs to be revisited several time a year at the minimum), talk about ABATE and what we do for the motorcycle riders in California, leave a copy of our 2024 Constituent Bill Ideas, and last, obtain staff contacts for follow-up at the Capitol offices in January.

Those of you reading this article today may say, "That's all well and good, but the process doesn't seem that straight forward or easy." Well, this article will serve as a primer for making first contact as easy as possible.

But first off, you might ask, "Why is any this important?"

The relationship between a constituent (that's you) and your district state legislators is the foundation of ABATE's (or any rights

organization's) ability to achieve its goals and advocate for its members. Without membership (grassroots) support, it would be very difficult to influence state legislators to support or oppose issues and or bills that ABATE believes are important for all of us. Constituents represent votes, money and political support, elements that politicians need to stay in office and succeed in their goals. It is a two-way street. We need their support and they, in turn, need ours.

Understand that paying a membership to a rights organization is not a substitute for engaging in the political process. Both are required. While members lobby ideas with lawmakers at a district level, ABATE mobilizes all the efforts throughout the state and focuses our collective goals into realistic, achievable activities to move the needle.

ABATE also leverages professional lobbyists who know the ins and outs at the capitol and have the relationships and ongoing name recognition to navigate through what can be a complicated process moving our agenda forward through the various committees and floor sessions. Strategic partnerships, political alliances, social and news media...continued on

## Lobbyist Capitol Update

The Legislature is still in recess until January 3rd. The deadline for last year's bills, that failed, to stay alive and pass out of their house of origin (Assembly or Senate), is January 31st or they are dead for the Year.

The deadline for new bills to be introduced is February 16th, 2024. As usual there will be over 2500 new proposed Laws introduced in the Senate and the Assembly. Plus, mark March 5th on your calendars because it is the Presidential Primary Election Day in our State. California moved the election from June to March years ago so the California Election could have more influence on selecting the next President. Because the elections will be held earlier in the year, it will affect the Legislative process with all 80 Assembly Members up for Election and half of the Senate running as well so look for super busy start for our year. Also, don't forget the Selection of a New US Senator with the passing of Senator Feinstein - Quite a crowded field.

As Senators and Assemblymembers are back in their Districts all of December, make sure to stop by their local offices and introduce yourselves, perhaps even ask to schedule a meeting with your Local Representative!

## Politics: Legislature Proposed New Laws

### **AB-251 Ward California Transportation Commission: vehicle weight safety study - Support, \*Amended**

This bill would require the CTC to convene a task force to study the relationship between vehicle weight and injuries to vulnerable road users, such as pedestrians and cyclists, and degradation to roads, and to study the costs and benefits of imposing a passenger vehicle weight fee, or restructuring an existing fee to include consideration of vehicle weight. The bill would require the CTC, by no later than January 1, 2026, to prepare and submit a report to the Legislature, as specified. **\*Signed into Law**

### **AB-316 Aguiar-Curry Vehicles: autonomous vehicles - Support**

This bill would prohibit the operation of an autonomous vehicle with a gross vehicle weight of 10,000 pounds or more on public roads for testing purposes, transporting goods, or transporting passengers without a human safety operator physically present in the autonomous vehicle at the time of operation. **\*Vetoed by Governor**

### **AB-645 Friedman Speed Safety System Pilot Program Oppose**

This bill would authorize, until January 1, 2032, the Cities of Los Angeles, San Jose, Oakland, Glendale, and Long Beach, and the City and County of San Francisco to establish a Speed Safety System Pilot Program if the system meets specified requirements, and would require the participating city or city and county to engage in a public information campaign at least 30 days before implementation of the program, including information relating to when the systems would begin detecting violations and where the systems would be utilized.

The bill would require a participating city or city and county to issue warning notices rather than notices of violations for violations detected within the first 60 calendar days of the program.

This bill would specify that any violation of a speed law recorded by a speed safety system authorized by these provisions would be subject only to the provided civil penalties. The bill would, among other things, provide for the issuance of a notice of violation, an initial review, an administrative hearing, and an appeals process, as specified, for a violation under this program.

This bill would require a \$25 filing fee for an appeal challenging a notice of violation issued as a result of a speed safety system until January 1, 2032. **\*Signed into Law, after 6 years of defeating similar Bills**

### **SB-50 Bradford Vehicles: enforcement - Tracking/Monitoring**

This bill would prohibit a peace officer from stopping or detaining the operator of a motor vehicle or bicycle for a low-level infraction, as defined, unless a separate, independent basis for a stop exists. The bill would authorize a peace officer who does not have grounds to stop a vehicle or bicycle, but can determine the identity of the owner, to send a citation or warning letter to the owner.

The bill would authorize local authorities to enforce a violation of the Vehicle Code through government employees who are not peace officers. **\*Failed. Ordered to Inactive File until January 2024.**

### **SB-708 Jones Vehicles: off-highway motor vehicles: off-highway motorcycles: sanctioned event permit - Support**


Existing law authorizes the Department of Parks and Recreation to issue to a nonresident of this state a special permit to operate an off-highway motor vehicle. Existing law requires the fee for this special permit to be not less than \$20, as established by the department.

This bill would require the department to issue a special permit to California residents to operate certain off-road motorcycles at sanctioned events, as defined. The bill would require the department to establish a fee for this permit, as specified.

**\*Held in Assembly Water, Parks & Wildlife Committee. Chair Bauer-Kahan ( Democrat - East Bay) refused to set Hearing**

### **SB-847 Dahle Vehicles: motorcycle: safety helmet religious exception - Tracking/Monitoring**

This bill would authorize the department to adopt a regulation certifying a helmet offered for sale, or sold, that substantially complies with, but does not meet, the requirements imposed by the specified federal standards if the helmet is designed for the purposes of compliance with a driver's or passenger's religious beliefs or practices. **\*Vetoed by Governor**



are also very important to our success and will be covered in a separate article.

So how can you get started? Glad you asked! There are multiple ways to introduce yourself and establish a relationship with your local legislator(s). The good news is it doesn't take much time out of your life and the benefits are many. Although there is much debate regarding the use of letters and phone calls, they are still low-cost, minimum effort options. However, the face-to-face method is ideal.



### WHEN MEETING WITH ELECTED OFFICIALS

#### IDENTIFY YOUR LEGISLATOR(S):

California is divided into assembly and senate districts. The easiest way to determine who your legislators are is to use the below link or QR Code.

<https://findyourrep.legislature.ca.gov/>



#### SCHEDULE A MEETING IN ADVANCE:

Call ahead to make an appointment- do not unexpectedly show up. Let the legislator's aide know what you want to discuss. Be as specific as possible so that your legislator and their staff can prepare materials they may want to provide you.

IF YOU ARE REPRESENTING A GROUP, LET THE LEGISLATOR KNOW:

When you introduce yourself make it clear who you are and what organization, if any, you are working with.

#### DON'T FEEL SLIGHTED IF YOU END UP MEETING WITH A STAFF MEMBER:

A legislator will often have you meet with trusted staff members who attend meetings and conduct other duties on behalf of the legislator. You should provide the same information to the staff member as you would the legislator.

#### DO YOUR HOMEWORK AND BE PREPARED:

Be concise and try to anticipate direct and challenging questions and prepare your answers before the meeting. If you need guidance and or help to prepare, contact your Local President or a member of the ABATE board.

#### BRING MATERIALS THAT HELP MAKE YOUR POINT:

If you have completed bill idea forms, fact sheets, studies and surveys or other statistical information to back up your views, bring them. ABATE PAC/Legislative Director, Asst. Director and/or board members can provide much of this material to you. Often these items and materials are discussed and provided by Presidents at the Locals' monthly meetings.

#### LET LEGISLATORS EXPLAIN THEIR VIEW:

Believe it or not, they may have input from many sources, state agencies, committees, historical records and/or contacts with other state or private groups with expertise on the issue.

#### FOLLOW UP:

Shortly after meeting with your legislator or staff member, give him or her a call, or follow-up with a 'thank-you' note.

#### WHEN TELEPHONING AN ELECTED OFFICIAL

#### DON'T EXPECT TO TALK DIRECTLY TO A LEGISLATOR ON THE FIRST CALL:

A call to a legislator's office is usually answered by staff who will note your request or your position on a bill. This information will be passed on to the legislator. If you're calling to request background information or to discuss a particular issue, your call may be transferred to the staff person responsible for that particular issue area. If you are calling to schedule a face to face with either the

legislator or a senior member of his/her staff – Legislative Director or District Director, for example, you may need to request to be transferred or obtain the direct number to the scheduler in either the local or capitol office.

#### INTRODUCE YOURSELF CLEARLY:

Be sure to provide the staff member with your name, address and email. This will help ensure that you will receive helpful follow-up information.

#### TRY TO COVER ONE SUBJECT PER CALL:

If there is a pending vote, action or follow-up on a bill, your phone call should be simple and to the point. The information will be taken down and forwarded to the appropriate staff person.

#### KEEP YOUR COMMENTS BRIEF:

Be prepared to state your question or position, what you want the legislator to consider doing and be ready to support your position with one or more well thought-out responses.

#### THANK LEGISLATORS FOR THEIR RESPONSE:

If a legislator or their staff does not have an immediate response to your request, politely ask when you can expect an answer. When you receive a reply, be sure to thank the legislator for getting back to you, even if the legislator's position is not the same as yours.







### Safety Article

*by Jeff Bassler, President Local #19 & Board Member*



I'd like to Introduce You to a New Safety Feature on YOUR Motorcycle...

Too many of you might not have noticed a small pedal near your right foot while you are riding. This is a special control that applies ONLY the rear brake of your bike. We are taught in training that the FRONT brake is 70% of the braking power, and the control is conveniently located next to the throttle, just like they are in a car. With so much power at your fingertips, few riders bother mastering alternate slowing techniques. Further rider training highlights that we can apply both front and rear brakes for 100% of the braking force for straight line emergency or panic braking. However, there is little more attention paid to this rear brake thing.

Under normal operation, you should notice that the front end of the bike dips when you apply pressure to the front brake lever. That applies more weight to the front tire. Especially with ALL your steering control

reliant on front tire traction, there are several situations in which too much of that pressure and braking can be hazardous. Lock the front brake, or otherwise slide the front tire, and you lose steering control, and you might not keep that shiny side up. This is clearly less than desirable. There has to be a better way.

That is where the rear brake comes in. Like many controls, safe operations come from practice. Like the front brake, applying too much rear brake power has its own hazards. Although the rear brake applies less weight to the front tire than front braking, it still does transfer some weight from the rear to the front tire. That means you have less grip on the road with the rear tire, making it easier to lock up the rear tire. Although it is easier to safely rear skid to a stop than it is for a front tire lock up, it still is less than desirable. THAT is what the practice seeks to avoid. The best way to practice the rear brake is to utilize every normal stop light slow down and stop as a chance to apply the rear brake and get the feel for it. NEVER apply hard pressure. Apply light pressure, and gradually firm up pressure to control your safe stop. Get in the habit of using the rear brake, always gradually increasing from light pressure to firmer pressure... under rolling control.

Now that you have made safe rear braking a habit, you can move on to safe situational use of that rear brake. A catch all that describes the best times to use the rear brake can be simply stated as times loss of steering control are most hazardous. These fall into three major categories.

Curves and Turns are challenging times to apply the front brake. That is why we are taught to straighten up the bike for hard braking. Too much spinning resistance on the front tire while lateral forces are applied (because of the turn), can lead to the front tire sliding out from under you. However, applying the rear brake applies no spinning resistance on the front tire. That allows the front tire to maintain a more consistent grip on the road through the turn. That said, the light to firmer progression of brake application is critical. Too much pressure and you slide out your rear tire. That is why the straight-line practice is encouraged. But you have safer slowing control with the rear brake than the front while leaning into a curve. Further, this can be paired with very light front braking for maximum slowing.

Poor Traction Surfaces, like off road, gravel, sand, or other loose hazards on the

road make it MUCH easier for the front tire to lock up and take away your steering control. You just don't have the margin of error when applying your brakes on such surfaces as you do when on a more solid, grippy, surface. This leads to paranoid riding. Less experienced riders are universally uncomfortable, at best, riding on such surfaces. Mastering the rear brake technique of gradual application of pressure can restore control, and thus confidence, on these surfaces.

And another major situation where rear braking can lead to safer bike operation is Slow Speed Maneuvers. While riding at slow speeds it is easy for front brake pressure to grab and lock the front brake. If that happens while the handlebars are turned, and especially if there is a lean angle too, a momentary lock of the front brake is enough to throw you down the direction you are steering. Additionally, that is a situation more people are likely to be watching you. I'll tell you; you won't feel much more stupid doing ANYTHING on a bike than dropping it in front of a group of spectators in a parking lot. Don't let this happen to you. This is also a key to motor officers successfully completing the motorcycle rodeo courses that include a lot of slow speed tight turns. Be in command of your rear brake and allow the front wheel to steer you to your destination in style and safety. Be that "cool" biker.

Sadly, the majority of riders use the rear brake very little, if at all. One of the missions of ABATE is to increase rider safety. Having full command of ALL the controls on your bike, knowledge of when to use them, and command of their nuanced use can make you one of the safest riders on the road. Don't rely on bad habits... and always strive to be a better rider.
