We've all heard horror stories about about to be eliminated because of the driving public's opposition, there. Realistically though, unless you work in a motorcycle environment where you are constantly exposed such as a race team or a shop, how often are you going to encounter a motorcycle in your everyday travels or on your job or in your home? Unless you live in close proximity to a biker bar, motorcycle sage during the heavy summer riding shop, racetrack or some similar type of operation, chances are slim.

They are slim because motorcycles and sign up for our Leg Alerts - you only comprise 3% of the total registered vehicles on the road. Sure there are concentrated areas such as large runs or bike nights but those are normally pre-planned events of short duration, scheduled well enough in advance that nearby residents should be prepared. Otherwise, you might go about your daily routine and travels without ever encountering a solitary motorcycle. And typically, motorcycle noise is transient in nature and of a passing nature. And some events even tout that noise is an integral part of the event through the names that are chosen such as Thunder on the Lot or Rolling Thunder. Just the word "thunder" evokes a mental image of immense sound but on the other hand, thunder is also a transient experience





While there is nothing in the data to indicate the cause of the sudden decline, the GHSA asked state safety agencies to speculate on reasons for the decline, and several respondents pointed to the economy and underscored that a significant portion of motorcycling is for recreation rather than transportation.

Other reasons cited in the study for the decline: Fewer beginning motorcyclists; an increase in priority given to state motorcycle safety programs; an increased awareness of motorcycles by other drivers; and colder, wetter weather in some states during the riding season. It doesn't appear helmet laws played a significant role in the decline.

The popularity of motorcycles has surged in the past decade, particularly among aging baby boomers and women, nearly doubling to more than 10 million.

Those ages 50-59 were the fastest growing group involved with crashes, and accidents involving riders in that age group were almost twice as likely to be fatal as those involving younger bikers.

"Treating a 60-year-old who has been in a motorcycle accident is very different from treating a 21-year-old who has been in a similar accident -- 60-year-olds bring a lot more medical baggage with them and impact outcomes," Dr. Mark Gestring, director of the trauma program at the Medical Center.

Age-related factors associated with aging, such as impaired vision, delayed reaction time, and altered balance contribute to motorcycle crashes in this population.

# A Near Miss or A Near Hit?

"That guy ran the red light and almost killed me! My light was green; I had the Right of Way!!" I didn't??? That driver was supposed to yield the Right of Way to me, but if he doesn't, then I don't HAVE the Right of Way! The National Safety Council describes 'Defensive Driving' as "driving to save lives, time and money despite the conditions around you, and the actions of others." Another favorite of the National Safety Council describes an 'accident' as when a tornado hits town and carries off your garage. Whereas a 'collision' is what happens when a motor vehicle hits something.


Whose fault is the collision? Fault or blame are words used by lawyers, not by safety professionals. That's because investigation reports show that most traffic crashes have driver error as their number one cause.

# Spring Has Sprung! by John Del Santo

Old Man Winter is melting away and the good riding days are upon us. Those of you who have been riding all winter will be able to do so with a lot less clothing, and those who have not been able to do much winter riding will be suffering from PMS (Parked Motorcycle Syndrome) and will be itching to get out on the road.

How has your bike weathered the winter? Are there any cracks in the rubber? And do the tire stems look sound? How about those rubber hoses and electric wires? Check 'em out. Is there anything on the bike moving that shouldn't? And does everything move that should? Tighten it, lube it, and kick it a couple of times.

There are some bike owners who sat out the cold months in front of the TV and who will go out there on the first warm day and 'Hot Dog' it and end up in a ditch or shoving the rider next to him into oncoming traffic. Be it riding, skiing, or playing the fiddle, if we haven't done much of it for three months, then we're not going to do it well. If you haven't been riding very much, be aware of your limitations and work into it gradually. You might even want to pop down to the lo-



cal training area and spend a day on the Experienced Rider Course. It's good for tuning up your skills and costs less than most pieces of chrome you could buy for your bike. Besides, a good rider never stops learning.

Is some group hosting a big spring group ride? Be aware of who you are riding next to in that group. If you don't know them

or know how good they are, don't ride near them. If they do something stupid, tell them about it and then make them go ride someplace else. Don't worry, their feelings have probably been hurt before.

There will be potholes in the road that weren't there last week and the spring runoff will wash sand and gravel out on the road right around that next bend, be ready for it. Spring has sprung! Let's get in the wind and enjoy it! Ride Smart! Ride Straight! And Ride Safe!


