## Lobbyist's Legislative Report

There's a lot's happening this month - June Primary Elections, Pavley's motorcycle muffler inspection bill, Share the Road freeway signs appeared for May and because California's \$20 billion in the hole, Red Light Cameras are back.

Our list of Endorsed Candidates is out and posted on our website! Check for a Candidate in **YOUR** area to help. **THEN**, go and volunteer at least just **ONE DAY!** At the Capitol Rally in April, many people thanked me for all that I do to protect our freedom to ride! I asked them then, and you now, to volunteer for at least a one day shift to help an ABATE endorsed candidate in their election campaign.

If your Assembly Member or Senator is not endorsed, look for one nearby and work in **their** campaign. Many thanks also to those individuals and Locals, who have contributed to the PAC fund. The money is being strategically contributed to those races in which we think we can make a difference, and win! So give us a day of volunteering, **PLEASE**.

I have it on good authority that Senator Fran Pavley's bill, SB 435, will be amended shortly to emphasize the enforcement of modified motorcycle muffler systems more by requiring law enforcement personnel to check if the required muffler identification stampings (since 1982) match the bike that the muffler is on, to meet legal noise (and by extension) emission requirements.



**GET READY FOR A BRAWL!** Sign up some new members and bring them to the Capitol to pack fourth floor Assembly Transportation Committee hearing room number 4202, where our helmet law repeal bill was heard last year. Whatever it will cost you to

take that day off from work will be cheaper than having to replace your exhaust system (if you can even find the original parts, any more).

This needs to be taken very seriously; its author Pavley, got AB 32, the greenhouse gas ban bill, through against the strong opposition of almost every business group and labor union in the state (and country). Keep writing your letters to the Transportation Committee - **OPPOSE SB 435!**

To help close the gaping \$20 billion budget deficit, Governor Schwarzenegger has, once again, included speed camera ticketing in his May Budget Revise. This will authorize cities, counties and the state to put speed enforcement cameras on any street, road or highway to be able to send violators a \$450

fine plus a point on their driving record. Our cash-starved cities and counties are looking to these "peeping toms" as a revenue generator, so to force this from the proposed budget will be another tough struggle!

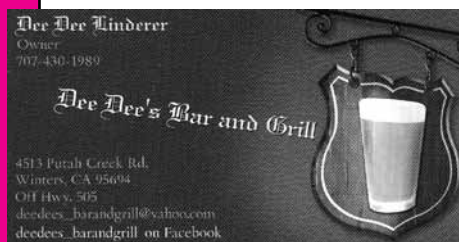
We've all heard horror stories about Arizona's speed cameras which are about to be eliminated because of the driving public's opposition, there. On behalf of ABATE, I testified against this earlier this year, and joining me in the opposition were the Teamsters Union, Auto Clubs and the CHP Union. We were the only MRO or highway user group to oppose it.

Republican Assembly Minority Leader, Martin Garrick, ushered in "May 2010 Is Motorcycle Awareness Month" by authoring HR 29 for us. Due to the efforts of John Del Santo, and me in Sacramento, we were able to persuade the CHP to get Caltrans to run the "Share the Road With Motorcyclists" freeway signs during May to further promote motorcyclist awareness.

I have been working on using the freeway signs to promote motorcyclist awareness already for nine years, as I reported in last month's *Bailing Wire*, but we never stopped pushing for it. This shows that, although progress can be very slow in Sacramento, being persistent can pay off! I'm also continuing to pressure Caltrans to also post our message during the heavy summer riding season.

Finally, check the ABATE website and sign up for our Leg Alerts - you know that if you receive one, it isn't **SPAM**; it will be important for you to act on it **TO PROTECT OUR RIDING FREEDOMS!**

See you in Sacramento or at the next Board Meeting in Pomona on July 24.

## Executive Director's Report

Greeting Brothers, Sisters, & Friends: The anti noise crowd is hard at work to mitigate what they perceive as excessively loud and harmful exposure to motorcycle exhaust. Now I'll be the first one to tell you that long prolonged exposure to sustained high levels of sound can be detrimental to one's hearing, and depending upon the type of noise, possibly even affect our mood. As example of how loud noise "can" be harmful, and certainly guaranteed to influence one's mood, just crank up some of that alleged "music" that is favored by kids today where the "vocalist" sounds as if he has just stepped upon his own "family jewels" and you will see not only my mood begin to swing from a happy carefree mood to one of increased irritability and anger in which no boom box or iPod or any other form of offending electronic media is safe from my wrath and/or hammer!

Realistically though, unless you work in a motorcycle environment where you are constantly exposed such as a race team or a shop, how often are you going to encounter a motorcycle in your everyday travels or on your job or in your home? Unless you live in close proximity to a biker bar, motorcycle shop, racetrack or some similar type of operation, chances are slim.

They are slim because motorcycles only comprise 3% of the total registered vehicles on the road. Sure there are concentrated areas such as large runs or bike nights but those are normally pre-planned events of short duration, scheduled well enough in advance that nearby residents should be prepared. Otherwise, you might go about your daily routine and travels without ever encountering a solitary motorcycle. And typically, motorcycle noise is transient in nature and of a passing nature. And some events even tout that noise is an integral part of the event through the names that are chosen such as Thunder on the Lot or Rolling Thunder. Just the word "thunder" evokes a mental image of immense sound but on the other hand, thunder is also a transient experience

and once in a while it is good to experience a little of Mother Nature's noise pollution to keep ourselves properly humble about our place in the grand scheme of things.

Regardless, I rarely hear or see another motorcycle within my neighborhood until I venture out onto a major thoroughfare. And my neighbors rarely hear mine either because as soon as I start the engine, I start idling towards the main drag and get the hell out of dodge where I won't bother them when I start to twist the throttle. I'm sure many of you are just as courteous towards your neighbors, so how is that we keep getting such a bad rap nationwide on issue of noise pollution?

First of all, we can thank the biker ste-



reotyping of Hollywood for fueling much of the anti-biker sentiment that we accrue today. But we can also thank many irresponsible members of our own motorcycling community for the increased problems of noise we are facing. There is a time and place for just about everything and my perspective is a little noise once in a while is a good thing. But as we, as motorcyclists, begin to face the issue of noise pollution, there are many issues the anti-noise crowd is not coming clean about. They attempt to maneuver people onboard their platform under the guise of motorcycle noise being physiological harm-

ful but there is another side of noise that I have just become aware of that involve studies in behavior modification or perhaps manipulation would be a better choice of words.

Noise researcher/writer George Prochnik tells us "For years social scientists and marketers have been scrutinizing the links between loud music, fast tempos, and drinking habits." What is even more frightening about these studies is that these folks have figured this science out in fine degree, such that they know how to use this information to manipulate people into chewing faster, drinker faster, and finish dining faster, all in an effort to boost corporate profits. According to Prochnik, one example of such behavioral modification studies came when "In the mid-1980s, researchers at Fairfield University demonstrated that people increased their rate of chewing by almost a third when listening to faster, louder music, accelerating from 3.83 bites a minute to 4.4 bites a minute. Stoked with data of this nature, chain

restaurants, such as Dick Clark's American Bandstand Grill, developed computerized sound systems that were preset to raise the tempo and volume of music at hours of the day when corporate wanted to turn tables."

Moreover, Prochnik informs us "a study completed in the summer of 2008 in France found that when music was played at 72 decibels, men consumed an average of 2.6 drinks at a rate of one drink per 14.51 minutes. When the sound level was cranked up to 88 decibels, the numbers spiked to an average of 3.4 drinks, with one consumed every 11.47 minutes. No wonder I'm thirsty after going for a ride?

My point here is that there are a great many more people who are exposed to noise levels as high as motorcycle exhaust in such seemingly innocuous places as our favorite restaurant at happy hour, be it Chilis or Chuys, than those who are simply exposed to motorcycles. How many of you have ever walked out of one of these places with your head and ears ringing from the ambient noise level of the crowd. So, as we wander through the corporate cultural wasteland of America, one thing becomes

apparent - noise it's only bad if it caused by those nasty old tattooed up bikers but if you're a "corporate personhood" as recently established by the Supreme Court, it is okay to produce noise to modify your customer's behavior to increase your profit margin.

My advice is that we in ABATE begin to place a little emphasis on the issues surrounding noise pollution so that we can be prepared to tackle this problem before we are inundated with legislation and test parameters that we will find to be too restrictive and unworkable. Let's be pro-active and not let the powers that be, or those that would like to be, rule the day on the issue of motorcycle exhaust. Until next month, ride hard, ride safe, & ride free!

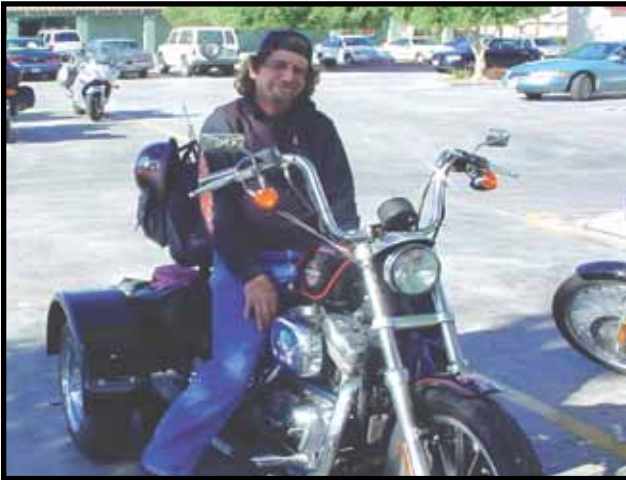


## Sporty's Rides

# COAST TO COAST BIKER NEWS

**MOTORCYCLIST FATALITIES INEXPLICABLY PLUMMET** Following more than a decade of steady increases, motorcycle rider fatalities unaccountably dipped by double-digit proportions last year. Motorcyclist deaths dropped by 16% nationwide through the first three quarters of 2009, compared to the same period in 2008 when fatalities reached their highest level of 5,290.

The study -- sponsored by the Governors Highway Safety Association, which represents state traffic safety agencies -- is drawn from preliminary fatality data from all 50 states and the District of Columbia. While there is nothing in the data to indicate the cause of the sudden decline, the GHSA asked state safety agencies to speculate on reasons for the decline, and several respondents pointed to the economy and underscored that a significant portion of motorcycling is for recreation rather than transportation.

Other reasons cited in the study for the decline: Fewer beginning motorcyclists; an increase in priority given to state motorcycle safety programs; an increased awareness of motorcycles by other drivers; and colder, wetter weather in some states during the riding season. It doesn't appear helmet laws played a significant role in the decline.

The popularity of motorcycles has surged in the past decade, particularly among aging baby boomers and women, nearly doubling to more than 10 million.

During the nine-month period of the comparison, the District and 38 states reported a drop in motorcycle deaths, and 12 states recorded an increase. California had 133 fewer deaths, Florida had 111 fewer and Ohio had 48 fewer. Only two states -- Hawaii and Rhode Island -- had double-digit increases. Once numbers for the final three months of 2009 are factored in, the report projects, the annual fatality decline will be at least 10%.

## AGING RIDERS AT HIGHER RISK

Motorcycle riders across the country are growing older, and the impact of this trend is evident in emergency rooms nationwide as doctors are finding that senior citizens who ride motorcycles are more likely to be

involved in accidents and also more likely to be injured or die than their younger counterparts.

Researchers at the University of Rochester Medical Center found that half of all motorcyclists needing emergency treatment in 2005 were over 40, nearly double the number in 1996, which is consistent with demographic data indicating that the average age of motorcycle ownership has rose from 33 years in 1998 to 40 years in 2003. Injury severity, length of stay in the hospital or intensive care unit, and mortality were higher for riders over the age of 40.



In the study, which was published in the March issue of the American Surgeon, researchers using the National Trauma Databank reviewed the records of 61,689 motorcyclists aged 17 to 89 years involved in a motorcycle crash between 1996 and 2005.

Those ages 50-59 were the fastest growing group involved with crashes, and accidents involving riders in that age group were almost twice as likely to be fatal as those involving younger bikers.

"Treating a 60-year-old who has been in a motorcycle accident is very different from treating a 21-year-old who has been in a similar accident -- 60-year-olds bring a lot more medical baggage with them and impact outcomes," Dr. Mark Gestring, director of the trauma program at the Medical Center.

Age-related factors associated with aging, such as impaired vision, delayed reaction time, and altered balance contribute to motorcycle crashes in this population.

The increase in injury severity for older riders may be related to the reduced capacity to withstand injury as the body ages, including decreases in bone strength and brain size, as well as pre-existing medical conditions.

**NATURALISTIC MOTORCYCLE SAFETY STUDY** The Motorcycle Safety Foundation (MSF) has announced that it will partner with the Virginia Tech Transportation Institute (VTTI) on the world's first motorcycle safety study that will use small video recorders and instrumentation mounted on numerous bikes for 6-18 months to gather data about the riders and events that occur.

Termed a "naturalistic" study, VTTI has developed this technology and used it successfully to conduct a 100-car study in 2005 that included 69 crashes and more than 750 near-crashes. According to the MSF, "The method is presently in use by researchers across the globe to target nearly every type of roadway user, with the exception of two-wheeled vehicles. This study, expected to be on the road by early 2011, will greatly advance the understanding of interactions among rider, motorcycle, roadway, other roadway users and the environment."

VTTI Director Tom Dingus added that "We expect the study to be very valuable to the Motorcycle Safety Foundation's work, since we also will examine where and how crash avoidance is successful. With so much information bandwidth coming from the cameras and instrumentation on each bike, we'll be able to examine details for years, and the findings will be relevant for decades."

Naturalistic Method identifies crashes using time-series video and numeric data, reveals factors not detectable through crash investigation, creates its own controls by comparing the crash-involved rider to himself/herself at all other times, and permits quantification of rider performance and behavior in non-critical and critical riding situations.

**GLOBAL MARKETS BOOST MOTORCYCLE SALES** While U.S. motorcycle sales continue to drift downward, globally Honda bucked the trend by posting a 30% sales gain for first quarter of 2010, reflecting 2.54 million motorcycles sold outside of Japan.

Sales in the American market dropped 21% during the first quarter of 2010, a less

precipitous slip than the previous year's 37% slide, but the rising demand for small displacement bikes in Asian markets helped the juggernaut manufacturer post a \$2.68 billion profit for the last fiscal year, a staggering 95.9% increase over the prior year.

We may find consolation in the U.S. market since our sales are sliding less steeply than before, but the evolving global marketplace is not only motivating companies like Volkswagen to purchase one fifth of Suzuki, such international sales figures are also prompting manufacturers like U.S. stalwart Harley-Davidson to divert their efforts into regions like India.

**PATRIOT GUARD RIDERS BARRED FROM MINERS MEMORIAL** Many of the 29 West Virginia coal miners who died at the Upper Big Branch mining explosion on April 5th were veterans and some rode motorcycles, so bereaved families had requested the Patriot Guard Riders to attend the memorial service. PGR is an informal group of motorcyclists which exists to make sure that all veterans are given respectful funerals. But they were barred from attending this service by federal officials who labeled them a security threat.

The appearance of the Patriot Guard Riders at the service, at the request of several families, had been cleared in advance by West Virginia Governor Joe Manchin, who is also a motorcycle rider. But the day before the service, Joe Cumblidge, the West Virginia State Captain of the Patriot Guard Riders e-mailed the men who were scheduled to participate: "Due to circumstances totally and completely beyond the control of the Patriot Guard Riders and Governor Joe Manchin of West Virginia, we are regrettably ordering a STAND DOWN for this mission. Specific details will not be posted here but, we've been told we are not welcome to participate because of certain high-level dignitaries that are scheduled to be in attendance."

The "high-level dignitaries" were President Barack Obama and Vice President Joe Biden. A Patriot Guard Rider told WSAZ in Charleston that Manchin had been forbidden to allow them to participate "because of overwhelming security concerns with high-ranking federal officials -- it was just not logistically possible for them to be a part of the event."

Both Obama and Biden managed to escape West Virginia unharmed.



# COAST TO COAST BIKER NEWS

**LEGAL CHALLENGES TO MICHIGAN HELMET LAW** Several members of ABATE of Michigan rode to the Lenawee County judicial building on Tuesday, April 20th to show support for a fellow motorcyclist who is challenging a non-compliant helmet ticket. Ryan Hildebrand, 26, is one of nearly a dozen riders ticketed this spring by Adrian police Sgt. Lynn Courington for wearing helmets that the state claims do not meet federal Department of Transportation standards.

Representing the group of ticketed riders is Aid to Injured Motorcyclists (A.I.M.) attorney Lawrence "Katman" Katkowsky, who filed an appearance for the helmet defendant. A formal hearing was set for June 29 in district court, and Katkowsky said he will try to consolidate all the helmet infraction cases that are being challenged for the June 29 hearing. "The issues are all the same," he said.

He is taking on the helmet enforcement issue in Lenawee County on behalf of ABATE of Michigan, which also has a lawsuit pending in United State District Court in Grand Rapids, challenging the state's DOT helmet rule.

One of the enforcement issues Katkowsky will raise is regarding probable cause to justify a traffic stop on a civil infraction. ABATE claims in the lawsuit that

police have to look inside a helmet to determine if it meets DOT standards, and therefore cannot claim plain sight evidence to justify a traffic stop and request to inspect a helmet. No trial date is scheduled.

**ANGRY FRENCH MOTORCYCLISTS SNARL TRAFFIC IN PROTEST** Forty thousand motorcyclists demonstrated all over France in protest of a recent Government announcement to fine any bikers caught filtering through traffic ("lane splitting"), and more than 60 cities saw their roads blocked by hordes of angry riders who said NON to French authorities who propose to treat motorbikes, scooters and mopeds like cars and require them to stay in their lane one behind another.

So, they behaved like cars! On March 13th the La Fédération Française Des Motards en Colère (FFMC - the French Federation of Angry Bikers) urged all motorcyclists to occupy the space of one car in each lane, and within minutes an enormous traffic jam was created that gridlocked the whole of Paris on a busy Saturday afternoon as car drivers were stuck in traffic until late in the evening.

While bikers blocked the roadways above ground, other protestors went underground bringing the subway system to a grinding halt in response to a statement made by French Transport Secretary Jean-

Marc Belotti, who said "If they (bikers) are not happy, they can take the metro like everyone else."

They inconvenience us, we will inconvenience them, responded the FFMC, which set a fine example of civil obedience to demonstrate the impact of motorcycles on traffic flow, good or bad.

**WEIRD NEWS: EASY WRITERS TEXT WHILE RIDING** Everyone knows that texting while driving can be dangerous. Now consider this: texting while riding a motorcycle, in heavy traffic! It's not uncommon in Vietnam, where 29 million motorcycles are the primary source of transportation.

Pham Thi Thuy Linh is 21, a college student and -- according to a recent contest sponsored by a mobile phone company -- has the fastest fingers in Vietnam. She can text 160 characters in 25 seconds, though she admits she is "about 20 or 30 percent slower texting on my bike." She doesn't much care that texting while driving is both illegal and not too smart.

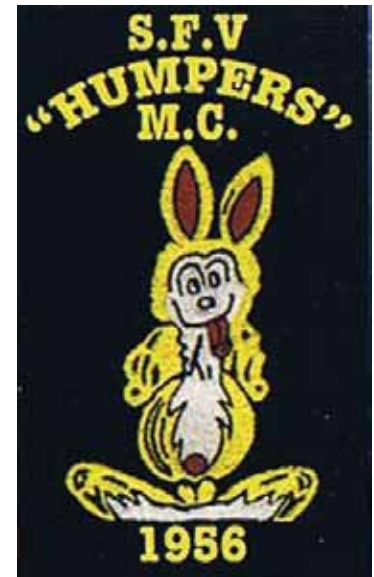
Tran Van Thanh is a senior official in the government's office of traffic safety. He told National Public Radio that understands the concerns about texting while driving, but says peoples' bad habits will take time to change, and with limited resources it's

impossible to crack down on everyone for everything.

Meanwhile, contest-winner Pham says she can't wait to get one of the new iPhone packages. She says it will enable her to text even faster than she does now, from everywhere -- including her bike.

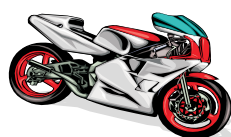

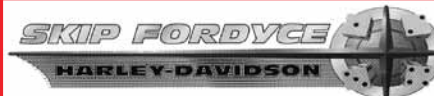

## Tech Tips

by Craig Griswold

### Carburetors - Part IV

In the last few articles of this series we talked about tuning procedures for a few different carburetors. During the tuning process, the tuner must ascertain whether the air fuel mixture is appropriate for a given circuit, or overly rich/lean. There are several ways to determine this. Be advised that a lean condition can be caused by vacuum leaks, so you'll want to diagnose that symptom before proceeding.

In any given circuit (idle, intermediate, or main), a lean condition will usually result in popping or coughing through the carb. The ideal jetting will be just rich enough to eliminate this symptom. On the other hand, an overly rich tune will result in sluggish performance and in most cases, black smoke from the exhaust. Most carburetor manufacturers provide guidelines for jetting. You can use this as a baseline. Remember that when changing jetting, go two sizes at a time. This will usually produce enough of a change that will be noticeable and will make tuning easier.

Using the above acceleration characteristics is probably the most common procedure. This can be combined with spark plug readings which will provide even more accuracy. Spark plug readings, also known as "plug chop" readings can be difficult and even dangerous depending on road conditions and traffic density. If possible, use a closed course.

The procedure is fairly simple. Warm the bike to full operating temperature. Run it in the RPM band that you are tuning. For the intermediate circuit, cruising between

2000 and 3500 RPM with less than 50% throttle will be about right. After several minutes, and when it's safe to do so, pull in the clutch, chop the throttle, and kill the motor. Coast to a safe location and pull the plugs. The condition will illustrate the state of tune for that circuit. Black sooty plugs indicate a rich condition, white and/or blistering appearances indicate too lean. A tan to rusty brown powdery deposit is indicative to ideal combustion. The same procedure can be used for the main. RPM should be above 3500 with greater than 50% throttle.

If you're in doubt, a dyno tune is definitely the most accurate procedure of all. It's also pretty expensive, so it pays to shop around. Although labor rates may be comparable, how the hours are charged can vary greatly.



# A Near Miss or A Near Hit?

"That guy ran the red light and almost killed me! My light was green; I had the Right of Way!!" I didn't??? That driver was supposed to yield the Right of Way to me, but if he doesn't, then I don't HAVE the Right of Way! The National Safety Council describes 'Defensive Driving' as "driving to save lives, time and money despite the conditions around you, and the actions of others." Another favorite of the National Safety Council describes an 'accident' as when a tornado hits town and carries off your garage. Whereas a 'collision' is what happens when a motor vehicle hits something.

Whose fault is the collision? Fault or blame are words used by lawyers, not by safety professionals. That's because investigation reports show that most traffic crashes have driver error as their number one cause.

## Spring Has Sprung!

Old Man Winter is melting away and the good riding days are upon us. Those of you who have been riding all winter will be able to do so with a lot less clothing, and those who have not been able to do much winter riding will be suffering from PMS (Parked Motorcycle Syndrome) and will be itching to get out on the road.

How has your bike weathered the winter? Are there any cracks in the rubber? And do the tire stems look sound? How about those rubber hoses and electric wires? Check 'em out. Is there anything on the bike moving that shouldn't? And does everything move that should? Tighten it, lube it, and kick it a couple of times.

There are some bike owners who sat out the cold months in front of the TV and who will go out there on the first warm day and 'Hot Dog' it and end up in a ditch or shoving the rider next to him into oncoming traffic. Be it riding, skiing, or playing the fiddle, if we haven't done much of it for three months, then we're not going to do it well. If you haven't been riding very much, be aware of your limitations and work into it gradually. You might even want to pop down to the lo-

cal training area and spend a day on the Experienced Rider Course. It's good for tuning up your skills and costs less than most pieces of chrome you could buy for your bike. Besides, a good rider never stops learning.

Is some group hosting a big spring group ride? Be aware of who you are riding next to in that group. If you don't know them or know how good they are, don't ride near them. If they do something stupid, tell them about it and then make them go ride somewhere else. Don't worry, their feelings have probably been hurt before.



There will be potholes in the road that weren't there last week and the spring runoff will wash sand and gravel out on the road right around that next bend, be ready for it. Spring has sprung! Let's get in the wind and enjoy it! Ride Smart! Ride Straight! And Ride Safe!

And the insurance company might charge the other car with 90% of the collision, and me with 10%. Or at an uncontrolled intersection, the chargeability might depend on which vehicle hit which vehicle, and where did they hit them, front, middle or rear.

The reason insurance companies use this gobbledygook terminology, is so they can try to find a way to bail out and avoid responsibility for their client's actions, so they can avoid paying for the collision. By the same token, if we go around trying to duck any responsibility after we are involved in a collision or close call, i.e. "That idiot pulled right out without looking" - "It's that dummy's fault, he looked right AT me and didn't SEE me", then we are trying to lay the blame totally on someone else, and we are doomed to repeat our involvement in the next collision. You have heard that type of person talking, "Yes, I've had 13 accidents, but only one of them was my fault." Whereas someone who rides defensively would consider, "Was I being observant enough?

Should I have expected that driver to make that move? Traffic was getting a bit heavy, could I have used a bit more following distance? I have a cold; will I need more reaction time than usual? Was I in that guy's blind spot?"

"Even though that driver messed up BIG TIME, was there anything reasonable that I could have done to prevent the collision?" Then we are using the situation as a learning experience! "What doesn't kill me should make me a smarter rider."

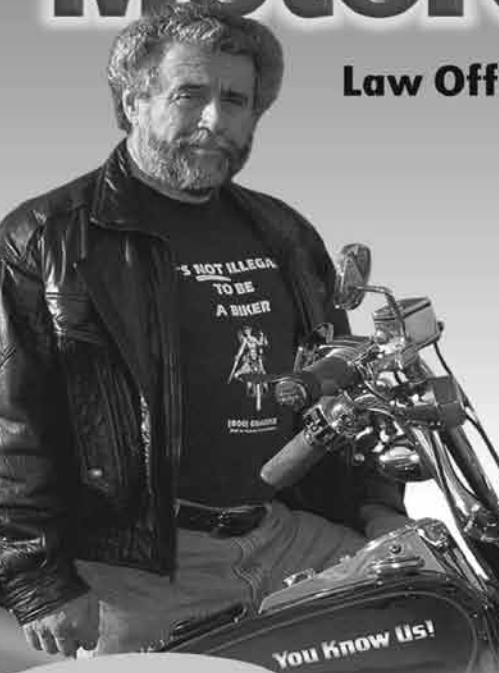

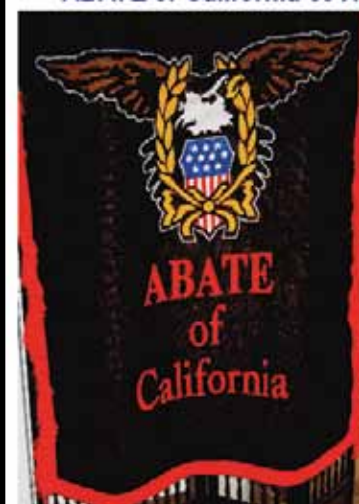
