Lobbyist's Legislative Report



a Bill ABATE has opposed these past 3 years successfully and prevented the giveaway sale price, reduced future expansion of riding area for off-roaders that was purchased with OHV Registration money in the 1990s! Much thanks to all of you that responded to OUR CALL TO ACTION ALERT and sent in messages to Governor Newsom's office. A huge victory - job well done! It helped us in our meetings with the Governor staff in requesting a VETO.

SB 112 State Government was amended during the last week of session to alter the non-fix-it ticket for Motorcycle noise violations. Motorcycles with the Federal stamp on their muffler, will be able to receive a fix-it ticket for a damaged or defective muffler!

Finally AB 47 Daly (D - Anaheim) - drivers holding their phone while driving will receive an increased fine (it was the lowest fine on the books) for their 1st violation and a point on their record for their second and subsequent violations. It unfortunately will not go into effect until 2021, a concession to the Teamsters Union as any violation occurring in your personnel vehicle does affect their commercial driver's license and insurance.

Keep an eye out for California Motorcyclists Safety Organization update with the meeting occurring October 24th at CHP headquarters in Sacramento.

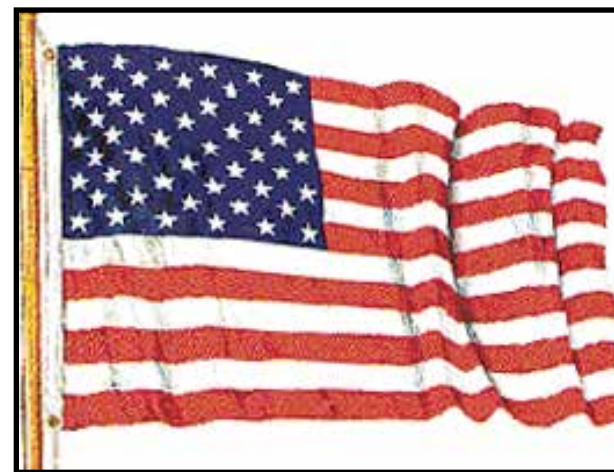

Governor Newsom took his FINAL ACTION close to 2000 BILLS this year. The deadline was Sunday, October 13th! If you're planning a ride to the beach to have a beer and a smoke, better do it before January 1st, SB 8 Glazer (D - East Bay) outlaws smoking at ALL State beaches January 1st, 2020! Also, if you're thinking of buying a fur coat to wear at the beach that day - the sale of fur products will also be outlawed at the start of next year!

The Governor did VETO a bill we strongly opposed, AB 1086 Bauer-Kahan (a last week of Session Gut & Amend/Jailbreak of SB 767 Glazer that we killed in Committee) which would have forced the sale of Department Parks and Off-Highway Vehicle Commission land at Carnegie State off-road park. It was

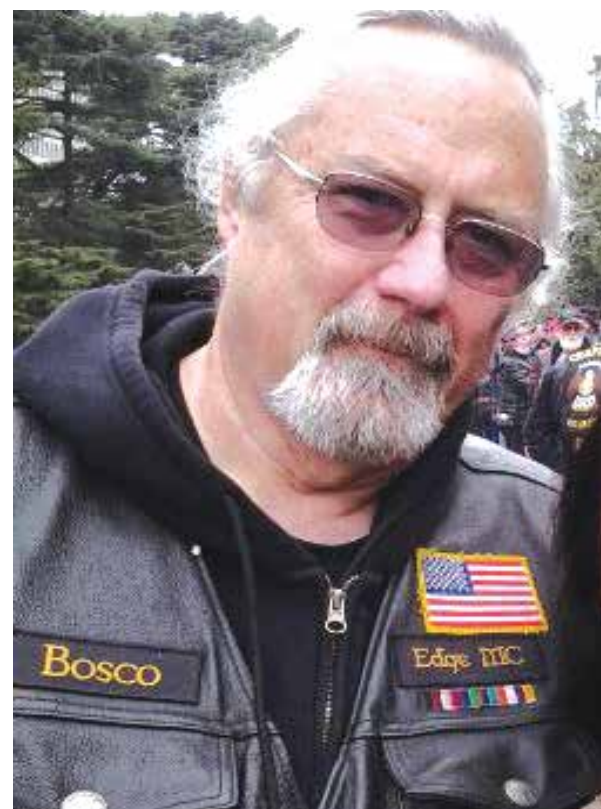

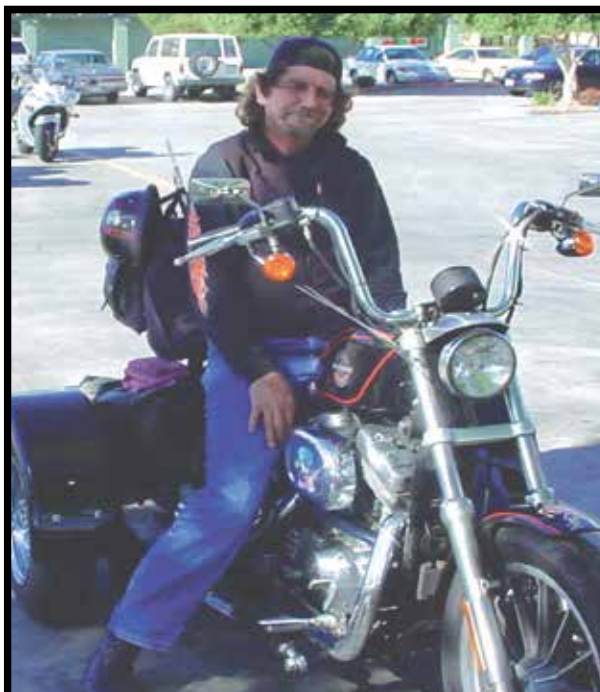

Bills at a Glance

AB-47 Daly (D – Anaheim) Frazier (D – Vacaville) Driver records: points: distracted driving would make the ticket for holding your phone while driving a moving violation and point on your Driving Record.

Signed into Law by Governor Newsom October 8th, 2019.

AB 1086 Bauer-Kahan B-767 Glazer (D – East Bay). Off-highway vehicular recreation: Carnegie State Vehicular Recreation Area: Alameda-Tesla Expansion Area. This bill would authorize the department to dispose of the portion of the Carnegie State Vehicular Recreation Area known as the "Alameda-Tesla Expansion Area" to permanently preserve that land for conservation purposes and not Off-Road Riding.

Vetoed by Governor Newsom on October 11th, 2019

*SB-112 State Government Budget Trailer Bill (Signed into Law) Deletes a violation of the noise requirements related to mufflers and exhaust systems from the list of disqualifying conditions, thereby making a person who is arrested for one of these offenses eligible to execute the notice described above, except if the violation consists of modifying the exhaust system of a **motorcycle in a manner that purposefully causes it to exceed noise limits.***

California to ban smoking on state parks, beaches

SCARAMENTO, Calif (AP) – California will ban smoking on state parks and beaches starting next year under legislation signed by Gov. Gavin Newsom.

The law also bans disposing cigar and cigarette waste at parks and beaches. Violations of the law will punishable by a fine of up to \$25. Newsom, a Democrat, announced Friday he had signed the bill into law.

It covers smoking traditional cigarettes as well as using electric smoking devices. Smoking will still be allowed in parking lots at beaches and parks. Film and television productions can still allow people to smoke on state property with the proper permits.

Democratic state Sen. Steve Glazer has been pushing such a ban for years, with lawmakers approving it several times. But former Gov. Jerry Brown, a fellow Democrat, repeatedly vetoes it.

"We have many rules telling us what we can and can't do and these are wide open spaces," he wrote last year.

Glazer has argued such a rule will protect public health and curtail pollution.

California already prohibits smoking at childcare centers, within 25 feet (7.6 meters) of farmers' markets, in government buildings and on public transportation. Cities and counties can also adopt their own smoking laws.

California has roughly 280 state parks and 340 miles (547 kilometers) of coastline.

A legislative analysis predicts it will cost the state parks system nearly \$2 million to put up more than 5,000 signs alerting people to the ban and complying with various state regulations.

The law is supported by many medical and environmental groups as well the cities of Huntington Beach and Santa Monica. Many Republicans in the Legislature voted against the measure.

During that time he worked on a partnership with the local Harley-Davidson dealer to create the Hot Rods & Harleys event, a very successful venture for ABATE and Harley. 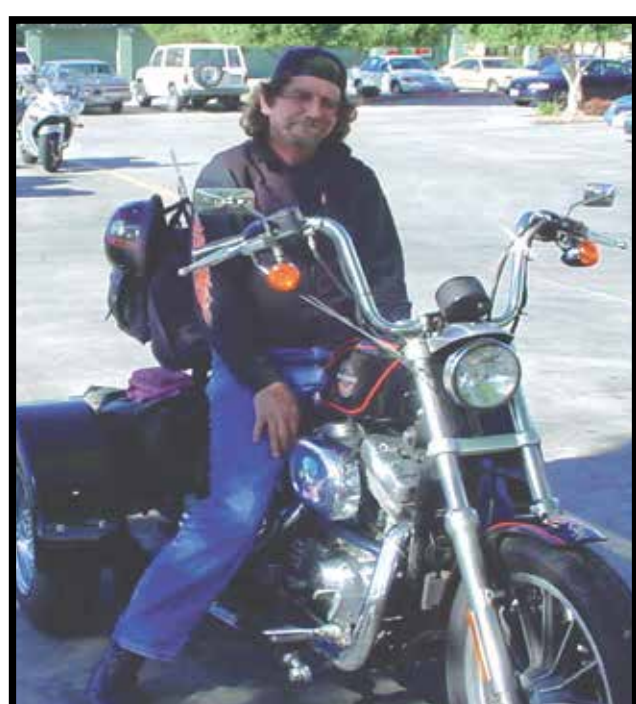

Two separate recall efforts launched against California Gov. Newsom, but face steep uphill battle

FRESNO, Calif. (KFSN) -- Two Republican politicians have launched separate efforts to recall Gov. Gavin Newsom, (D) California, but political analysts say their chances of success are slim for now.

Current congressional candidate Erin Cruz, from the Palm Springs area, launched her petition first in early August, accusing the governor of mismanaging the state and criticizing his support of certain policies. She specifically cited his Medicare for All proposal and laws helping immigrants living in the country illegally.

The secretary of state approved a second petition later in August from former congressional candidate Dr. James Veltmeyer, from the San Diego area. It says Gov. Newsom has violated the public trust in four areas: Health care for undocumented immigrants, tax increases, homelessness, and sanctuary state and cities policies.

History would indicate both petitions are facing a steep uphill battle, trying to take down a governor [who won 62% of the vote](#) just a year ago, but [a recent poll by the Public Policy Institute of California](#) showed his job approval ratings down to 44% in September.

But political analyst Mark Keppler, the executive director of the Maddy Institute, tells Action News, "Newsom is doing quite well," even in the PPIC survey, where 32% of participants disapproved of the governor. "The quick answer is, no, Newsom has nothing to worry about."

Why wouldn't he worry? It's very easy to [start a recall petition in California](#), but difficult get the recall on the next ballot. They need to get enough verified signatures representing 12% of the number of voters who cast ballots in the previous election. In this case, the petitions need almost 1.5 million verified signatures.

Thesecretaryofstate'sofficehasnotverifiedanysignaturesyet,butitsfirstcountofunverifiedsignaturesshowedtheCruzeffortaccumulatingfewerthan17,000signaturesinitsfirstmonth.

Organizers pointed to almost 4.5 million votes for President Trump in California's 2016 election, a reason for hope.

"I think we're doing excellent," said Cruz petition organizer Monica Gallagher. "I'm confident we'll make it to 1.5 million."

Over the last 106 years of governance in the state of California, petitioners have launched 165 recall efforts, [according to the secretary of state's office](#). Nine have qualified for the ballot. Five have succeeded. Gov. Gray Davis was the only person to lose a statewide office because of a recall.

"Gray's situation had to do with a car tax and some other issues, like a failed deregulation rollout," said Keppler.

Leaders of the current petition efforts point to some similar circumstances for Newsom after [PG&E cut power to more than 500,000 Californians](#) citing wildfire dangers.

"34 counties losing power is worse than Davis' rolling blackouts," said Andrew Russo, an organizer for the Veltmeyer effort. "Nero fiddled while Rome burned. (Newsom is) our version of Nero. He's fiddling while California burns."

But 156 of 165 recall efforts failed before even getting to the ballot -- 95% of them.

"The hurdle for filing these efforts is the money it takes to collect the signatures," Keppler said. "And with so many propositions likely to appear on the 2020 November ballot, my guess is that the cost per signature is going to be fairly high. As a result, only those with deep pockets can really afford to lead these recall efforts."

Cruz is relying solely on volunteers to collect signatures, [mostly at permanent locations](#) throughout the state, like gun stores and other businesses. They're also doing special events, like the Merced County Tomato Festival and an October 19 collection at State Foods Marketing in Madera County.

[Dr. Veltmeyer's petition effort](#) is using paid signature collectors because they say that's the only way to get the results they need.

"The best volunteer effort in California has only gathered less than 700,000 signatures," an organizer told Action News. They're aiming for 2 million to account for signatures they won't be able to have verified.

Havingtwoseparatepetitionsmayalsobeanissue.Theycan'tcombine their petitions now, but both sides tell Action News they tried to coordinate and join forces before launching separate efforts.


Leaders from both recall efforts acknowledge confusion about the separate petitions. They recommend people sign both. And they're hoping to pick up steam as voters learn more about the bills just passed by the Democratic state legislature and signed by Gov. Newsom.

Recall efforts are just a fact of life for governors in California, especially since voters recalled Davis in 2003. Seven petitions tried to terminate his replacement, Arnold Schwarzenegger. Five recall petitions targeted Jerry Brown during his second stint as governor.

Political analysts say a lot of the petitions are just a way for candidates for other offices to get their names in the public eye. Cruz, who ran for U.S. Senate in 2018, is running for Congress in 2020. Veltmeyer ran for Congress in 2016 and 2018 but is not currently seeking office.

"We believe it would/could be beneficial for congressional and other candidates to fund this effort - much like Darrell Issa did in 2003," said an organizer with Veltmeyer's petition. "Plus, candidates can certainly use the issue as a campaign platform and fundraising pitch."

"This is a way to encourage Republicans to turn out to vote since they want to retake some of the close races they lost," like the 21st Congressional seat David Valadao narrowly lost to Democrat T.J. Cox in 2018, said the Maddy Institute's Keppler. "Given the low Republicans statewide registration, it is unlikely that they were able to win any statewide races."

JUDGE DISMISSES COUNTY AS DEFENDANT IN TWIN PEAKS LAWSUIT: A federal judge has dismissed McLennan County as a defendant in a civil rights lawsuit filed by three bikers arrested after the 2015 Twin Peaks shootout, but ruled the plaintiffs can pursue claims against the city of Waco and seven individual defendants.

The lawsuit, filed by the three bikers who were never indicted in the deadly shootout with law enforcement, is one of about 20 pending Twin Peaks civil lawsuits involving about 130 bikers with claims of unlawful arrest and conspiracy.

The plaintiffs allege former McLennan County District Attorney Abel Reyna was the final policymaker for McLennan County regarding the events at Twin Peaks, but U.S. District Judge Alan Albright ruled that a county sheriff, not the district attorney, is the final policymaker.

The lawsuit alleges Reyna was the county's final policymaker because he "was responsible for devising the overall prosecutorial goals and strategies" of the county on the day of the shootout that left nine bikers dead and 20 injured in a hail of police gunfire, but the judge ruled that "regardless of Reyna's involvement in helping to decide whether the arrests should be made, he did not have authority to make municipal policy."

The judge denied the city's motion to dismiss the lawsuit. The order leaves claims pending against D.A. Reyna, as well as the former Waco police chief, assistant chief and various named officers.

More than 200 bikers were jailed on identical arrest warrant allegations. Only one case went to trial, which ended in a hung jury favoring acquittal and a mistrial. District Attorney Barry Johnson, Reyna's successor, dismissed the remaining charges against the bikers.

According to a report by Tommy Witherspoon in Insane Throttle Biker News (www.harley-liberty.com), the lawsuits allege the defendants violated the bikers' Fourth Amendment rights

by obtaining arrest warrants based on a fill-in-the-name affidavit that lacked probable cause. They also allege defendants violated their 14th Amendment due process right to be free from unlawful arrest.

Insane Throttle was recently awarded the Silver Spoke Award for Media at the 2019 National Coalition of Motorcyclists' NCOM Convention in Orlando, Florida.

PROPOSED IOWA ORDINANCE WOULD ALLOW ATVs ON COUNTY ROADS: A committee in Linn County, Iowa is working to pass a new ordinance that will allow ATVs to be driven on county roads, despite concerns about having off-road vehicles sharing the streets with regular vehicles.

County Supervisor Brent Oleson said a committee approached him about the ordinance, saying that "I'm all for not taking anything off the table, anything that gets people outdoors can only have positive benefits."

But Sheriff Brian Gardner told TV9 that combining ATVs and regular vehicles on the same road is just too dangerous. "They're off-road vehicles, and they're designated as off-road vehicles for a reason."

Oleson says they're going to look at what works for ATV ordinances in other areas, and hopes to have something passed before spring.

Right now, unless a town or county passes an ordinance allowing it, ATVs can only be driven on one of Iowa's eight riding parks or on private property. ATVs are also allowed to cross streets, with some restrictions.

VIRGINIA BECOMES 15TH STATE TO CREATE AN OFFICE OF OUTDOOR RECREATION: Virginia Governor Ralph Northam (D) has announced the creation of an Office of Outdoor Recreation to lead efforts to promote the outdoor recreation industry in Virginia and recruit new outdoor businesses to the Commonwealth.

The outdoor recreation industry contributes nearly \$22 billion annually to the Virginia economy, and employs more than 197,000 Virginians. Virginia will be the 15th state in the nation to establish an office or task force dedicated to strengthening the outdoor industry, and the third on the East Coast.

"Every region of our Commonwealth is home to unique outdoor assets and recreation opportunities, which continue to earn national praise and are sought out by millions of travelers each year," Gov. Northam said. "In establishing a statewide Office of Outdoor Recreation, we are taking significant steps to recognize the importance of this industry as a true driver of economic development in the Commonwealth, and demonstrate why Virginia is the natural fit for outdoor business. Outdoor recreation not only improves the growth potential of our communities, but it also aligns with our goals on land conservation, workforce development, and public health."

The Office will lead an effort to grow the outdoor industry in Virginia through industry promotion, coordination, and recruitment.

NATIONWIDE MOTORCYCLE THEFTS DECREASING: While motorcycle theft has been a significant problem in the US, the latest National Insurance Crime Bureau report indi-

cates that motorcycle thefts across the country went down in 2018, and in fact have been on a steady decline since 2016 after experiencing an uptick the previous two years.

A total of 41,674 motorcycles were reported stolen in 2018 compared with 44,268 reported stolen in 2017 -- a decrease of six percent.

By manufacturer, Honda was the most stolen bike brand, followed by Yamaha, Suzuki, and Kawasaki. Harley-Davidson rounded out the top five.

Unsurprisingly, motorcycle thefts in the US are at their peak during the summer months, with August, July, and September, in that order, seeing the highest number of thefts, and with about half as many bikes stolen in February 2018.

The report also gives a state-by-state breakdown, and notes that thefts are more common in large metropolitan areas as well. California leads the country in motorcycle thefts, with 7,035 occurring in 2018, followed by Florida with 4,279 thefts reported, then Texas (3,073), New York (1,777) and South Carolina (1,743). By city, New York City led the way with 1,310, then Los Angeles with 628, Miami (595), Las Vegas (540), and San Diego fifth with 527.

A total of 16,261 bikes were recovered from thieves in 2018, or about 44% of those stolen.

STUDY SHOWS MOTORCYCLES MOST LIKELY VEHICLE TYPE IN U.K. TO BE STOLEN: One in every 46 registered motorcycles in the United Kingdom (UK) was stolen last year, according to new figures gained by a Freedom of Information (FOI) request by the Motorcycle Action Group (MAG). In London, one in every 12 bikes was reported stolen in 2018.

While the countrywide figure actually signals a modest 3.98% improvement over 2017, the national average of one in 46 still means that motorcycles are seven times more likely to be stolen than any other road vehicle!

"For a biker, the theft of their bike is definitely not a victimless crime," said Colin Brown, MAG's Director of Campaigns & Political Engagement. "More so than for any other mode of transport, riders become emotionally attached to their bikes. For some, the loss of a bike is akin to the loss of a family member."

With an average 500 bikes stolen a week in 2018 motorcycles remain the most commonly stolen vehicle in the UK, seven times more likely to be nicked than anything else, which is why security firms are coming up with ever-more sophisticated locks.

NEW HAMPSHIRE TO MODERNIZE DMV IN WAKE OF DEADLY JUNE CRASH: Following the deadly June 2019 crash that killed seven motorcyclists in New Hampshire, officials want to work with other states to prevent anything like this from happening ever again.

The truck driver currently facing seven charges of negligent homicide in those deaths -- who had a Massachusetts-issued CDL -- should not even have been driving, according to his combined driving record. The head of the Massachusetts DMV resigned and others at the agency were fired once this came to light.

Over the past few weeks, New Hampshire has also been conducting an internal review of its

own DMV records and practices. On August 29, 2019, NH governor Chris Sununu gave a press conference with other top officials to share their findings. The results: nearly 4,000 drivers will have their licenses suspended following a review of over 13,000 out-of-state notices, as well as a backlog of 62 commercial license notices dating back to 2016.

One unintended and potentially good consequence of this terrible accident is that it's led New Hampshire to modernize its DMV system and automate notices, so that paper backlogs like this can't build up in the future. Additionally, the governor is now pushing the state legislature to allow the NH DMV to become part of a computerized state-to-state driver verification system using Real ID.

One of the biggest issues that the terrible crash brought to light is that truck driver Volodymyr Zhukovskyy had a number of driving offenses spread across multiple states -- that obviously didn't communicate effectively with one another. Creating processes that enhance communication of driving offenses across state lines seems like a logical step toward preventing catastrophes like this in the future.

EURO5 EMISSIONS RULES EXPECTED TO BRING TECH PROGRESS: The latest European emissions limits (Euro5) will be introduced from the start of next year on, and while many naysayers preach gloom about tightening emissions laws, others predict that they will spur development, creating bikes that are measurably better than their predecessors.

Euro5 is the fifth iteration of European emissions limits that have gotten steadily stricter since the original Euro1 came in 1999, and the newest limits represent an astounding improvement over the two decades since: compared to the current

Euro4 limits, Euro5 levels are down by a third.

The big news is the introduction of a limit for 'non- methane hydrocarbons' (NMHC) -- quite literally hydrocarbons that aren't methane -- which wasn't measured before. NMHC makes up most of a bike's HC emissions, so the 0.068g/km limit is a particular challenge. To reduce HC emissions in high-revving performance engines as well as at low revs, expect to see an explosion in the use of variable valve timing (VVT) as well as higher capacity engines to reduce reliance on higher revs; both of which will boost performance.

On the downside, as the bikes get more impressive, they'll also be more complicated, making them more costly to produce, and making maintenance more expensive.

As before, Euro5's introduction is staged. New models from January 1, 2020 must meet the limits but manufacturers have an extra 12 months to adapt existing designs.

Brexit won't exclude the UK from compliance, as they're already committed to remaining aligned with EU rules and other non-EU countries such as India and China are adopting similar standards.

FRENCH ROLL OUT 'NOISE CAMERAS':

France has begun tackling loud motorcycle exhausts, by installing a 'noise radar' capable of identifying the offending vehicle, with the device linked to Police CCTV cameras in order to automatically issue fines.

In the UK, the Department for Transport has likewise announced that they will be trialing new 'noise cameras' in a bid to cut down on illegal exhausts.

REAL ID Enforcement Begins in One Year – Are You Ready?

New federal ID requirements to fly within the U.S. and enter secure federal facilities fast approaching

Sacramento – The California Department of Motor Vehicles (DMV) reminds Californians who fly within the United States or enter secure federal facilities and military bases that they will need a REAL ID driver license or identification card, or [other federally approved document](#), to pass through security checkpoints starting one year from today – **October 1, 2020**.

A REAL ID driver license or identification card is the result of a 9/11 Commission recommendation to establish minimum standards for identity verification and security features on driver licenses and identification cards issued in all 50 states. A gold bear and star indicates your California driver license or identification card is REAL ID compliant.

To obtain this next generation of federally compliant identification, applicants must visit a DMV office and bring the following:

- One proof of **Identity** – Original or Certified
(Valid passport, birth certificate, etc.)
- One proof of **Social Security** number
(Social Security card or W-2 form showing entire number)
- **Two** different proofs of **California Residency** showing street address
Paper documents required.
(Utility or cell phone bill, bank statement, mortgage bill, etc.)

To view a complete list of acceptable application documents visit REALID.dmv.ca.gov.



You may not need a REAL ID to fly or enter secure federal buildings if you currently have a valid passport, military ID, Global Entry Card, or other federally approved document. While a passport may allow you to fly within the U.S., the REAL ID does not replace a passport for travel outside of the U.S.

The DMV encourages you to wait until your driver license or identification card is up for renewal to apply for a REAL ID. However, if your card expires after the October 2020 enforcement date and you need a REAL ID sooner, apply now!



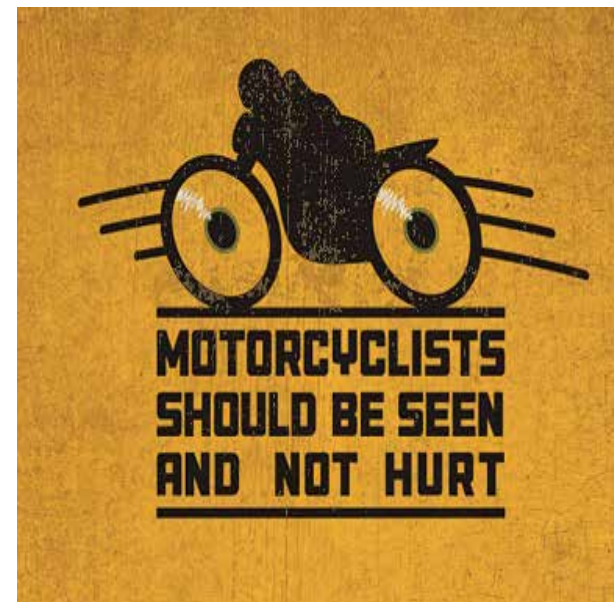

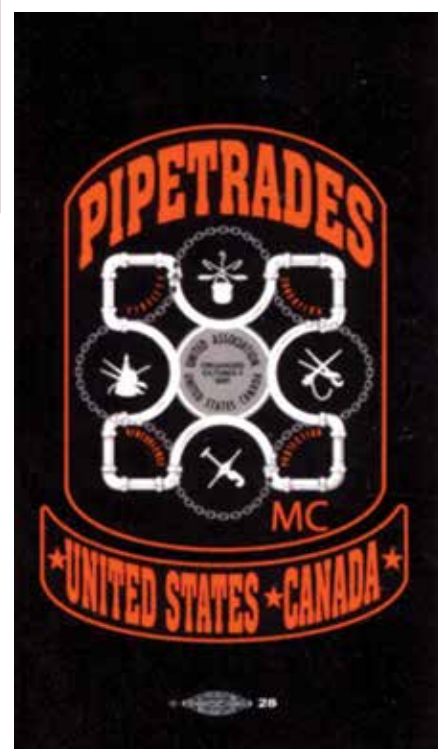
