



## Lobbyist's Report

The Legislature is in recess until January 4, 2016, which also is a major **ELECTION YEAR!** Although the Legislature can return since Governor Brown already called for two Special Sessions for the Legislature that ran concurrently with the regular session that just ended. One dealt with transportation funding for our pathetic potholed road system and the second one to deal with health care funding. Neither session produced any legislation that reached Governor Brown's desk.

Now because of the disastrous Northern and Central California wildfires that have caused more property damage than any of the many fires this year in the Western United States, he could again call for the Legislature to return to deal with any or all three of these issues!

SB 350 was passed, but stripped of the mandate for California to reduce its petroleum use by 50% in only 15 years. If that would have passed, it would have likely affected motorcycle emissions and gas consumption, even though motorcycles already get two to three times the fuel efficiency than the average car or light truck. It would have ignited a battle for the motorcycle industry and us, California's motorcycle owners and operators, to demonstrate that our mode of transportation is already doing its fair share when it comes to carbon-based petroleum use!

SB 350 is now limited to increasing energy efficiency in buildings and calling for higher amounts of electricity from renewable sources.

Stay tuned and thanks to all who contribute to the dedicated Lobbyist fund to keep me in the Capital!

Meanwhile, it's the final quarter of the year and events like the Love Ride in October are the perfect venues to get members.


Remember, always keep your members informed. Give them membership renewal trinkets; that could be a thank you for sticking with your Local and ABATE of California email.

by Lee "Sporty" Milligan


Hi all! That time again. Sporty's Rides brought to you by the able body of Sporty Milligan.

### MONGOLS MC PATCH FORFEITURE CASE DISMISSED:

In a long-awaited decision with ramifications that could affect all patch-wearing clubs, on September 16, 2015 Federal District Judge David O. Carter issued a dismissal of the government's most recent attempt to seize the Mongols Motorcycle Club's name and patch.

In the case titled United States of America versus Mongols Nation, Judge Carter saw the key legal question in the case as the "distinctness" between a "person" and "an 'enterprise' that is not simply the same 'person' referred to by a different name."

In layman's terms, the good news is that the government's indictment is hereby dismissed pending appeal, which appears unlikely.

"We won," said Richard Lester, a California-based attorney who has rallied support for defense of the patch forfeiture case through various Confederations of Clubs around the country and the National Coalition of Motorcyclists, organizations he helped to establish. "We didn't win the day on key legal points, and the court's decision didn't make the statement we wanted to make in defending the patch, but we won."

The protracted litigation against the Mongols MC on racketeering charges began October 21, 2013 when the indictment against the club was unsealed. Although the club won its first trial, the judge's ruling was poorly written and welcomed the charges to be properly re-filed.

While the constitutionality of seizing the Mongols insignia -- or the insignia of any motorcycle club -- remains unresolved under the dismissal, Judge Carter did rule that the government cannot indict a club as an "enterprise" for racketeering without also indicting a group who can be actually punished; noting that the indictment makes "no meaningful distinction between the association Mongol Nation and the enterprise of the Mongols Gang," which is good news for



all motorcycle clubs.

The prosecution, and subsequent persecution, of the club as a whole was designed to bankrupt the Mongols with mounting legal fees, but money has been raised by both the Mongols club and through the "Save the Patch" effort launched by the COCs and NCOM, and the Trademark Defense Fund I will continue to accept donations until the enormous debt is retired or if needed for a governmental appeal.

### CONGRESSIONAL MEASURE ADDRESSES MOTORCYCLIST SAFETY:

A Congressional sub-committee has approved two motorcycle safety measures for inclusion in the federal highway bill; one to de-fund motorcycle-only checkpoints, and another to prohibit the DOT from lobbying on any pending legislation.

On September 10, the Subcommittee on Research and Technology of the U.S. House Science, Space and Technology Committee passed the two amendments to the "Surface Transportation Research and Development Act of 2015" to be incorporated in the House version of the surface transportation authorization bill.

Amendment No. 036 directs a study to be conducted to determine the most effective methods of preventing motorcycle crashes, and further bars federal funding to states to conduct motorcycle-only checkpoints until the research is completed.

Amendment No. 037 prohibits the Department of Transportation from lobbying on any pending federal, state or local legislation. The current "NHTSA Lobby Ban" only prevents the federal DOT from lobbying at the state level.

The U.S. Senate's version of the highway funding bill already contains language to prohibit federal funding of motorcycle-only checkpoints.

### NTSB CALLS FOR COLLISION AVOIDANCE SYSTEMS FOR ALL VEHICLES:

In a report released June 8, the National Transportation Safety Board outlined the life-saving benefits of currently available collision avoidance systems, and recommends that the technology become standard on all new passenger and commercial vehicles.

"You don't pay extra for your seatbelt," said Chairman Christopher A. Hart. "And you shouldn't have to pay extra for technology that can help prevent a collision altogether."

NTSB's Special Investigation Report, "The Use of Forward Collision Avoidance Systems to Prevent and Mitigate Rear-End Crashes," stresses that collision avoidance systems can prevent or lessen the severity of rear-end crashes, thus saving lives and reducing injuries.

According to statistics from the National Highway Traffic Safety Administration (NHTSA), rear-end crashes kill about 1,700 people every year and injure half a million more. More than 80% of these deaths and injuries might have been mitigated had the vehicles been equipped with a collision avoidance system.

Citing slow progress as a major safety issue, the report notes that a lack of incentives and limited public awareness has stunted the wide adoption of collision avoidance technology.

Only 4 out of 684 passenger vehicle models in 2014 included a complete forward collision avoidance system as a standard feature. In the report, the NTSB recommends that manufacturers make collision avoidance systems standard equipment in newly manufactured vehicles.

**MISSOURI MOUNTED PLATES:** In a measure signed into law on July 13 by Missouri Governor Jay Nixon, SB254 modifies provisions relating to motor vehicle license plates, allowing trailer and motorcycle license plates to be mounted horizontally or vertically on the left rear of the motor vehicle.

### NEW YORK ADVENTURE LICENSE PLATES:

The New York State DMV has unveiled the 9 new "I LOVE NY Adventure Custom Plates" designed especially for motorcycles. There are three themes (hunting, fishing, and parks) for a total of nine new designs that are available to anyone holding a valid Department of Environmental Conservation sporting license or Parks Empire Passport.

The NY DMV also offers custom motorcycle plates for military and veterans, police organizations, medical doctors, the AMA and HOG. Historical and vintage motorcycle plates are also available.

**PAINTED MESSAGES AT ACCIDENT SCENES TO SPARK AWARENESS:**

Coroners in six counties in North Carolina will soon use a stencil to spray paint on the road a cross and message that says; "Look Twice Save A Life" at the scene of all deadly motorcycle accidents.

Anderson County Deputy Coroner Don McCown said he hopes this warning message prominently displayed at fatal accident sites will increase awareness and decrease the number of accidents involving motorcycles.

"We're hoping it will remind the public that someone died at this location, and more than likely they died of distracted driving or someone not being aware of their surroundings," explained McCown, adding that the number one reason given for most deadly motorcycle accidents is that the driver never saw the rider. "There are a lot of motorcycle riders out this time of year and we have to share the road."

**ALLSTATE DONATES WARNING SIGNS AT DANGEROUS INTERSECTIONS:**

Allstate insurance company and its engineering partners are working closely with local traffic authorities to review available crash data and to identify intersections with a high number of multi-vehicle crashes involving motorcycles. Allstate then donates warning signs to be installed at the site with the intent of elevating awareness of motorcycle incidents that would not be readily apparent to a driver.

The warning signs used in the campaign are yellow diamond warning signs that read "Watch For Motorcycles." Allstate worked in conjunction with the Federal Highway Administration to design the current sign to ensure compliance with section 2A.06 paragraph 13 of the M.U.T.C.D.

The NHTSA (National Highway Safety Administration), in their Fatality Analysis Reporting System, supports the Hurt Report's findings, showing 46% of all multi-vehicle motorcycle crash fatalities

(8,107 out of 17,470 fatalities from 2006-2012) occurred at intersections. This data shows that, on average, three motorcyclists are killed every day from multi-vehicle crashes at intersections in the US.

**MOTORCYCLE HELMET CAMERAS "ILLEGAL" DOWN UNDER:**

A motorcycle rider "down under" unsuccessfully challenged a citation for using a camera attached to his helmet, setting an important legal precedent for riders in the Australian state of Victoria.

Victorian police cited a technicality within the rules to argue the camera was an "unauthorised alteration" to an otherwise Australian Standards-approved helmet. Items that protrude more than 5mm from the helmet surface are deemed illegal attachments, the police argue, and therefore render the helmet non-compliant with the Australian Standards.

In other words, as far as Victoria Police were concerned, it's as if the rider wasn't wearing an Australian Standards-approved helmet at all. In all Australian states and territories, motorcycle riders must wear a helmet approved by Australian Standards while riding.

As a landmark ruling by a Victorian court, the decision effectively bans motorcycle riders in that state from wearing helmets with cameras attached, but meanwhile police in other states enforce the laws much differently.

So while riders in Victoria are now fair game and have even reportedly been fined for attaching tinted visors to their helmets, and New South Wales police have already been targeting riders for wearing cameras, police in Western Australia and Queensland wear helmet cameras themselves -- the very act that has seen motorcyclists fined in NSW and, now, Victoria.

"Riders tell us they wear helmet cameras to improve their safety while on the roads and that drivers and other road users show more care when there is a camera in use," said the rider's lawyer, who is considering an appeal. "Riders should not be penalized for trying to improve the safety of their riding," he said, adding that cameras are also ideal for capturing evidence during a collision.

**CIVIL FORFEITURE LAWS LEGALIZE PROPERTY SEIZURES:**

The recent attempt by the government to seize the patches of motorcycle clubs has focused attention in the motorcycle

world on civil forfeiture laws. What started off as a measure to cripple drug kingpins and crush their criminal empires by confiscation of their property has morphed into an often abused law enforcement tactic that harms blameless citizens.

"Civil forfeiture" is the legal procedure which allows police to seize property suspected of being related to a crime, and in testimony given before a citizen commission, one police chief was surprisingly frank in referring to assets seized as "pennies from heaven," and said the money acquired was sometimes used to buy "toys" that the department could not usually afford.

Under state and federal law, police departments can seize and keep property that is suspected of involvement in criminal activity. Unlike criminal asset forfeiture, however, with civil forfeiture, a property owner need not be found guilty of a crime -- or even charged -- to permanently lose their cash, car, home, or other personal property merely on suspicion that a crime might have been committed.

No hearing is held prior to seizure, which occurs abruptly without any notice or warning whatsoever. Although civil forfeiture doesn't draw criminal charges against the owner, it does deprive him of his property without due process based solely on an officer's "reasonable suspicion," and a portion of the assets seized typically is retained by the police departments who seized the property in the first place.

In 2012, \$4.5 billion was acquired via civil forfeitures in tens of thousands of instances nationwide, and in most cases the value of the assets seized was less than what it would cost to hire an attorney to go to court to win it back.

Asset forfeitures have been abused by many police departments, but like the Mongols MC and other motorcycle clubs, citizens are starting to fight back. Americans from all sides of the political spectrum have started to expose the dangers of civil forfeiture, and members of Congress from both sides of the aisle have introduced legislation to reform the federal civil forfeiture laws. Reforms of state laws have also been called for.

**Tech Tips  
by Craig Griswold**

**Cruel Shoes**

While designing the Twin Cam engine, the Motor Company was faced with several challenges, not the least of which was reducing emissions. When we think of emissions, we usually think of exhaust. While that is at the top of the list, noise emissions are a significant challenge to the engineering process. Ever increasing EPA restrictions on noise and exhaust emissions force manufacturers to rethink the design process.

Harley's reason for going back to two cams was simple. This allowed a reduction in the angle of the lifters and pushrods. The pre-Twin Cam engines had significant side loading of the lifters due to the angle of the pushrods, especially the front cylinder exhaust lifter. It was not uncommon to have one or more of those lifters go south before the 50,000 mile mark. The system to drive the new two cam set-up had to be different than the previous gear drives of the past in order to pass noise emissions. The answer was a "silent chain drive." Picture 1 shows the set-up used from 1999 to 2005.

The first systems from model year 1999 to early 2000 had trouble with cam bearing failures. It was discovered that the rear cam bearing, which was a ball bearing, could not handle the radial tension or side forces. The fix was a replacement with a roller bearing. It was also discovered that the tensioner shoes were wearing out beyond service life as early as 30,000 miles. There was no consistency in the shoe longevity. Some would last over 60,000 miles while some were completely gone by 30,000. The problem then becomes a cost issue as most shops charge one half to a full hour of labor to inspect the shoes. Most shops will recommend inspection every 20,000 miles.

In 2006 (Dynas only, 2007 all big twins), HD redesigned the cam support plate, chains, shoes, and oil pump. The new shoes are now utilizing a hydraulic tensioner, a much improved design over the spring tensioner it replaced. The chains were also changed to a roller style, which are less abrasive (see picture 2).

The good news for all you pre '06 folks is that there are several options to retrofit the new hydraulic system to your bike. Andrews sells conversion cams that can be used with the new plate and tensioners. Harley's Screamin Eagle line has a complete kit which allows the use of the pre 2006 cams. This is a nice option if you want to continue to use your existing cams.

Another option is the gear drive system offered by S&S (see picture 3). Although a bit more costly, there are no concerns with wear. They can be a bit noisy. Depending on gear fitment, a whine or tick similar to worn lifters may be heard. Gears should be measured to ensure the best fit possible. Pinion shaft run-out is a criteria with gear drives as well. Pay close attention to S&S's instructions. If run-out exceeds specifications, the gear drive system cannot be used (see picture 4).

Deciding which system to use depends on performance requirements, cost, and even annual mileage. If you're mostly interested in keeping your bike stock, and put very few miles on the odometer, why spend the cash? More radical set-ups would be better served with gear drives. Ask a reputable shop before spending that hard earned cash.

# Motorcycle Safety Report

## Preparation is a Good Thing

We've had a great summer of riding. At this time of the year it's still hot during the day and it gets darker earlier. In some areas it cools down 20-30 degrees after the sun goes down, especially in the mountain zones and on the coast. Do you prepare for these changes of temperatures or do you grind it out? I have been caught in the Big Bear forests at sunset and the temperatures change fast. As soon as the sun goes down, it's suddenly jacket time. Me and my bud got caught and nearly froze our asses off while riding down the back side of the mountains. It was a race we were forced into. We never thought about checking out the weather conditions because it was still summer - at least in our city 150 miles away.

As soon as the sun was eclipsing the mountains, we felt it. As soon as the shade hit us, so did the weather. We hopped on our bikes and rode as fast as we could. We thought the high desert would warm us up, but it didn't. We had to ride even faster because we thought being cold for a shorter time would be best. It wasn't until we reached Little Rock that it started warming up. We stopped for some hot coffee and laughed at ourselves - we both had saddle bags and nothing in them! We were prepared for the hot day and didn't think about bringing a jacket or extra layers of clothes; it was definitely a mistake.

I guess you can say we learned the hard way; to grind it out while practically freezing as we rode. It really hurt and I had to focus on riding even more because I was feeling thick and sluggish. I knew we had no other choice because the back roads were dark and they had no asphalt shoulders to pull over onto and the sand/dirt shoulders just didn't look good enough for me while riding at a fast speed (so fast I can't tell you because it would be an admission to guilt!) As we rode south past Palmdale it warmed up and I was thinking to myself how unprepared I was. We didn't plan this road trip, we just decided to go thinking it was all good.

Being prepared is now my first agenda! Knowing where I'm going, checking the local weather report and road conditions, especially when the season starts changing or when you're going somewhere that has climate changes from day to the evening. With all the modern technology out there it's very simple to do. My cell phone is the best pocket companion that one could want, with all the apps it has all I need to do is remember to keep it charged and bring it with me. You all know you have the whole wide world at your access pretty much anywhere you ride. When I think about it, my cell phone is actually a tool that I use. You could even claim it as a safety device, with all of its features and apps you just can't go wrong. I, like many others, have made that techno jump even though I'm considered an old fart of a distant generation. If I have modern day technology issues, I have kids that can square me away easily. My favorite riding zones is the high desert (not when it's blazing hot)



and the mountains. Now that I know how to plan them out, I am always fully prepared.

Because I have family in the Apple Valley area, the high desert calls me to ride or drive out there year-round. The Pear Blossom Highway (138) is always an awesome ride. The last few months I've been going out there (July & August) I've noticed a small sign, out in the middle of nowhere, on the side of the highway, one word, "Flooded"! My brain clicked and I remembered they talked about flash flooding in the high desert areas. I was concerned because they reported it the night before. I started to notice in all the depressions mud and water and some wash out that leached out onto the road. Some areas were bad that I changed my mindset about how I was riding. All of a sudden I noticed that the deeper depressions had more dirt/mud still on the roads. I didn't see any clean up crews and now I had to approach these depressions with caution. It seems that the depressions were kind of like creek beds to the left and right of the highway and, as we all know, it hardly rains out here, but it does. Because I saw the sign, and no clean up crews or work that had been done (at the time), it was all on me, as well as anybody else, to ride safely.

I remember back in the day when I only had a motorcycle for transportation. I was working in New Mexico and living in El Paso. It was an 80 mile roundtrip ride that was in the high desert on only a two lane highway. It was raining, I don't mind riding in the rain and I have a lot of experience. I was cruising around 80+ miles per hour (NOT a safe speed in the rain) on a straight stretch of road when I saw it from about a quarter of a mile out, a flash flood crossing the highway. It was as high as a car rooftop then flattened out real fast. The mountains were on the right side of the road about a half a mile from the road, but had a good grade to the highway. I kinda freaked out, but then my brain kicked in real fast. I started braking and down shifting, then I braked harder as I felt I had good control of my bike while still downshifting. I made sure I was not downshifting at too high of a speed that would cause my rear

tire to lock momentarily. Because of the wet road, I knew if I did my bike would probably slide out from me or I would lose control (I learned while dirt bike riding, the dirt is the same as a wet road). I couldn't stop before I hit the wash out. I was doing around 15 mph and I didn't panic as I was now in the mud running over small rocks and other debris, I didn't stop at all, just kept it going until I cleared that wash out, then I stopped. I got off my bike, lit a cigarette and calmed down while looking at what I just went through. I was glad I didn't over react or panic. I thought about all the trials and errors of my dirt bike riding days and I was glad that what I had learned in the past helped me out that day.

I always say, "It happens that fast!" Riding in the rain is dangerous, but can be done safely. I'm pretty sure we've all been caught in the rain, from light to heavy. You've got to have confidence and trust in your skills. I know some people who freak out and won't ride in the rain even if they're caught in it. It's not a bad thing if you know your limitations, then stick to them. In one of my previous articles I talked about practicing hard braking and downshifting at different speeds. I also talked about locking your rear tire from low speeds to higher speeds so as you can feel what your bike does when you do these things. It's important to do, it's how you raise your skill level to handle any situations that could happen really fast and build your confidence up to handle them!

As the seasons change, just be prepared in advance. With all the talk of us having a big El Nino' season, who knows what we will be riding in. This is a great time of the year to ride, second only to spring. Ride smart, and ride safe!




