

The Legislature has adjourned for their summer recess and finally (for the first time in 8 years) passed out a State Budget, on time, that Governor Brown promptly vetoed. The first attempt was a State Budget that wasn't balanced, causing Legislators not to be paid or receive their \$140.00 each day tax free per diem payment for living expenses.



The restoration of their pay and fringe benefits is the main reason the legislators finally passed and sent to Governor Brown a more realistic, cuts only, Budget that he signed. OH YES — AND THEN, THE LEGISLATORS STARTED TO GET PAID! The budget they passed, however, has

triggers that will go into effect and cause further reductions to money for schools and other state funded programs, should state revenues drop in the pay me. I appreciate it even more in these espenear future. So expect them back in October or November dealing with the state budget, once again.

A huge battle is brewing in early January to get ABATE's AB 1047 passed. This is the bill, by Assembly Transportation Committee Vice Chairman Kevin Jeffries (R-Murrieta), that will prohibit all California law enforcement agencies from using Grant money from the feds or the state Office of Traffic Safety to fund the setting up of "motorcycle only" traffic "safety" checkpoints. This is pure discrimination and profiling against lawabiding motorcyclists and has to stop NOW!

To demonstrate how out of control the use of this grant money has become, the City of Citrus Heights just announced that their "motorcycle safety" checkpoints will check for *loud mufflers*, courtesy of overtime money and sound meters provided by money from the Office of Traffic Safety. It's a real stretch to claim that loud mufflers are safety hazards; actually many bikers feel it's the other way around — Loud Pipes Save Lives!

ABATE's helmet law repeal bill, AB 695 will also be up for a vote at that same hearing. THE ONLY WAY EITHER OF THESE BILLS WILL BE PASSED IS IF YOU'RE WILLING TO COME AND SHOW UP AND FIGHT FOR THEM! THE HEARING ROOM AND CAPI-TOL HALLS NEED TO BE PACKED WITH **BIKERS!**

We are planning a rally at Noon on January 9th on the South steps of the Capitol where we

have had our rallies before! This will allow us to reserve the street for parking! If you can't attend, please send some money to pay for parking for those who can come!


Also, when you do your meeting reminders, try to include all your current members, that way they are in the Local loop and will know that you care about all the members in your Local.







STATES GREEN-LIGHT RED-LIGHT

LAWS: Motorcyclists in a growing number of states are being allowed to go through red lights when sensors aren't able to detect they are there. Effective July 1, Virginia became the tenth state since 2002 to give motorcyclists license to proceed with caution after stopping when the device that causes the light to change from red to green doesn't activate, while a similar bill in Illinois sits on the governor's desk awaiting his signature.

HB 1981 by Virginia State Delegate Thomas A. Greason (R-Potomac Falls) allows riders of motorcycles, mopeds and bicycles to treat red lights as stop signs provided they come to a complete stop for two cycles of the light before proceeding with due care when safe to do so.

Illinois Governor Pat Quinn has until August 29 to sign or veto HB 2860 by Rep. Dan Beiser (D-Alton) which would permit motorcycle operators to proceed through a steady red signal that fails to change to green within a "reasonable period of time". 





When you were a kid, did you ever want to be invisible? Well, riding at night comes darn close to it! You know that many car drivers just don't "see" motorcycles and even in the daytime many riders are struck from behind when slowing a lot less after dark, and anyone who has had a drivers have gained skill and experience, but So why didn't Kawasaki use the 2357 bulb in have less night vision and glare recovery, and night road with you! When you are downshifting dawn, the more you are aware and the more you can light-up and reflectorize yourself, the less chance you have of being mowed down.

At night we are looking well up the road, way beyond the puddle of our headlight. We're THIS JUST IN: If you can find them, Sylvania looking for MOTION - the swing of an arm between you and a road reflector or a reflectorized license plate. You'll see that long before the pedestrian comes into view. Constant surface appraisal is the key for spotting oil, water, potholes, rocks and escaped tire treads. Scan for darker or lighter spots in the road where there shouldn't be any.

> Animals are active at night and are pretty much invisible from dusk on. They aren't lit up and don't wear safety vests and you can be right on them before you realize they are there. > After dark you are more likely to have moisture on the road. Even on dry road, at only 40 mph it will take you at least 120 feet to stop your bike (reaction time plus braking distance). If you can't see further than 120 feet and you are running at 50 mph, then there is NO WAY you can stop when a hazard pops into view!

Overdriving your visibility (or ability) into the dark is just as dangerous as overdriving your visibility (or ability) into blind curves in the daylight. You can often swerve around a hazard, but this can sometimes result in an "unexpected improper dismount" and if you're down at night, the next car coming around the curve will probably run you over.

So to go "Peacefully into the Night" be Alert, Be Visible and look for the Invisible.




















Downed Biker Ministry



Time to Re-Tire?

A good set of properly inflated motorcycle tires with good tread keeps us attached to the road and separates us from being just another flying object. The National Highway Traffic Safety Administration estimates that hundreds of thousands of crashes could be prevented if vehicle owners kept their tires properly inflated. This agency recommends checking your tire pressure at least once per month. When you're on a bad idea. According to the U.S. Department of Energy, keeping your tires properly inflated can improve your gas mileage up to 3.3%. And this quote was made before gasoline prices reached four bucks a gallon!

The MSF's "T-Clock Inspection" advises us to check: "TIRES: Tread depth, wear, weathering, evenly seated, bulges, imbedded objects. AIR PRESSURE: Check when cold, adjust to load/ speed". If you do a lot of one-type of riding, such preservative in the rubber compound to keep it as a lot of freeway, your tread will wear unevenly; from hardening and splitting. This material is like part of the tread can wear down while other parts look deep enough. Watch for the "wear bars" in the tread. When you change your tire, invest in a new valve stem.

Depending on the shape and size of the wheel and the valve stem, it can be a pain in the butt to check the air pressure on your bike. "Aw, what the heck, the tire looks round, it must be OK". I bought a small, brass, right-angled valve stem from San Diego BMW that attached to the valve stem on my wife's bike and made her life easier. Some Honda's come with a large L-shaped valve stem that sticks out and simplifies reaching

the stem with a gauge or air hose nozzle. That stem comes with a plastic support to keep the stem from vibrating, and if the stem is installed without that support, road vibrations can cause a crack in the stem and cause an instant "Air-Out". That was an exciting experience!


AccuPressureCaps.com sells a valve stem cap that changes color when the tire pressure starts to get low. If your tire pressure is too low, or too high, the tread will start to cup or bow and a trip, checking the pressure every morning is not make proper contact with the road. That kinda defeats the whole purpose of having good tread. The recommended pressure printed on the side of the tire is there for a good reason.

> Any time a tire starts showing ozone cracks in the sidewall, it's time to replace them right away. Sidewalls operate at some pretty high temperatures due to the bending of the sidewall and any separation on a sidewall can cause catastrophic tire failure. A tire has a wax-like sun blocker. It's that off-color material that seems to show up on your sidewalls for no reason. It protects the compound against ozone which is produced by the sun and also by electric motors. This protectant helps the compound to stay soft. It can be worn away, washed away, and chemically washed/leeched out of the tire.

Do NOT clean your tires with stuff like Armor All. There are a few solutions that detailers use on tires that will not harm the tires, if you are into "pretty" instead of functional, but when applying even these, you can use it on the sidewall but not past the line that separates the sidewall from the tread area.


There are many important round things in life, like Silver Dollars and Crispy Donuts, but the most important are your motorcycle tires! They keep us alive and keep our knees in the breeze! Take good care of your tires and they will take care of you.





Living in a Nowhere Land

"Honest, Officer, he came out of NOWHERE!" That phrase is heard so often at accident scenes and shows that a lot of drivers out there have no idea that there are blind spots all around them that don't show in any mirror. Maybe they've heard about blind spots, but they don't know where they are and certainly don't check them before they make a move! It's up to us to avoid getting caught in their mistakes.

You will be in someone's blind spot hundreds of time each day; the trick is to stay there as short a time as possible. Be aware, watch for head motion or their tires starting to creep towards your lane, have an escape route open; and be ready with your throttle, brakes, and horn if they start to move towards you. Eye contact is good, but how many times has someone looked right at you and then pulled right out in front of you. You know that many drivers have unconsciously programmed themselves to look for cars and they just don't see motorcycles. If you have a headlight modulator on your bike or run with your headlights on high beam during the day, it may help the car drivers to be aware. Many of the older members of the driving society have started to lose some of their hearing (this author included), and the more expensive cars are being produced to be so soundproof that the occupants can just barely hear the siren on a fire truck, let alone your mufflers. Folks who think that "loud pipes save lives" are liable to get a big surprise.

If you are driving through town on a multilane road, and a van or truck going in your direction is waiting to make a left turn at an intersection while you are passing them by in the right lane, you are in a major blind spot of the car coming from the opposite direction that is also making a left turn. Be ready! Bushes, fences, a stopped bus or a parked van, all create blind spots

at any intersection or driveway.


You know about the huge blind area behind a big truck, but there is also a big blind spot just off their right front fender. When you are behind a big truck or next to one, if you cannot see their face clearly in their mirror, then they can't see you!

Car drivers who have decorations, parking placards, or big smelly deodorizers hanging from their rear-view mirror have created a blind spot out in front of them, off to the right side, that will hide a motorcycle or pedestrian until they are almost on them. People who turn their sun-visor sideways to keep the sun out of their side window may not see traffic coming from the left side until it is almost too late. Pickup tucks with caps and big family vans have major blind spots.

You know that tailgaters are also lane jumpers. Keep a special watch on them and the dopes that appear to be yacking on a car phone or texting. When the sun is low on the horizon and glare is everywhere, everybody is in someone's blind spot.

It would be a bit extreme to think we need to shoot flares off in front of us as we're tooling down the road, but if you assume that all the drivers never check their blind spots, are not concentrating on their driving, and may do just about anything at any moment, then you are taking good defensive steps towards keeping out of harm's way. Stay visible and RIDE SAFE.


























To Blink or Not To Blink

California drivers do not need to use their turn signals if no other car is nearby according to a ruling handed down recently by the state's second-highest court. A three-judge panel of the court of appeal found that a La Habra Police Officer was in the wrong when he stopped Paul David for making a right-hand turn in his Chevy SUV without signaling. The Officer was about 55 feet away traveling in the opposite direction

at the time David made his turn. The road was otherwise empty. The Officer charged David with violating Vehicle Code section 22107, which states a signal must be used when "any other vehicle may be affected by the movement."

Because the police car was approaching from the opposite direction when David's vehicle made a right-hand turn away from the officers vehicle, and no other vehicles were present, there was no possible violation of section 22107 the Judge ruled.

This is good information to have on hand if you are ever bagged for turning without signaling, but do we really want to add "to blink or not to blink" into our driving habits? With all of the thousands of thoughts and decisions it takes to successfully pilot your motorcycle through traffic, why would we add "I'm getting ready to turn, so I need to signal continuously within 100 feet (that's about two tractor-trailer lengths) is there any vehicle or pedestrian within a hundred or so feet of the turn? Which direction are they headed? Is there anyone in any of those parked cars who is ready to throw open their door? Is there anyone in any of those parked cars who is ready to flip into a U-turn? Because we know that U-turners never signal their intentions because their cars did not come equipped with a

U-turn signal. Is there anyone in any of my blind spots? OK, it all looks clear, so I guess that I can turn without using my signal"

Man, that is an awful lot of work to avoid just signaling! You should build your driving habits so that when you are turning, you are signaling, period! That is WAY less work! Doing otherwise would be like if before coughing or sneezing I took the time and effort to check the whole area to see if there was anyone who I would be spreading germs on or who I would be spitting on their necktie or whose sanitary habits I would be offending and then deciding whether I would cover my mouth or nose or not. Of course not, we have trained ourselves as we became adults that if a cough or sneeze was coming, we cover up! When we are preparing to change the direction we are riding in, we signal. So with just a flick of our thumb, we let other folks know what our intentions are and reduce the chances that

they will do something to get in our way and put us in harm's way.






